WHEREAS, the formal chain of command was followed and the Borough Administrator authorized immediate action, which included the purchase of an emergency generator; and

WHEREAS, the cost of said services shall not exceed \$20,000.00 and the borough will seek financial assistance from a FEMA grant; and

WHEREAS, pursuant to N.J.S.A. 40A:4-52, an Affidavit of the Chief Financial Officer shall be issued regarding this emergency appropriation;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the South Plainfield Borough Council that the emergency appropriation to purchase an emergency generator at a cost not to exceed \$20,000.00 was a necessary decision that required emergency action to ensure the public health, safety and welfare; and

BE IT FURTHER RESOLVED that all permit fees required for the above-referenced work shall be waived; and

BE IT FURTHER RESOLVED that two copies of this Resolution are to be filed with the Director of the Division of Local Government Services, as well as an Emergency Procurement Report, which must be filed within 30 days of the emergency.

Pursuant to the authority provided by the Municipal Interlocal Services Act, <u>N.J.S.A.</u> 40:8-1 <u>et seq.</u>, the Borough of South Plainfield deems it to be in the public interest to enter into an Interlocal Services Agreement with the Township of Woodbridge for the provision of an industrial wastewater sampling program.
- 2. The Mayor and the Municipal Clerk of the Borough of South Plainfield are authorized and directed to execute and attest, respectively, on behalf of the Borough of South Plainfield, that certain Interlocal Services Agreement providing for said services to the Borough.
- 3. The term of the aforesaid agreement authorized hereunder shall be for the period of two (2) years commencing January 1, 2012 and terminating December 31, 2013.
- 4. The aforesaid agreement shall provide for Woodbridge Township to supply all manpower, materials and equipment for industrial wastewater sampling and analysis. It shall be set forth that the total cost for said services shall not exceed \$75.00 per sample.
- 5. This Resolution shall take effect immediately upon adoption and publication according to law.

REPORTS:

Borough Attorney Paul Rizzo updated the governing body on the escrow account deficiencies of a number of applicants for zoning applications. He advised the Council that he would be contacting the attorneys of those applicants with deficiencies to let them know that the borough may be filing suit against their clients. Further action will be decided after their responses are received.

Mr. Cullen reported that he and Mr. Miller have been discussing the Safe Streets Safe Schools as it relates to areas with no sidewalks or partial sidewalks, especially near our schools. He also mentioned that there will be funds left over from the ADA ramps project to do additional ramps.

Mr. Miller echoed Mr. Cullen's report on the ADA ramp project and also advised that the New Market Ave Phase II is near completion.

Ms. Graf reminded the public that Tuesday is Election day with the polls open from 6am to 8pm. and that there will be a national emergency alert on Weds. Nov. 9th at 2pm.

Mr. Cullen reported that the curbside pickup of storm debris is ongoing and the borough is working hard to clean everything up as quickly as possible. He acknowledged that all the tree work done by DPW this summer helped reduce the amount of damage from the storm.

Mr. Salerno wished all the candidates the best of luck in Tuesday's election.

Mr. Bengivenga reported progress.

Mr. McConville expressed his thanks to the DPW staff for an excellent job during the snow storm.

Ms. Buteas also thanked DPW and all the Emergency services for their efforts during and after the storm. She wished all the candidates good luck on Election Day.

Mr. Rusnak also wish all the candidates good luck tomorrow.

Mayor Anesh extended his best wishes to the candidates. He commented on the cooperation of PSE&G which allowed the Mayor to provide timely updates to residents who called him about their power outage. He acknowledged how stressful the events of the storm were and how well DPW handled things.

Mayor Anesh opened the meeting for public comment.

Paul McCullen of Walnut St. thanked Chief Parker for the County pedestrian sign on Walnut Street. He reported that he and Larry Morrell cleaned the stream of debris as best as they could but could use DPW's help with the big branches that fell. He also mentioned that every other street light along Clinton and Sampton from Franklin down to Trista's Way were out.

Debbie Boyle of Van Fleet Ave thanked DPW and Emergency Services for their efforts during the snow storm. She also said she wanted to set the record straight regarding Board of Ed employee totals. She reported that in 2010 – 2011 there were 522 total employees in all categories. In 2011 – 2012 there are 513 total. She also commented on Shared Services and how successful the joint effort has been for the borough. She and Council President Rusnak were interviewed by *The Leader* on shared services and she noted that Governor Christie has mandated that all towns do shared services with their Board of Ed.

Frank Mikorski of Regency Pl. asked if there was any progress on the proposal to have the DPW do oil changes for the Board of Ed buses. Mr. Cullen said that they weren't sure it would work as originally anticipated. Mr. Rusnak mentioned that the proposal would be re-visited by himself, Mr. Cullen and Mr. Capparelli. Mr. Mikorski concluded by commenting on negative campaign tactics.

With no further public comment, Mayor Anesh called for a motion to adjourn.

Mr. McConville made a motion to adjourn at 7:40pm; seconded by Mr. Rusnak and approved unanimously.
