## Minutes from the February 21, 2012 Public Meeting of the South Plainfield Mayor and Council

The meeting was called to order at 7:15pm by Mayor Matthew Anesh in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6, with adequate notice of this meeting of the Borough Council being provided to the borough's two official newspapers and also published on the Borough's website.

Clerk Graf called the roll. Those present were Council Members Barletta, Bengivenga, Frank, McConville, Rusnak and White.

After the Pledge of Allegiance, the invocation was offered by Councilman Bengivenga.

Mayor Anesh presented two proclamations. The first proclamation designated March as Women's History Month in the borough. The second proclamation was present to members of the Board of Education and members of the Library Board in honor of Read Across America.

Mayor Anesh then presented wedding fee donation checks to six charitable organizations. It is a tradition for Mayor Anesh to donate all the proceeds from the weddings he performs throughout the year to local charitable organizations and causes. He gave a brief summary about each of the recipients. They are:

- South Plainfield Domestic Violence Team \$1350.00
- Elks Camp & Cooley's Anemia \$300.00
- The Pink SOCS Foundation \$600.00
- The Brayden Carr Foundation \$600.00
- The Buddy Walk \$600.00

Mr. White made a motion to accept the minutes of February 6, 2012, Agenda, Public and Executive; seconded by Mr. Barletta.

**YES: Barletta, Bengivenga, Frank, McConville, White and Rusnak** Motion Carried Mayor Anesh opened the meeting to the Public for comments on Agenda items only.

Frank Mikorski of Regency Place complimented the governing body for approving Resolution # 12-028, joining the Middlesex Regional Education Coop. He commented on the borough's agreement with the Plainfield Municipal Utility authority for the disposal of bulk waste; and he inquired about the tuition reimbursement policy of the borough as it related to Resolution # 12-039.

Debbie Boyle of Van Fleet Ave advised the Council that the annual Women's history Essay contest that was started a few years ago will again take place this year. She also announced that the date for the Walk/Run fund raiser and PBA basketball event to benefit Rutgers students with disabilities has been changed to April 15<sup>th</sup>.

Mayor Anesh closed the public portion and called for Ordinance # 1950.

Clerk Graf read Ordinance #1950 by title only for Public Hearing and final adoption as follows:

**#1950 entitled**: An ordinance amending Chapter 84 titled "Police Department" of the Code of the Borough Of South Plainfield".

WHEREAS, the Chief of the Police Department of the Borough of South Plainfield has

requested that the Code of the Borough be amended to reflect the overtime rate for a Class C

officer performing private or quasi-public functions when off duty in accordance with the current PBA contract now in effect;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Code of the Borough, Chapter 84 entitled "Police Department' shall be and is hereby amended to delete Section 84-16. Rate of Payment for Service. To be replaced as follows:

The party requesting the service of a member of the Police Department as stated in Section 84-14 hereof shall be charged and pay for each service per hour at one and one half (1.5) times the compensation rate presently payable to Class C patrolman, plus five (\$5.00) dollars administrative fee for all entities, except nonprofit groups (including, but not limited to churches) in which the administrative fee will remain at \$2.00. An additional fee of \$15.00 will be added to the hourly rate charged when a patrol vehicle is required. All sums shall be paid to the Treasurer of the Borough of South Plainfield, and shall become part of its general funds.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

Mr. Barletta made a motion to adopt Ordinance # 1950; seconded by Mr. Bengivenga.

As this is a final reading, Mayor Anesh opened a public hearing on the ordinance.

No comments were offered so Mayor Anesh closed the public hearing and asked if the council had any questions or comments.

Clerk Graf read Ordinance #1951 by title only for Public Hearing and final adoption as follows:

**#1951 entitled:** A Bond ordinance providing for improvements to the Pool Utility in and by the Borough of South Plainfield, in the County of Middlesex, New Jersey, appropriating \$90,000 therefor and authorizing the issuance of \$85,500 bonds or notes of the borough to finance part of the cost thereof.

#### **BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY** (not less than two-thirds of all members thereof affirmatively concurring) **AS FOLLOWS**:

Section 1. The improvement described in Section 3(a) of this bond ordinance is hereby authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as a general improvement. For the improvement or purpose described in Section 3(a), there is hereby appropriated the sum of \$90,000, including the sum of \$4,500 as the down payment required by the Local Bond Law. The down payment is now available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the improvement or purpose not covered by application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$85,500 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. (a) The improvement hereby authorized and the purpose for the financing of which the bonds are to be issued is various improvements to the pool utility, consisting of the removal and replacement of both pool recirculation pumps, the removal and replacement of both motor starters, the removal and replacement of a suction strainer, the removal and replacement of all throttle and isolation valves, and piping modifications to suit the above improvements, including other related work in and around the pool and including all work and materials necessary therefor and incidental thereto.

(b) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose is as stated in Section 2 hereof.

(c) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefor.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough **is** hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvement or purpose described in Section 3(a) of this bond ordinance is not a current expense. It is an improvement or purpose that the Borough may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this ordinance, is 15 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$85,500, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$10,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purpose or improvement.

Section 7. The Borough **hereby** declares the intent of the Borough **to** issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3(a) of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purpose described in Section 3 hereof shall be applied either to direct payment of the cost of the improvement or to payment of the obligations issued pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Mr. White made a motion to adopt Ordinance # 1951; seconded by Mr. McConville.

As this is a final reading, Mayor Anesh opened a public hearing on the ordinance.

No comments were offered so Mayor Anesh closed the public hearing and asked if the council had any questions or comments.

**WHEREAS,** Keely Heyman-Loria, an employee of the Borough in the position of telecommunicator, filed a grievance against the Borough seeking reimbursement of education costs, and

**WHEREAS**, the grievance was scheduled for a hearing, at which time the parties entered into settlement of the claim;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Mayor and Borough Clerk are authorized to execute an agreement with Keely Heyman-Loria and AFSCME Council 73, Local 3970, as follows:

1. The Borough and Local will discuss the procedures to apply and qualify for education reimbursement during the upcoming negotiations for a new collective bargaining agreement;

2. The Borough shall reimburse Keely Heyman-Loria \$3,500.00 for the completion of her coursework in full and final settlement of her grievance;

3. Keely Heyman-Loria and the Local shall make no further claim for additional coursework which has been completed by Ms. Heyman-Loria, and was referenced in the grievance filed by Ms. Heyman-Loria;

4. The Borough shall not be obligated to provide reimbursement for coursework that is not related to an employee's job duties with the Borough. Further, the Borough asserts and maintains that it will not reimburse any claims for educational reimbursement that are not timely submitted;

5. The Local union maintains that it shall rely upon contract language to assert that the Borough is obligated to provide education reimbursement to union members; and

6. The aforesaid agreement represents the complete and final settlement of all claims arising from the grievance filed by Keely Hayman-Loria.

Mr. Cullen reported that the Division of Local government Services are releasing the State Aid figures and he anticipates that the budget will be introduced at the March 5<sup>th</sup> Council meeting. He also expects to have the Roads list ready for the next meeting. Mr. Cullen reported that TD Bank was the successful bidder at the Bond Sale with a rate of .084%. The closing is expected on Thursday.

Mr. Frank reminded the public on behalf of the Environmental Commission to observe the antiidling ordinance in place in the borough and encouraged drivers to cooperate.

Mr. Barletta and Mr. Bengivenga each reported progress

Mr. McConville invited the public to support the Marine Corps. Spaghetti Dinner being held on Feb 25<sup>th</sup> at the American Legion. He also reported on a plan to repair the fence behind borough hall at the park.

Mr. White announced that Registration for 2012 Community Poll membership has begun. Also, the deadline to register for Ponytail and T-Ball is March 9<sup>th</sup>. There is a new Mommy and Me program starting at the PAL.

Mr. Rusnak commented on the Board of Ed roof repair project and assured the public that contrary to rumors, the roofs are not unsafe.

Mayor Anesh commented on the fact that he performed 127 weddings that resulted in the charitable donations given tonight. He spoke about the Mayor's Wellness Campaign Committee and noted that committee positions are still available and applications are being accepted. the Mayor also recognized the South Plainfield High School Wrestling Team on their success thus far and their once again attaining the #1 ranking in the State of NJ.

Mayor Anesh opened the meeting for public comment.

Frank Mikorski of Regency Place asked Mr. Cullen for the rates on the BAN sale. Mr. cullen confirmed that the rate was .084%. The other bidders came in at 1.25% and 1.5%. Mr. Mikorski thanked Mr. Rusnak, White & Bengivenga for attending the Board of Education meeting. He also remarked on the press release which confirmed that the Board of Ed Auditor was correct and there is a \$1.3 surplus. Regarding the possible use for roof repair to the schools, Mr. Cullen emphasized that the Borough's Construction Official did not inspect the roofs. He requested submission of a structural report which he did receive.

In response to Mr. White's earlier report about repairs to the park fence at the rear of Borough Hall, John Abbruzzese noted that given the low use of the recreation area behind Borough Hall and the need for increase parking space, perhaps the best plan would be to utilize the area to expand the parking lot and to pave the entire lot.

Debbie Boyle of Van Fleet Ave. commented on the condition of the school roofs and blamed Sodexho for not keeping up with the maintenance. She also reported that Bloomfield has begun shared services efforts because of the success of South Plainfield's program.

Mayor Anesh closed the public portion of the meeting and the Council moved into Executive Session to discuss 3 DPW personnel matters.

On the council's return from Executive session, Mayor Anesh announced that not further action was required and he called for a motion to adjourn. Mr. Rusnak made a motion to adjourn, seconded by Mr. McConville at 8:30pm.
