Minutes from the January 17, 2012 Public Meeting of the South Plainfield Mayor and Council

The meeting was called to order at 7:15pm by Mayor Matthew Anesh in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6, with adequate notice of this meeting of the Borough Council being provided to the borough's two official newspapers and also published on the Borough's website.

Clerk Graf called the roll. Those present were Council Members Barletta, Bengivenga, Frank, McConville, Rusnak and White.

Mayor Anesh presented three proclamations. The first was in honor of Catholic Schools Week -January 29 - February 5, 2012. The second proclamation acknowledged National Wear Red Day for Women – February 3, 2012 and was accepted by Darlene Pinto and Debbie Boyle. The third presentation was a Service Recognition Proclamation honoring outgoing Fire Chief Larry Del Negro for 10 years of service as Fire Chief.

Mr. Del Negro addressed the governing body and audience and spoke briefly about his time as Chief. He expressed how the fire officers were able to convey their vision for the department to the members of the governing body over the years to make the company what it is. He acknowledged and thanked his fellow fire fighters for their dedication and commitment as members of the South Plainfield Volunteer Fire Dept.

Following the proclamation presentations, Councilman Bengivenga was joined by Chief Scalera and Deputy Chiefs Mocharski and Del Negro to present Meritorious Awards to Firefighters Alex Nieradka, Tim Gray, Nicholas Figler, Adam Tennenbaum and Chief Del Negro for their actions during a recent Plainfield fire which resulted in the discovery and rescue of an unconscious female from the fire.

Mr. Bengivenga made a motion to accept the minutes of December 19, 2011; seconded by Mr. Barletta.

Observer Editor Nancy Grennier asked for clarification on the proposed purchase of two garbage trucks. Mayor Anesh explained that the plan is to do projects like leaf pick up, bulk pick up and senior pick ups "in house" rather than outsource them. Mr. Rusnak added that details need to be worked out but they were considering issuing 2 coupons to each household to be used by appointment rather than doing bulk by district.

Frank Mikorski of Regency Place asked about Ordinance # 1944 and the purchase of an ambulance. Mr. Bengivenga explained that EMS Chief LaFerrere suggested the purchase of a slightly used ambulance from Perth Amboy with only 10,500 miles on it. The saving is substantial over buying new plus with the cost saving from the Somerset Medical Center Ambulance service agreement, the cost will be covered in 3 years.

Mr. Mikorski asked Mr. Cullen about bonding/notes and also about the purchase of a new fire engine.

Mayor Anesh closed the public portion and called for the introduction of Ordinance # 1944.

REPORTS:

CFO/Administrator Cullen reported that PSE&G would be in town swapping out 250 old telephone poles for new ones.

Borough Engineer Miller gave an Engineering Status Report of all projects the borough is working on including the close out of New Market Ave, Phase II, the ADA Ramp project and the 2011 Road resurfacing project, the Sampton Ave project, various County joint projects, tree planting and the annual DEP Storm water Report.

Each member of the governing body expressed his thanks and appreciation to Chief Del Negro for his 10 years as Chief and wished the new Chief, Tom Scalera all the best in his new position.

Mr. Frank also recognized the passing of two local veterans – Bob Riordan and Tom Adams.

Mr. Bengivenga also announced the PBA/Middle School tournament to be held on January 29th beginning at 11:30am. He encouraged residents to come out to support this event as well as the Ponytail Comedy Show on January 28th.

Mr. White also announced that Recreation is is currently running sign ups for T Ball and Ponytail leagues. He thanked Jr. Baseball for helping out with parking by utilizing field 6. He acknowledged the new goals on the hockey rink out back of borough hall. Mr. White also recognized the Boy Scouts who were in attendance to earn a merit badge.

Mr. Rusnak also reported that the governing body does have a plan for bonding .

Mayor Anesh shared a story about street hockey and how the new goals came to be. He announced that he will be seeking six (6) volunteers to serve on the Mayor's Wellness Campaign Committee. The Mayor also shared a story and some personal thoughts on Harold Martin, the owner of Glopak, a local manufacturer on Case Drive who recently passed away.

Mayor Anesh opened the meeting for public comments.

Dennis Scalera of Banta Road suggested that the town consider holding a Veterans Community Picnic and gave the Clerk a printed summary of his idea. He also asked the borough to look into a new monument to honor all vets. He also asked if anyone knows of a bag pipe palyer.

Frank Mikorski of Regency Place would like the website to carry the meeting schedules for the Library board, the Board of Freeholders and the Open Space Board. He would also like a spread sheet displaying the dollar amounts of the budget components available to the public. Mr. Mikorski spoke at length about the Board of Education Audit and the various misinformation that was made available during the budget process. He pointed out that as of 6/30/2011 the Fund Balance showed \$3.8 million and a Capital Reserve of \$1.6million. The auditors recommended that the excess surplus of \$1.343 million should be returned to the taxpayers. He suggested that the financial state leaves the credibility of the Board of Education in question.

Mayor Anesh Closed the public portion.

Mr. Bengivenga requested that the Council hold the annual Housing and Community Development Block Grant Public Hearing at 6:45pm on February 6th. The meeting was so set and will be advertised.

The Council went into executive session at 8:25pm.

The Council returned to the Public meeting at 8:45pm. Mayor Anesh announced that nothing additional transpired so he called for a motion to adjourn.

Mr. Bengivenga made a motion to adjourn, seconded by Mr. Rusnak.
