Minutes from the January 7, 2012 Reorganization Meeting of the South Plainfield Mayor and Council held at the Senior Center

The meeting was called to order at 1:00pm by Mayor Matthew Anesh in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6, with adequate notice of this meeting of the Borough Council being provided to the borough's two official newspapers and also published on the Borough's website.
