Mr. Cullen explained and said no, we did not receive more money from the state. The budget amendment is mainly due to the refinancing of our debt. Mr. Mikorski said he does not understand the overpayment of sewer fees on tonight's agenda and asked who discovered it. Mr. Cullen advised the resident and their attorney discovered it. Mr. Mikorski concluded by asking if the Borough is a member of the New Jersey State League of Municipalities. Mr. Cullen said yes. Mr. Mikorski asked the Council to tell Mr. Dressel to get off of NJ 101.5.

BUDGET AMENDMENT INTRODUCTION:

#12-191A AUTHORIZING AMENDMENT OF THE 2012 MUNICIPAL BUDGET AS ADVERTISED IN FULL, AND POSTED ON THE MUNICIPAL WEBSITE AND ON THE MUNICIPAL BULLETIN BOARD – Mr. Cullen explained that due to various changes in the budget we are required to have a special public hearing before we adopt it. The public hearing will be next Monday, July 23, 2012 at 6:30 p.m. The new tax rate is 1.293. We did put additional money into the budget for tax appeals. When all was said and done, we were able to reduce the overall budget by \$425,000. Refinancing our debt made a big difference. Council President Rusnak advised that \$167,000 was cut on the on-set by meeting with the various department heads. Unfortunately, we still have not received any support from the Library Board or School Board., though we sure tried. Mr. Cullen advised that next week we will discuss the budget in more detail. Councilman McConville thanked the Council for such a great job.

COUNCIL REPORTS:

Borough Attorney Rizzo, Esq. - has no report for this evening.

<u>Administrator Cullen</u> – wanted to further clarify that \$300,000 was put into the budget to cover this year's tax appeals.

Engineer Miller – Mr. Miller briefed the Council on the status of various projects. Improvements to New Market Avenue Phase II is being finalized and closed out. Permits have been submitted for the 2012 Stream Cleaning Project and it is anticipated that NJDEP will have approvals in the next two weeks. The revisions for the truck by-pass route have been completed and submitted to NJDEP. The field survey is completed for Sampton Avenue Improvements and base maps are being worked on. T&M is presently working on preparing specifications and contract documents for road resurfacing. Construction work is ongoing pertaining to the New Brunswick Avenue Bridge replacement. The County is preparing conceptual plans for modifications to Stelton Road and New Brunswick Avenue. Mr. Miller advised that the Borough needs to move forward with the Right-of-Way acquisitions for New Durham Road and Corporate Boulevard. Furthermore, the Borough needs to acquire right-of-way for West 7th Street, and Stelton Road.

<u>Clerk Antonides</u> – has no report for this evening.

<u>Councilman Barletta</u> – said he would like to welcome Louie G Ice Cream and wishes them much success. Councilman Barletta further advised that he met with Royal Coffee of New York and they will be moving to South Plainfield soon. They are a popular coffee distributor. Mr. Barletta concluded by remarking what a nice turn out there was at the car show last week and thanked emergency management for their efforts.

<u>Councilman Frank</u> – complimented the efforts of Council President Rusnak and his team who worked hard trying to seek out any kind of compensation from the Board of Education and Library.

<u>Councilman Bengivenga</u> – also thanked the EMS for holding the car show on July 8th and cited what a nice job they did. The Elks breakfast is this week and we are looking forward to that. To conclude, Councilman Bengivenga questioned the Borough Engineer about a road resurfacing project.

<u>Councilman White</u> – said that the new sewer truck is a fine looking piece of equipment. Councilman White thanked Cappi, his team and Glenn, for implementing the bocci ball court. The DPW did a real fine job installing it. The Lizard Guy Show at the Library was a fun event that was enjoyed very much. There will be puppet show art this week at the Library. To conclude, Zumba Gold at the Senior Center is looking to add another class due to its popularity.

<u>Councilman McConville</u> – reported that Putnam Park has a brand new bocci ball court that is now complete and those interested in playing should bring their own balls. Mr. Cullen advised that a resident has donated balls for the bocci court. To conclude Councilman McConville advised that the Public Works Department has received the new sewer truck and looks forward to putting it to some good use.

<u>Council President Rusnak</u> – explained that tax appeals filed from 2011 to early 2012 have been most successful than ever before. The Council is trying to take an aggressive approach to stay on top of this area of concern. Mr. Rusnak complimented the Police Chief and his department for their fast apprehension of a murder suspect within a 48 hour time frame. To conclude, it is apparent that the Mayor's Wellness Champagne has been a great influence on our Council.

<u>Mayor Anesh</u> – encouraged everyone to check out the Facebook page to see the photos from the car show. There were a lot of nice cars and it was a very successful event. Mayor Anesh advised that Royal Coffee of New York is a very fascinating company. They search for coffee beans from all over the world. We are very pleased to have them housed here in South Plainfield. Also, at the end of last month, he and Glenn met with the State DEP and went through an 18 point letter addressing areas of concern. The state expressed how impressed they were with the work done by T&M in revising the potential truck route.

COMMENTS FROM THE PUBLIC:

Mr. Dennis Scalera, former member of the Traffic Safety Advisory Commission, asked what the Borough has done to make the streets safer. Mayor Anesh advised that the Borough has put focus on expanding the Safe Street/Safe Kid Program in which we have received a lot of positive feedback. Councilman Bengivenga advised that we also applied for grants for our sidewalks and crosswalks. Mr. Scalera said he is concerned about vehicles running a red light and cutting people off , like what recently happened to him. Mayor Anesh said it can be costly to add red light cameras and there is not much of a history with the roads that Mr. Scalera speaks of. (Hamilton Blvd.). Mr. Scalera said the road on Stelton Road by Staples is the biggest concern as it doesn't seem to work. There is something wrong with the left hand turn signal. Councilman Bengivenga said the Traffic Safety Advisory Commission will take a look at this.

Mr. Paul McCullen of Walnut Street asked if the new Coffee Company moving into South Plainfield will generate new jobs. Mayor Anesh said yes, most likely. Mr. McCullen asked if the road improvements are paid for with grant funding? Mr. Cullen said yes, both grant funding and some bonded. Mr. McCullen advised that this Wednesday night the Board of Ed is holding a meeting in which discussions pertaining to custodial savings will be had and encourages the Governing Body to attend. Mr. McCullen concluded by saying he encourages the Council to appeal to our local legislators for support pertaining to these tax appeals. Mayor Anesh said he believes there is a Bill pending right now.

Ms. Kelly Dunn, 15 Brick Road, is the Pop Warner President. Ms. Dunn thanked the Council for authorizing repairs to the Pop Warner Snack Bar facility. Councilman Barletta explained what the contractor will be doing. Ms. Dunn expressed concerns about outside town organizations conducting fund raisers in South Plainfield, yet we cannot conduct our fund raisers in their towns. The Council asked the Borough Attorney, Mr. Rizzo, to look into the legalities.

Mr. Jeff Seider, 208 O'Donohue Avenue, asked if the Council is happy with the way they handled his complaint about rats? Council President Rusnak advised that reports were reviewed, investigations took place, exterminators were called in, bait traps were set. Mr. Rusnak said the final reports concluded that the source of the problem was not were Mr. Seider thought it was. Mr. Seider asked if the Council read the reports from December. Councilman Barletta said he did. Mr. Seider gave an account and time line of what he perceives to have taken place by the Borough Council, Borough Health Department and the Administrator. Mr. Seider said he is very frustrated.

Ms. Terry Wilkenson, who lives near Mr. Jeff Seider, said the rats are a concern to her as well and is happy Mr. Seider is here to speak out about this problem. Ms. Wildenson said she feels the source is from a neighbors shed and also expressed her frustration.

Mr. Frank Mikorski of Regency Place, advised that at a June 13th meeting, the Board of Education pointed out some of their increased costs. Mr. Mikorski complimented Council President Rusnak for his effort and consistency with the Board of Ed. Mr. Mikorski also complimented Councilman Barletta on his weight loss as well as his work on economic study. Mr. Mikorski suggested that the Council ask the Board of Ed to refinance their debt. To conclude, Mr. Mikorski advised that New Brunswick is staffing an auxiliary police department and maybe we should do the same.

Mr. Jason Coravelli, who also lives near Mr. Jeff Seider, said that he had two rats in his yard and is concerned for his children playing in the yard so he hired his own exterminator and learned that the problems seems to be more wide spread. It is very important for residents to keep their properties clean.

Mr. Jeff Seider suggested that the Council do an audit of the Board of Ed books going back to 2006.

With no further comments from the public, Mayor Anesh closed the floor.

At this time, 8:30 p.m., Mayor Anesh advised that they will be going into Executive Session and everyone is welcome to stay for their return back into public session.

ADJOURNMENT

The Mayor and Borough Council reconvened back into public session at 9:01 p.m. and advised that there are no matters that require action from the closed session meeting this evening. Without further comment, Mayor Anesh called for a motion to adjourn. Councilman Bengivenga made a motion to adjourn, seconded by Council President Rusnak and unanimously carried. The meeting was adjourned at 9:02 p.m.
