<u>CALL TO ORDER:</u> Mayor Anesh called the meeting to order at 7:10 p.m. Mayor Anesh read the sunshine statement and announced that same is being held pursuant to the Open Public Meetings Act of 1974 and all provisions of that Act have been met with adequate notice of this meeting having been provided to the Borough's two official newspapers and also published on the Borough's website.

FLAG SALUTE: was led by Mayor Anesh and Council President Rusnak led the invocation.

Public Hearing on the CY 2012 Municipal Budget Amendment (#12-211)

Administrator/CFO gave a synopsis of the budget process for this year. He advised that we are a little late adopting our budget this year due to the refinancing of our debt. When we began the budget process we were up around \$500,000, but where then able to cut that significantly. We had to budget an extra \$100,000 due to the influx of tax appeals this year. Though there has been a decrease in the ratable base, there has been an increase with building permits as we seem to be seeing a lot of economic activity. Overall we are in as good a shape as can be.

Council President Rusnak advised that our biggest obstacle this year has been being faced with so many tax appeals. There are more tax appeals now than in the past four year. We have budgeted a total of \$300,000 to cover this.

Councilman Barletta advised that we started out looking at a potential substantial tax increase. We worked very hard together to make necessary cuts to keep a low tax increase. Councilman Barletta thanked Council President Rusnak, Councilman Bengivenga and Mr. Cullen for all their suggestions and help to get the numbers down. We all worked very hard together. The refinancing of our debt was of significant benefit. Excellent job done by Mr. Cullen with his financial abilities. The Council unanimously agreed.

Councilman Bengivenga advised that they went through every single line item diligently, and many hurdles were encountered along the way. Council President Rusnak said that we were able to cut a total of \$167,000 which is a remarkable indication for how far we have come in the process.

Mayor Anesh stated that it is really remarkable that our budget is comparable to that of 2007 levels. No one wants to see their taxes go up and as such, we did all we could to have as minimal of a tax increase as possible. It is because of the good work of the Council and the Administrator that we were able to keep the budget down and the taxes nearly flat.

Councilman White arrived at this time; 6:50 p.m. but had no comment.

Mayor Anesh opened the floor for public comment pertaining to the 2012 Municipal Budget.

Mr. Paul McCullen of Walnut Street noted that we used \$400,000 in surplus and questioned if we will be able to make up for that surplus. Mr. Cullen said that surplus revolves from year to year but fully anticipates by the end of 2012 to have built it back up again.

Mr. Frank Mikorski of Regency Place questioned the large figures budgeted for Department of Public Safety and 911. Mr. Mikorski also noted that health benefits figures went up. Mr. Cullen advised that we actually had a reduction to pension costs and as for health benefit reductions, we won't see the benefits of the health care contributions until 2013 or 2014. Mr. Mikorski questioned \$1.9 million for compensated absences. Mr. Cullen explained how some employees are grandfathered pursuant to law. Mr. Mikorski concluded by expressing his hope that a document that Mr. Cullen has depicting other components of our tax rate are published. Mayor Anesh said we will consider doing that.

With no further comments, Mayor Anesh closed the floor for public comments pertaining to the budget.
