ORDINANCE – SECOND READING AND PUBLIC HEARING:

ORDINANCE NO. 1963 AN ORDINANCE AMENDING CHAPTER 157 OF THE CODE OF THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY ENTITLED "SEWERS"

NOW THEREFORE BE IT ORDAINED by the Governing Body of the Borough of South Plainfield, State of New Jersey that the following be and is hereby amended as follows:

Schedule A Annual Sewer Rental - 2012 (Effective for bill periods beginning July 1, 2012)

This Schedule A hereby establishes three (3) sewer user classes under this ordinance as follows:

All recipients of the \$250.00 real property tax deduction granted in accordance with the provisions of P.L. 1963, C. 172 (R.S. 54:4-8.41) shall be given a deduction in the sewer rental rate that will result in a net annual rate not exceeding \$175.00.

(2) Commercial users

Minimum annual sewer service unit user charge for any Commercial user connected to the Borough Sanitary Sewer System shall be six hundred and forty dollars (\$640.00). The following rates are for actual consumption in 100 cubic feet of water used per information supplied by the water company(ies).

Notwithstanding any rates set forth herein to the contrary, in no case shall the charge for Monitored Industrial users be less than the charge for an equal volume of flow as otherwise world be determined utilizing the commercial establishments rate set forth in Commercial User (2C) Class 3 rate \$11.255 or for a minimum annual user charge of five hundred dollars and ninety (\$640.00), whichever is higher. In addition to the loading and flow charges, the Monitored Industrial User shall pay for the cost of sampling and laboratory testing of the wastewater.

(5) Application for a Certificate of Use for sanitary sewer review shall be through the Borough Building Department. The fee shall be \$100.00 for an application of a change of building use. This fee is in addition to the current Building Department Review Fee.

All other fees and provisions of this Article shall remain in full force and effect. This amendment becomes effective after final adoption and advertisement in accordance with the law.

ORDINANCE – INTRODUCTION (Public Hearing Set For June 18, 2012)

ORDINANCE #1964 An Ordinance Providing Fees for the Purpose of Opting Out of Health Benefit Coverage Provided by the Borough of South Plainfield

WHEREAS, the Borough of South Plainfield provides health, prescription and dental group employee benefits coverage; and

WHEREAS, the Borough of South Plainfield wishes to control the cost of health benefits and other group employee coverage's to the maximum extent possible; and

WHEREAS, one method of achieving this objective is to encourage employees to waive health, prescription and/or dental coverage where the employee does not need the coverage; and

WHEREAS, the Borough wishes to encourage employees to waive this coverage when they are able to do so and wishes to offer employees as an incentive to waive coverage a portion of the savings realized by the Borough when the employee chooses to waive the coverage(s);

NOW, THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL OF SOUTH PLAINFIELD AS FOLLOWS:

- Section 1. Effective July 1, 2012, an employee of the Borough of South Plainfield ("Borough") who is eligible for other health care coverage may waive the health care coverage under the Borough's health benefits program pursuant to N.J.S.A. 40A:10-17.1.
- Section 2. In order to be eligible for this benefit, an employee must complete a new "Change in Coverage or Termination of Benefits" form and submit same along with proof of alternative health coverage (if waiving health coverage) to the Borough Administrator's Office. Likewise, to reinstate coverage, this same form may be used. In each case, the form must be certified by the Borough Administrator in order for the request to be effective.
- Section 3. In consideration of the filed waiver, the Borough will pay semi-annually to the eligible employee, benefits as set forth in the attached policy entitled "Borough of South Plainfield, Waiver of Health Benefit Coverage".
- **Section 4.** Any employee who waives coverage shall be permitted to resume coverage under the same terms and conditions as apply to initial coverage if the employee ceases to be covered through the employee's spouse's benefit plan for any reason. An employee who resumes coverage may be required to repay a pro rata portion of any previously paid lump sum that represents an advance payment for any period of time for which the waiver has been revoked. An employee wishing to resume coverage shall complete, sign and file with the Borough Administrator's Office an official form for reinstatement.

- Section 5. All ordinances or parts of ordinances inconsistent with or in conflict with this ordinance are hereby repealed to the extent of such inconsistency.
- **Section 6.** The provisions of this ordinance are declared to be severable, and if any section, subsection, subsection, sentence, clause or phrase hereof shall, for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses or phrases of this ordinance, but they shall remain in effect, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any part.
- Section 7. This ordinance shall take effect July 1, 2012 upon passage, publication and approval pursuant to law.

Introduction of Ordinance #1964: June 4, 2012

ORDINANCE NO. 1965 AN ORDINANCE AUTHORIZING THE SALE OF SURPLUS <u>MUNICIPAL PROPERTY PURSUANT TO N.J.S.A. 40A:12-13 FOR PROPERTY IDENTIFIED</u> AS BLOCK 305, LOT 2

BE IT ORDAINED by the Borough of South Plainfield, County of Middlesex, State of New Jersey that:

WHEREAS, the Borough of South Plainfield, County of Middlesex is the owner of property identified as Block 305, Lot 2 on the Borough Tax Map and located within the Borough (hereinafter referred to as the "Property"); and

WHEREAS, the Borough Counsel of the Borough of South Plainfield has determined that said property is no longer needed for public use; and

WHEREAS, the Borough Council has determined it to be in the public interest to sell said Property to a contiguous property owner in accordance with N.J.S.A. 40A:12-13(b); and

WHEREAS, Jonathan Properties, LP is the owner of all property contiguous to the Property;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey as follows:

1. The Mayor and Council declare the Property to be surplus and not needed for public use;

2. The Property may be sold to Jonathan Properties, LP as the contiguous property owner by private sale for \$21,000.00, the price determined by the Borough Appraiser, Russell K. Sterling;

3. The Mayor, Borough Clerk, Borough Attorney and such other Borough officials as the law may provide are hereby authorized to prepare and execute such documents as may be required to close and transfer title to the Property to the contiguous owner;

4. The Property shall be sold subject to all existing encumbrances, liens, zoning regulations, easements or other restrictions, such facts as an accurate survey would reveal in any present or future assessments for the construction of improvements benefitting said Property;

5. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance, and they shall remain in full force and effect;

6. In the event of any inconsistencies between the provisions of this Ordinance and any other Ordinance of the Borough of South Plainfield, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Revised General Ordinance of the Borough of South Plainfield are hereby ratified and confirmed, except where inconsistent with the terms hereof.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

ORDINANCE 1966

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING THE AGGREGATE AMOUNT OF \$210,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$199,500 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$210,000, including the aggregate sum of \$10,500 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, negotiable bonds are hereby authorized to be issued in the principal amount of \$199,500 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements that the Borough may lawfully undertake as general improvements, and no part of the costs thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 8 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$199,500, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$10,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated costs indicated herein for the purposes or improvements.

Section 7. The Borough hereby declares the intent of the Borough to issue the bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purposes described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued

pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final law.
