Minutes from the March 19, 2012 Public Meeting of the South Plainfield Mayor and Council

The meeting was called to order at 7:15pm by Mayor Matthew Anesh in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6, with adequate notice of this meeting of the Borough Council being provided to the borough's two official newspapers and also published on the Borough's website.

Clerk Graf called the roll. Those present were Council Members Barletta, Bengivenga, Frank, McConville, Rusnak and White.

After the Pledge of Allegiance, the invocation was offered by Councilman McConville.

Mayor Anesh presented a proclamation for "Purple Day" promoting awareness of the neurological disorder to Councilman Barletta, whose son has the disorder. Mr. Barletta thanked the Mayor for his support for Epilepsy Awareness and expressed how much it means to his family.

Mr. Bengivenga made a motion to accept the executive meeting minutes of February 21, 2012 and the Agenda, Executive and Public meeting minutes of March 5, 2012, seconded by Mr. White.

Mayor Anesh opened the meeting to the Public for comments on Agenda items only.

Mr. McCullen of Walnut Street asked what the effective date is on Resolution 12-070. Mr. Rizzo explained the subsequent steps that could take place before the resolution is enforced including the possible appeal process that could ensue. Mr. McCullen also asked if the garbage trucks could be utilized for the litter can maintenance program. He was told perhaps in the future.

Les Bergen of Hamilton Blvd. asked for more information on Resolution 12-066 and the vapor intrusion investigation. Mr. Miller provided a summary of the project. Mr. Bergen also asked if Liquid Assets would be responsible for the cost of the police coverage needed the night of the incident. Chief Parker replied that the coverage falls under mutual aid between towns.

WHEREAS, the Borough of South Plainfield, County of Middlesex, State of New Jersey presented a Notice of Charges against J.P.R.C., Inc., which does business as Liquid Assets, asserting violations of the New Jersey Administrative Code pertaining to a liquor license issued to J.P.R.C., Inc., and specifically charging that on January 15, 2012, the corporation engaged in or allowed, permitted or suffered a brawl or act of violence on their premises involving a crowd of approximately 150 to 200 people, and requiring a police response of approximately 35 police officers from South Plainfield, Plainfield, Piscataway and Edison; and that on such date, the corporation allowed, permitted or suffered the licensed place of business to be conducted in such a manner as to become a nuisance adversely affecting the quality of life in the municipality; and that on said date, the corporation engaged in, allowed, permitted or suffered the violation of a municipal ordinance or regulation by failing to comply with Borough Ordinance 136-9 by allowing a brawl and disturbances on the premises. The Notice of Charges sought suspension of a total of 70 days; and

WHEREAS, the Notice of Charges was duly served upon the corporation, and a hearing was conducted on March 8, 2012 during which hearing Sgt. Wayne Diana testified on behalf of the Borough concerning the events which took place on the night of January 15, 2012, and Mr. John Colasanti, the owner of the corporation, testified on behalf of the corporation; and

WHEREAS, Sgt. Diana testified that on the night in question, a crowd of 150 to 200 people were present at the premises, when multiple fights broke out, and Sgt. Diana described a riot taking place, which necessitated calling all police officers on duty for the Borough at the time to the location, and calling for assistance from neighboring towns, with twelve police officers responding from the City of Plainfield, ten police officers responding from the Township of Piscataway, and six police officers responding from the Township of Edison. Sgt. Diana described the conditions which led to his deployment of a can of OC spray necessary to disburse the crowd. Sgt. Diana testified that he was aware of two individuals on site as security for the corporation. Sgt. Diana advised that he was concerned for his safety and that of all other officers responding due to the conditions at the site; and

WHEREAS, Mr. Colasanti testified that he is in charge of the operation of the bar. He testified that he used the services of a promoter, who retained an entertainer from Philadelphia who was to perform at approximately 1:30 a.m. on January 15, 2012, for a period of approximately six minutes. He advised that he retained six security personnel, which was double his normal security detail, out of concern for security anticipating that the event would draw a large crowd. One of the individuals was certified in the field of security, and the other five individuals were not so certified. He testified that the entertainer arrived late, but was advised to perform, at which time a fight ensued, Mr. Colasanti noted same, and called the police due to what he described as a skirmish taking place in the bar. Mr. Colasanti testified that he did not anticipate nor condone the conditions. Mr. Colasanti acknowledged that there was video of the events taking place that night, a police officer had requested the video the following day, and he did not provide access to it nor provide a copy upon advice of counsel. He received a Notice of Charges while the video still existed, but the video system is such that it tapes over itself every approximate 28 days. Accordingly, the video no longer exists; and

WHEREAS, the hearing was then closed, and the Governing Body discussed the responsibility and penalty;

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of South Plainfield, County of Middlesex, State of New Jersey, as follows:

1. J.P.R.C., Inc. is found to have violated N.J.A.C. 13:2-23.6(a) by engaging in or allowing, permitting or suffering on the licensed premises a brawl or act of violence;

2. J.P.R.C., Inc. is found to have been in violation of N.J.A.C. 13:2-23.6(b) by allowing, permitting or suffering the licensed place of business to be conducted in such a manner as to become a nuisance adversely affecting the municipality;

3. The charge of violation of Municipal Ordinance 136-9 is dismissed, based upon the legal advice that such Ordinance is likely unconstitutional; and

IT IS FURTHER RESOLVED that based upon the Schedule of Penalties provided by the Director of the Bureau of Alcohol Beverage Control, the Plenary Retail License No. 1222-33-001-005 held by J.P.R.C., Inc. shall be and is hereby suspended for a period of forty-five (45) days. Pursuant to such suspension, J.P.R.C., Inc. is prohibited from engaging in any alcoholic beverage activity in or about the licensed premises including delivery of alcoholic beverages, sale or consumption of alcoholic beverages, or advertisement that the premises are closed for any other reason than suspension. It is the position of the Borough of South Plainfield that the suspension not be converted into a monetary compromise; and

Mr. Rizzo reported that the sale of the property on Hamilton Blvd. to Fisher Contracting finally closed. \$12,000 is being held until the mortgage of record is discharged.

Mr. Cullen briefed the Council on the status of the Early Retiree Reinsurance Program (**ERRP**) stating that \$28,000 has been requested but the request is on hold pending funding. At this point, it doesn't look very promising.

Mr. Miller gave his Engineering Status Report which included

Mr. Frank remarked on how proud he is to be part of the Council and the borough and sited the actions taken during the recent fire as an example of how remarkable the people of South Plainfield are in helping one another.

Mr. Barletta congratulated everyone involved in the presentation of Thursday's Festival concert at the high school and commented on what an outstanding evening it was.

Mr. Bengivenga thanked the Knights of Columbus and UNICO for sponsoring the annual St. Joseph Day event.

Mr. McConville gave an update on the status of the DPW garbage truck/bulk pick up program. They are waiting on the permits needed. Once that is received, residents will be able to phone DPW and make an appointment for individual bulk pick ups.

Mr. Rusnak reported that the Shared Services Committee is looking into possibly having the borough take over the maintenance of the school grounds and fields. They are trying to work out an agreement. He also reported that a report on the condition of the school roofs was left for him in his mailbox and the report indicated that the extent of work and the suggested cost of repairs were over estimated. Mr. Rusnak also noted that Mr. Miller's attendance at meetings has been reduced to an as needed basis rather than having him attend every meeting.

Mayor Anesh commented on how great the Festival Concert at the high school was and congratulated everyone involved. He also commented on the Girl Scouts 100th Anniversary walk over the overpass bridge to Holy Savior Academy and the days activities.

Mayor Anesh opened the meeting for public comment.

Debbie Boyle of Van Fleet made announcements on the following items:

- An update on the condition of the school roofs based on an examination of their condition by a professional roofer.
- The Relay for Life fundraising event to be held April 15 & 16 at Jost Field
- The merits of utilizing a digital sign rather than banners to advertise events
- The Education Asso. Wine Tasting event will be April 13th at Senior Center
- Brandon Carr Walk/Run fundraiser and PBA/RU Coaches basketball game will be held on April 15th at the Middle School
- Tiger 24 will be held April 28th at Jost Field

Paul McCullen of Walnut Street asked if the budget would be published on the Borough website. Mr. Cullen replied that it should be up by Thursday. Mr. McCullen also stated that he was very glad to see that tress on Lakeview Avenue are going to be replaced. He also commented on the work being done by Middlesex County Mosquito Control.

Les Bergen asked about a sewer vac truck he saw working and asked if it was owned by the borough. Mr. Cullen replied that the vehicle he saw is owned by PARSA.

Leon Abbusamara of Schillaci Lane inquired about the plans for the stream restoration downstream of Spring Lake. Mr. Miller gave a summary of the scope of work to be performed

which includes the removal of downed trees, logs, brush, etc. in the stream as well as feeder creeks. Some silt would be removed in the worst spots but the removal of silt is limited by DEP. Mr. Abbusamara emphasized that the borough needs to advocate strongly to correct the problem of the flooding in the area near Fred Allen and Schillaci.

Michael Palace of So. Central Avenue asked for a status on the Quiet Zone proposal. Mayor Anesh responded by explaining that the initial work was done but that funding is an issue. The Council discussed the matter recalling prior discussions and decisions made.

Ginny O'Brien of Madison Drive recalled a prior plan that involved the Army Corps. of Engineers and included the construction of dykes around Spring Lake.

Mayor Anesh closed the public portion of the meeting and the Council moved into Executive Session.

On the Council's return from Executive session, Mayor Anesh announced that not further action was required and he called for a motion to adjourn. Mr. Bengivenga made a motion to adjourn, seconded by Mr. White at 8:50pm.
