PROCLAMATION(S) - Mayor Anesh presented and read the following Proclamations in full;

"Nurse's Appreciation Week" - Mayor Anesh presented the Proclamation to a Nurse who happened to be in the audience. Everyone extended a round of applause. Mayor Anesh emphasized the long hours and hard work that nurses endure and expressed his appreciation for all that they do.

"Emergency Medical Services Week" – Mayor Anesh presented the Proclamation to four EMS members. Mayor Anesh advised that his family has a long history in serving on the EMS and proceeded to thank the EMS members for all that they do. Everyone extended a round of applause and photographs were taken.

<u>PUBLIC COMMENTS ON AGENDA ITEMS ONLY</u>: Mayor Anesh opened the floor for public comments. Mr. Paul McCullen of Walnut Street inquired about Ordinance 1963 and asked if there are any increases. Administrator Cullen advised that there is an increase just shy of 10%. Mr. McCullen concluded by asking what the ratable base pertaining to Resolution 12-134 is? Mr. Cullen explained.

Mr. Frank Mikorski of Regency Place inquired about Resolution 12-134 asking if it is consistent with the recent bond Ordinance. Mr. Cullen said yes. Mr. Mikorski asked who looked over and approved the specification for the new fire pumper truck? Mr. Cullen said both the Fire Chief and Borough Attorney. Mr. Mikorski asked if there is an age restriction for those applying for the part time internship job at the municipal building. Mr. Cullen said no, there is no age restriction, however, the invitation for such an internship was submitted to the high school. Mr. Mikorski asked what type of services 12-139 pertains to. Mr. Cullen advised that it is for someone to assist with our COAH administration as we have a requirement to administer our COAH obligations. Mr. Mikorski then inquired about 12-146 and 12-147 by asking if we are consolidating our debt. Mr. Cullen explained that we are restructuring our outstanding debt to streamline it. We are anticipating a 3% interest rate by doing this. However, this does not authorize any new debt. Mr. Mikorski asked if the DPW has a bucket truck. Mr. Cullen advised that they do, however there has been a recall on it and as such will be laid up for some time. Therefore, instead of being without a bucket truck to service our towns needs, we will rent one temporarily. To conclude, Mr. Mikorski asked what 12-150 is for. Councilman White explained that it is for the maintenance of our existing server.

With no further public comments, Mayor Anesh closed the floor.

The following Ordinance was introduced on first reading and Clerk Antonides read by title. The public hearing is set for June 4, 2012 at 7:00 p.m.:

ORDINANCE NO. 1963 AN ORDINANCE AMENDING CHAPTER 157 OF THE CODE OF THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY ENTITLED "SEWERS"

NOW THEREFORE BE IT ORDAINED by the Governing Body of the Borough of South Plainfield, State of New Jersey that the following be and is hereby amended as follows:

Schedule A Annual Sewer Rental - 2012 (Effective for bill periods beginning July 1, 2012)

This Schedule A hereby establishes three (3) sewer user classes under this ordinance as follows:

- (1) Residential structures

 - (1B) Residential structures reduced rate: \$175.00 per service unit.

All recipients of the \$250.00 real property tax deduction granted in accordance with the provisions of P.L. 1963, C. 172 (R.S. 54:4-8.41) shall be given a deduction in the sewer rental rate that will result in a net annual rate not exceeding \$175.00.

(2) Commercial users

Minimum annual sewer service unit user charge for any Commercial user connected to the Borough Sanitary Sewer System shall be six hundred and forty dollars (\$640.00). The following rates are for actual consumption in 100 cubic feet of water used per information supplied by the water company(ies).

(3) Industrial Establishment Users

(3A) Monitored Industrial establishments:

Notwithstanding any rates set forth herein to the contrary, in no case shall the charge for Monitored Industrial users be less than the charge for an equal volume of flow as otherwise world be determined utilizing the commercial establishments rate set forth in Commercial User (2C) Class 3 rate \$11.255 or for a minimum annual user charge of five hundred dollars and ninety (\$640.00), whichever is higher. In addition to the loading and flow charges, the Monitored Industrial User shall pay for the cost of sampling and laboratory testing of the wastewater.

- (3B) Unmonitored Industrial User\$12.332 per 100 cubic feet
- (4) Sample collection fees and laboratory analysis fees paid by the Borough shall be a pass-through cost to the User being monitored and shall be included on the next bill.
- (5) Application for a Certificate of Use for sanitary sewer review shall be through the Borough Building Department. The fee shall be \$100.00 for an application of a change of building use. This fee is in addition to the current Building Department Review Fee.

All other fees and provisions of this Article shall remain in full force and effect. This amendment becomes effective after final adoption and advertisement in accordance with the law.

Borough shall be obligated to provide for the execution and delivery of the Registered Bonds in certified form.

Section 19. Solely for purposes of complying with Rule 15c2-12 of the Securities and Exchange Commission, as amended and interpreted from time to time (the "Rule"), and provided that the Bonds are not exempt from the Rule and provided that the Bonds are not exempt from the following requirements in accordance with paragraph (d) of the Rule, for so long as the Bonds remain outstanding (unless the Bonds have been wholly defeased), the Borough shall provide for the benefit of the holders of the Bonds and the beneficial owners thereof:

- ending December 31 of the year in which such series of Bonds is issued, to the Municipal Securities Rulemaking Board through the Electronic Municipal Market Access Data Port (the "MSRB") and to the appropriate State information depository ("State Repository"), if any, annual financial information with respect to the Borough consisting of the audited financial statements (or unaudited financial statements if audited financial statements are not then available, which audited financial statements will be delivered when and if available) of the Borough and certain financial information and operating data consisting of (i) the Borough and overlapping indebtedness including a schedule of outstanding debt issued by the Borough, (ii) the Borough's most current adopted budget, (iii) property valuation information, and (iv) tax rate, levy and collection data. The audited financial information will be prepared in accordance with modified cash accounting as mandated by State of New Jersey statutory principles in effect from time to time or with generally accepted accounting principles as modified by governmental accounting standards as may be required by New Jersey law and shall be filed electronically and accompanied by identifying information with the MSRB:
- (b) in a timely manner not in excess of ten business days after the occurrence of the event, to the MSRB and to the State Repository, if any, notice of any of the following events with respect to the Bonds (herein "Material Events"):
 - (1) Principal and interest payment delinquencies;
 - (2) Non-payment related defaults, if material;
 - (3) Unscheduled draws on debt service reserves reflecting financial difficulties;
 - (4) Unscheduled draws on credit enhancements reflecting financial difficulties;
 - (5) Substitution of credit or liquidity providers, or their failure to perform;
 - (6) Adverse tax opinions, the issuance by the Internal Revenue Service of proposed or final determinations of taxability, Notices of Proposed Issue (IRS Form 5701-TEB) or other material notices or determinations with respect to the tax status of the security, or other material events affecting the tax status of the security;
 - (7) Modifications to rights of security holders, if material;
 - (8) Bond calls, if material, and tender offers;
 - (9) Defeasances;
 - (10) Release, substitution, or sale of property securing repayment of the securities, if material;
 - (11) Rating changes;
 - (12) Bankruptcy, insolvency, receivership or similar event of the obligated person;

- (13) The consummation of a merger, consolidation, or acquisition involving an obligated person or the sale of all or substantially all of the assets of the obligated person, other than in the ordinary course of business, the entry into a definitive agreement to undertake such an action or the termination of a definitive agreement relating to any such actions, other than pursuant to its terms, if material;
- (14) Appointment of a successor or additional trustee or the change of name of a trustee, if material.

For the purposes of the event identified in subparagraph (12) above, the event is considered to occur when any of the following occur: the appointment of a receiver, fiscal agent or similar officer for an obligated person in a proceeding under the U.S. Bankruptcy Code or in any other proceeding under state or federal law in which a court or governmental authority has assumed jurisdiction over substantially all of the assets or business of the obligated person, or if such jurisdiction has been assumed by leaving the existing governing body and officials or officers in possession but subject to the supervision and orders of a court or governmental authority, or the entry of an order confirming a plan of reorganization, arrangement or liquidation by a court or governmental authority having supervision or jurisdiction over substantially all of the assets or business of the obligated person.

- (c) in a timely manner to the MSRB and to the State Repository, if any, notice of failure of the Borough to provide required annual financial information on or before the date specified in this resolution.
- (d) If all or any part of the Rule ceases to be in effect for any reason, then the information required to be provided under this resolution, insofar as the provision of the Rule no longer in effect required the provision of such information, shall no longer be required to be provided.
- (e) The Chief Financial Officer shall determine, in consultation with Bond Counsel, the application of the Rule or the exemption from the Rule for each issue of obligations of the Borough prior to their offering. Such officer is hereby authorized to enter into additional written contracts or undertakings to implement the Rule and is further authorized to amend such contracts or undertakings or the undertakings set forth in this resolution, provided such amendment is, in the opinion of nationally recognized bond counsel, in compliance with the Rule.
- (f) In the event that the Borough fails to comply with the Rule or the written contracts or undertakings specified in this resolution, the Borough shall not be liable for monetary damages, remedy being hereby specifically limited to specific performance of the Rule requirements or the written contracts or undertakings therefor.

Section 20. This resolution shall take effect immediately.

<u>Attorney Rizzo</u> – had no report for this evening.

<u>Administrator/CFO Cullen</u> – Advised that it is possible that Resolution 12-146 may effect the pending budget and as such, we may not be able to adopt it just yet.

Municipal Clerk Antonides – had no report this evening.

<u>Councilman Frank</u> – complimented the Fire Department with the great job they did with the Johnny Cash concert at the High School and said it was very enjoyable.

<u>Councilman Barletta</u> - . Councilman Barletta also acknowledged that the Fire Department did a great job with the Johnny Cash concert. Mr. Barletta also thanked our local rescue squad for all that they do.

Councilman Bengivenga – had no report for this evening.

<u>Councilman McConville</u> – advised that he is sorry to have missed the Johnny Cash concert at the High School as he was at a birthday party for his wife. <u>Mayor Anesh</u> – Complimented Nancy Greenier, for the excellent awards dinner for the Junior Journalists last week. It was a great turn-out. Mayor Anesh further advised that he attended the CERT meeting in which they reviewed events for the year. He also advised that confirmations were this past Sunday, and National Honor Society inductions were also held recently. Our Girl Scouts were also recently awarded with Gold and Bronze medals.

PUBLIC COMMENTS

A resident stood up and complimented the Senior Director, Tree, for her hard work there. Mayor Anesh said he agrees that she is doing a fabulous job.

Mr. Paul McCullen of Walnut Street expressed his appreciation to our local EMS. Mr. McCullen went on to say how happy he is to hear the Borough will be looking into user rates for our sewer bills and then expressed concerns pertaining to redevelopment of Mulenberg Hospital citing traffic congestion due to a rumor of a potential large condo structure going there.

Ms. Debbie Boyle advised that the tribute yesterday for first responders was wonderful and added that the Public Works Supervisor, Cappi, is seeking donations for an electric sign to be placed at Borough Hall due to PSE & G prohibiting the placement of banners on their telephone poles. Ms. Boyle concluded by advising that this Thursday morning will be a Business Association meeting and everyone is invited to come out.

Ms. Nancy Greenier, from the Observer, thanked everyone for coming to the Junior Journalist Dinner last week citing that it was a nice turnout and a success. The children appreciate seeing the support of the Council.

Mr. Frank Mikorski of Regency Place thanked the Council for looking into user fees for the sewer rates. Mr. Mikorski inquired about the Borough's 2011 Open Space and Mayor Anesh explained that there is no way to opt out of the required open space taxes. Mr. Mikorski went on to express his concerns pertaining to school taxes.

Mr. Jeff Seider expressed his concerns about the condition in his neighborhood with rats. He advised that last October he spoke to the Borough Council about this and as a result the Council had an exterminator come out at which time I also spoke of concerns with using an exterminator. Mr. Seider said here it is May 2012 and he is still trapping rats. Mr. Seider said for the past eight years he has been doing this and is patience is now exhausted and wants to know what the Council is going to do about it. He added that there was a white dog in the neighborhood that ate the poison and died. Mr. Seider said that he feels the reports from the exterminator are "bogus". Mayor Anesh said that the Council will look into the matter. Mr. Seider said that the exterminator says one thing, but his reports say another and went on to say the traps were not baited. Councilman White said he understands this is a serious issue. Mr. Seider interjected that the problem is not being resolved. Councilman Barletta said that he did read the report and it said the traps were baited. Mr. Seider eluded to the cause of the problem stemming from a neighbors shed. Councilman Barletta advised that we do not have the legal authority to have a neighbor remove their shed. Mr. Seider advised that the exterminator and Health Inspector had said the cause of the problem is his neighbors shed, but then the stories change. Councilman White said he does not recall seeing that verbiage in the report. Mayor Anesh advised Mr. Seider that our Health Inspector will be advised to look into this and that we are not going to be able to resolve this tonight.

Mr. Frank Mikorski said that he can't believe that Mr. Seider is back here this evening with the same problem that has not yet been resolved. Mr. Rizzo, Esq. said it is a matter that needs to be deferred to the County Health Department.

Virginia, from 1840 Eganey Street, asked if a summons could be issued to the neighbor who is causing the rat problem concluding that maybe if they are hit with many costly summons they will be inclined to fix the problem.

Ms. Ginny O'Brien of Madison Drive, said that she had a rat problem years ago and the County Health Officer id d a very good job with helping to resolve the problem. Ms. O'Brien said that she also put her own rat traps out around her property.

Mayor Anesh concluded the public comments by advising that the will have the County Health Inspector look into this tomorrow. With no further comments, Mayor Anesh closed the floor.

At this time Mayor Anesh advised that they will be going into Executive Session and everyone is welcome to stay for their return back into public session.

ADJOURNMENT

The Mayor and Borough Council reconvened back into public session at 9:45 p.m. and advised that there are no matters that require action from the closed session meeting this evening.
