FLAG SALUTE: was led by Mayor Anesh and Councilman Bengivenga led the invocation.

<u>PROCLAMATION(S)</u> - Mayor Anesh presented and read the following three Proclamations in full; Older American's Month during May, Municipal Clerk's Week from May 6th to May 13th, and Police Week from May 13th to May 19th. Everyone extended a round of applause

<u>PUBLIC COMMENTS</u>: Mayor Anesh opened the floor for public comments. Mr. Frank Mikorski of Regency Place inquired if we will receive any grant funding for the road improvement projects that are on tonight's agenda. Mr. Cullen said yes. Mr. Mikorski asked if there is an age limit of who can apply for the Summer Help positions at the Public Works Department. Mr. Cullen said there is a minimum age requirement but not a maximum or up-to age requirement. With no further comments from the public, Mayor Anesh closed the floor from public comment.

Councilman Bengivenga expressed his appreciation for the donation of the Smart Board for the Municipal Court by the Police Department. It is important to note that the Police Chief found that it was more cost effective to make this purchase utilizing our local school boards vendor. The Court will make good use of this new Smart Board and much appreciation goes to the Police Department for their donation.

<u>PUBLIC AUCTION OF SURPLUS MUNICIPAL PROPERTY</u>: Mayor Anesh announced that we have three surplus municipal properties up for auction this evening.

- Mayor Anesh opened the floor announcing a minimum bid amount of \$88,000 for Block 398, Lot 2.01 located on Tremont Avenue. Mayor Anesh called for any bidders. Mr. Hekmatullah Amini of 701 Tremont Avenue was the only bidder with the bid amount of \$88,000. Mr. Rizzo, Esq. reminded the bidder, Mr. Amini, that he has three days to submit cash or a certified check representing 10% of the bid. Mr. Amini provided the Borough Clerk with his contact information.
- Mayor Anesh opened the floor announcing a minimum bid amount of \$100,000 for Block 398, Lot 2.10 located at the Northeast Corner of Harvard Avenue & St. John's Place.
- Mayor Anesh opened the floor announcing a minimum bid amount of \$85,000 for Block 404.03, Lot 1.01 located at the Southeast Corner of Harvard Avenue & St. John's Place. Mayor Anesh called for any bidders. There were two bidders who went back and forth bidding the following increments: \$85,000, \$86,000, \$87,000, \$88,000, \$88,500, \$89,000, \$90,000, \$91,000, \$92,000, \$93,000, and the final bid amount being \$93,500. Mayor Anesh made a last call for bids at \$93,500, with no more bids, the highest bidder was Mr. Michael Socha of 167 Somerset Avenue with the bid amount of \$93,500. Mr. Rizzo, Esq. reminded the bidder, Mr. Socha, that he has three days to submit cash or a certified check representing 10% of the bid. Mr. Socha provided the Borough Clerk with his contact information.

ORDINANCES: Public Hearing and Final Adoption

BOND ORDINANCE #1961

BOND ORDINANCE PROVIDING FOR ROAD AND RESURFACING IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING THE AGGREGATE AMOUNT OF \$608,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$376,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

- Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$608,000, including a grant in the amount of \$225,000 expected to be received from the State of New Jersey Department of Transportation (the "State Grant") for the improvement or purpose described in Section 3(a). Pursuant to N.J.S.A. 40A:2-11(c) no down payment is required for the improvement or purpose described in Section 3(b), an amount equal to \$7,000 is provided for as the down payment as required by the Local Bond Law. The down payment is now available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.
- Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the down payment and the State Grant, negotiable bonds are hereby authorized to be issued in the principal amount of \$376,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.
- Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

a) Road and resurfacing improvements, including, but not limited to, Sampton Avenue, including all work and materials necessary therefor and incidental thereto.	\$468,000 (Includes the State Grant)	\$243,000	10 years
b) Road and resurfacing improvements, including, but not limited to, West 8 th Street, including all work and materials necessary therefor and incidental thereto.	\$ <u>140,000</u>	\$ <u>133,000</u>	10 years
TOTALS	\$608,000	\$376,000	

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the State Grant for the purpose described in Section 3(a) and the amount of the down payment for the purpose described in Section 3(b).

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of the

Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

- (a) The purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements that the Borough may lawfully undertake as general improvements, and no part of the costs thereof has been or shall be specially assessed on property specially benefitted thereby.
- (b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 10 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$376,000, and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$175,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated costs indicated herein for the purposes or improvements.
- Section 7. The Borough hereby declares the intent of the Borough to issue the bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.
- Section 8. Any grant moneys received for the purposes described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or, if other than the State Grant referred to in Section 1 hereof, to payment of the obligations issued pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.
- Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.
- Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.
- Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond
