Borough Attorney Rizzo, Esq. - has no report for this evening.

Administrator Cullen - recognized the many people who put so much work and time into putting together the Labor Day Parade.

<u>Engineer Miller</u> – Mr. Miller briefed the Council on the status of various projects, particularly the multi-road resurfacing project as well as the Sampton Avenue project. The roads are being prepared now. Sampton Avenue and Nunnick Lane bids will be opened later this week.
