Title: "Bond Ordinance Providing for the Paving of Various Roads in and by the Borough of South Plainfield, in the County of Middlesex, New Jersey, Appropriating \$775,000 Therefor and Authorizing the Issuance of \$525,000 Bonds or Notes of the Borough to Finance Part of the Cost Thereof."

Purpose: The paving of various roads, including but not limited to Sampton Avenue Phase #2, Lowden Avenue, Willow Avenue, Bollinger Way, Skene Drive, Libourel Road, Sims Place, Lafayette Place and Strong Place, including all work and materials necessary therefor and incidental thereto.

Appropriation: \$775,000

Bonds/Notes Authorized: \$525,000

Grant Appropriated: N/A Section 20 Costs: \$125,000 Useful Life: 10 years

RESOLUTION AUTHORIZING SETTLEMENT OF 2010, 2011 and 2012 TAX APPEALS FILED BY TEITELBAUM PARTNERS, L.P., FOR THE PROPERTY KNOWN AS 140 SOUTH AVENUE AND IDENTIFIED AS BLOCK 518, LOT 1, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

WHEREAS, Teitelbaum Partners, L.P. (hereinafter referred to as "Taxpayer") is the owner of the property known as 140 South Avenue and identified as Block 518, Lot 1, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$2,250,600 for 2010; and

WHEREAS, the assessed value of the Property was set at \$2,250,600 for 2011; and

WHEREAS, the assessed value of the Property was set at \$2,250,600 for 2012; and

WHEREAS, Taxpayer filed appeals of the 2010, 2011 and 2012 tax assessments in the Tax Court of the State of New Jersey under docket numbers 002724-2010, 002014-2011 and 002312-2012; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the 2010, 2011 and 2012 tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for all three years under appeal; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2010 original assessment in the amount of \$2,250,600 shall be affirmed and remain unchanged;
- The 2011 original assessment in the amount of \$2,250,600 shall be reduced to \$1,885,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2011;
- The 2012 original assessment in the amount of \$2,250,600 shall be reduced to \$1,807,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2012;
- Taxpayer has agreed to waive statutory interest provided the subject refunds are paid within sixty (60) days from the
 date of the entry of Judgment; and

 Refunds regarding over payments shall be made payable to "Teitelbaum Partners, L.P. as Plaintiff and Zipp & Tannenbaum, LLC, as Attorney for Plaintiff" and forwarded to Zipp & Tannenbaum, LLC within 60 days from the date of the entry of Judgment.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

WHEREAS, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reductions to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 1. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$1,885,000 total tax assessment reduction for the 2011 tax year for Block 518, Lot 1 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 2. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$1,807,000 total tax assessment reduction for the 2012 tax year for Block 518, Lot 1 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 3. The Borough Attorney is authorized to execute on behalf of the Borough of South Plainfield the attached Stipulation of Settlement pertaining to the tax appeals filed by Teitelbaum Partners, L.P. under Docket Nos.: 002724-2010, 002014-2011 and 002312-2012, for the property known as 140 South Avenue and identified as Block 518, Lot 1, on the Borough of South Plainfield Tax Assessment Maps which results in the Taxpayer's 2010 tax appeal being affirmed and remaining unchanged; which reduces the 2011 total tax assessment on the Property from \$2,250,600 to \$1,885,000; which reduces the 2012 total tax assessment on the Property from \$2,250,600 to \$1,807,000; which further provides that Taxpayer agrees to waive statutory interest on any refund or overpayment due provided the refund check is paid within sixty (60) days from the issuance of Judgment; and which further provides that any refunds shall be made payable to "Teitelbaum Partners, L.P., as Plaintiff and Zipp & Tannenbaum, LLC, as Attorney" and forwarded to Zipp & Tannenbaum, LLC within 60 days from the date of the entry of Judgment.

COUNCIL REPORTS:

Borough Attorney Paul Rizzo, Esq. - had no report for this evening.

Administrator Cullen - had no report for this evening.

Engineer Miller – briefed the Council on the status of upcoming bid projects. The 3rd party electrical bid will be opened on March 7th and awarded the evening of March 7th. The recycling bid opening will be March 6th and awarded the evening of March 7th. The used tandem dump truck will have a bid opening of March 13th and awarded at the Council meeting of March 18th. To conclude, the survey work for the road improvements for 2013 is underway

Clerk Antonides – had no report for this evening.

<u>Councilman Diana</u> – thanked Cappi and the DPW for the emergency work that they recently performed on a pipe. Their fast action saved the Borough a lot of money. Councilman Diana commented on being happy to see Ordinance 1984 on this evening, having grown up in that area he has seen a lot of 18 wheelers getting hung up there.

Councilman Barletta – reported progress for this evening.

<u>Councilman Bengivenga</u> – pointed out that under "Correspondence" this evening you will see the resignation of Susanne Lyte from the Cultural Arts Commission and she has served on this Commission for a good many years and will be well missed. She is resigning as she is moving out of town. Councilman Bengivenga thanked her for her many years of service. Councilman Bengivenga also commented on how the bond ordinance this evening will enable us to continue with our road resurfacing program.

<u>Councilman McConville</u> – praised Cappi and the DPW for their expedient work fixing a broken water pipe on Lowden Avenue. They fixed the pipe in no time at all and saved the Borough a good deal of money. Kudos also to Stilo Excavating who assisted the DPW with this emergency repair. Also the DPW did a fantastic job last Friday during the snow storm and have already had many residents compliment the DPW for a job well done.

<u>Councilman White</u> – advised that he had attended the Valentine's Day party at the Senior Center in which over 100 were in attendance. The annual Cultural Arts Talent Showcase will be held on February 24, 2013. Read Across America events will be taking place all during March at our local schools and library. Recreation T-Ball Ponytail registration is still taking place. Councilman White concluded by congratulating the South Plainfield wrestling team on another win.

<u>Council President Rusnak</u> – advised that the goal he would like to see this year is for all the road projects to be completed by Labor Day this year. Council President Rusnak complimented Councilman Bengivenga on his negotiations with the Professional Managers as they have settled for 1.5% for the next three years.

Councilman Diana interjected that there was one thing he forgot to comment on earlier in that he received a call from a resident pertaining to all the trucks on Hamilton Blvd. and we did discuss a few meetings ago that perhaps GPS needs to be updated. Councilman Diana said he feels the truck issue on Hamilton Blvd. continues to be an issue and we need to explore this further as it continues to be a problem. Councilman Barletta said that he live off of Belmont Avenue and travel Hamilton a lot and do not see that many trucks, on occasion yes. Councilman Barletta said he would like to hear a statistic as he does not really see this as a big issue. There are so many signs telling trucks that they can't go on Hamilton Blvd. that I don't know what else you can do. There is at least six signs that say "no tucks allowed". Councilman Barletta said he believes the Police Department is doing and good job and sees them pulling trucks over. We have done all we can do. Councilman Barletta reiterated that he doesn't think it is that big of a problem. Councilman Diana said the only thing he can do it bring it to the Council when he hears of such a complaint. Councilman Diana said he suggests we see about updating the GPS as he does not have any statistics in this regard. Mayor Anesh said we can certainly look into the GPS aspect. Also Mayor Anesh said that he has been in contact with the Police Chief any time this issue has come up. The Chief doesn't need anyone on this Council to tell him to enforce the laws, as he already is doing that. Mayor Anesh said he essentially has had no residents come to him or to any Council meetings to complain about this. We do get calls endlessly on certain issues out there but, this is not one of them. Mayor Anesh turned to the Police Chief Parker in the audience and asked him if he is getting any of these phone calls or complaints. Chief Parker said no. Mayor Anesh advised Councilman Diana that if he is getting these complaints to have the people come forward. Council President Rusnak asked Councilman Diana to please forward via email the contact names and phone numbers of those who have complained about this matter so that he can reach out to them. Councilman Diana said he will see if they are comfortable with that. Council President Rusnak said he is sure they will be comfortable with that and to please forward the information to him.

<u>Mayor Anesh</u> – reported that the Mayor's Healthy Bake-Off is forthcoming. Also the Biggest Loser contest has ended and the results will be reported shortly. The wedding donations are still being determined and hope to have some ideas back in the near future.

Mayor Anesh concluded by advising that approximately 7:45 this evening the FBI and Attorney General has issued a press release pertaining to an incident that took place in town involving a former South Plainfield Police Captain; Michael Grennier. The arrest took place last Friday, February 15th in which they have charged Mr. Grennier with sexual exploitation of children. There is another individual involved in this case who has also been arrested and we believe has faced a Judge in Newark today. Those exact charges have not yet been released publically nor have they been included in this evening's press release that has gone out by the Attorney General's Office. Mayor Anesh said that it goes without saying that he as well as the Council's thoughts and prayers go out to the victims and their families. Mayor Anesh said that if these allegations are true the he, like everyone else, is physically angry and disgusted that such a thing could happen anywhere, let alone in our little community. Mayor Anesh said he has been told this investigation is ongoing and thus cannot provide any more details. Mayor Anesh advised what he can say is that the FBI was, and still is, the lead investigative body in this crime. The South Plainfield Police Department, particularly the Detective Bureau has assisted with this investigation led by Chief Parker. Their assistance will continue until such time the matter is brought to its conclusion. As more reportable details become available we will keep the residents apprised. Mayor Anesh concluded by respectfully asking that there be no questions at this time and that frankly he has told everyone all that he knows.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Mr. Robert Capparelli said he wanted to thank Stilo Excavating for their help with assisting the DPW with the recent emergency water pipe leak. Stilo goes above and beyond to help our town when needed.

Debbie Boyle of Van Fleet asked if the Board of Education is on our Recycling bid as there was an issue in the past about this. Council President Rusnak said yes. Mrs. Boyle went on to advise of all the upcoming events and dates for various activities in town.

Mr. Bob Richkus of 1325 Famularo Drive thanked the Governing Body for their support of resolution #13-74 this evening for the Alliance. Mr. Richkus also thanked Glenn, Amy and Anne for all their help.

With no further comments from the public, Mayor Anesh closed the floor.

At this time, 7:48 p.m., Mayor Anesh advised that the Council will be going into Executive Session and everyone is welcome to stay for their return back into public session.

ADJOURNMENT

Without further comment, Mayor Anesh called for a motion to adjourn. Council President Rusnak made a motion to adjourn at 8:09 p.m., seconded by Councilman White and unanimously carried. The meeting was adjourned.
