#1995 AN ORDINANCE AMENDING ORDINANCE 409-36 OF THE BOROUGH OF SOUTH PLAINFIELD TITLED "BONDS; CASH DEPOSIT"

WHEREAS, the Borough Code provides a permit process for public utilities desiring to make excavations or openings in streets, but does not provide for the payment of costs associated with engineering inspections necessary when such excavations or openings occur; and

WHEREAS, the Mayor and Council deem it appropriate that any public utility desiring to make excavations or openings in streets should pay all associated costs of same;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Section 409-36 of the Code of the Borough of South Plainfield titled "Bonds; Cash Deposit" shall be amended to be titled "Bonds; Cash Deposit; Inspection Fee Escrow", and a paragraph D. shall be added to such Section of the Code to read as follows:

Inspection Fee Escrow. The applicant shall post an escrow fee with the Borough Clerk to defray the cost of inspection of the excavation or opening in the street and paving restoration, such inspection to be conducted by the Borough Engineer. The Borough Engineer shall estimate the construction cost and the public utility shall post an escrow fee

to cover such cost in an amount that shall be equal to 12% of the estimated construction cost as determined by the Borough Engineer; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that wherever Ordinance 409-36 references "the South Plainfield Sewerage Authority", such wording shall be replaced with the phrase "the South Plainfield Sewer Utility".

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

WHEREAS, Santo V. Sorce Company, LLC (hereinafter referred to as "Taxpayer") is the owner of the property known as 104 New Era Drive and identified as Block 308, Lot 42, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$779,000 for 2011, 2012 and 2013; and

WHEREAS, Taxpayer filed appeals of the 2011, 2012 and 2013 tax assessments in the Tax Court of the State of New Jersey under docket numbers 011801-2011, 011106-2012 and 011334-2013; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the 2011, 2012 and 2013 tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for all three years under appeal; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2011 tax appeal shall be withdrawn by Taxpayer;
- The 2012 original assessment in the amount of \$779,000 shall be reduced to \$655,500 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2012;
- The 2013 original assessment in the amount of \$779,000 shall be reduced to \$702,100 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2013;
- Taxpayer has agreed to waive statutory interest provided the subject refunds are paid within sixty (60) days from the date of the entry of Judgment;
- Refunds regarding over payments shall be made payable to "Santo V. Sorce Company, LLC, as Plaintiff and Saiber, LLC, as Attorney for Plaintiff" and forwarded to Jason A. Rubin, Esq., c/o Saiber, LLC, 18 Columbia Turnpike, Florham, NJ within 60 days from the date of the entry of Judgment; and
- The parties agree that the provisions of N.J.S.A. 54:51A-8 (Freeze Act) shall not be applicable to this case.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above

and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

WHEREAS, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reductions to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 10. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$655,500 total tax assessment for the 2012 tax year for Block 308, Lot 42 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 11. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$702,100 total tax assessment for the 2013 tax year for Block 308, Lot 42 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 12. The Borough Attorney is authorized to execute on behalf of the Borough of South Plainfield the attached Stipulation of Settlement pertaining to the tax appeals filed by Santo V. Sorce Company, LLC under Docket Nos.: 011801-2011, 011106-2012 and 011334-2013, for the property known as 104 New Era Drive and identified as Block 308, Lot 42, on the Borough of South Plainfield Tax Assessment Maps which results in a withdrawal of Taxpayer's 2011 appeal; which reduces the 2012 total tax assessment on the Property from \$779,000 to \$655,500; which reduces the 2013 total tax assessment on the Property from \$779,000 to \$702,100; which further provides that Taxpayer agrees to waive statutory interest on any refund or overpayment due provided the refund check is paid within sixty (60) days from the issuance of Judgment; which further provides that any refunds shall be made payable to "Santo V. Sorce Company, LLC, as Plaintiff and Saiber, LLC, as Attorney" and forwarded to Jason A. Rubin, Esq. c/o Saiber, LLC, 18 Columbia Turnpike, Florham Park, NJ within 60 days from the date of the entry of Judgment; and which provides that the provisions of N.J.S.A. 54:51A-8 (Freeze Act) shall not be applicable to this case.
- 13. This settlement shall be without prejudice to the Borough's dealings with any other taxpayer's request or appeal for a tax assessment reduction.

WHEREAS, the foregoing vendors have previously responded to a request for bids and qualified for snow removal services;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Municipal Clerk Borough of South Plainfield, County of Middlesex, State of New Jersey are hereby authorized to execute service contracts between the Borough of South Plainfield and the foregoing vendors to provide snow removal services for the 2013/2014 Winter season at the rate of \$135.00 per hour for vehicles with a gross weight of 8,000 to 21,000 pounds, and a rate of \$165.00 per hour for vehicles with a gross of 21,000 pounds, conditioned upon each such vendor providing proof of liability insurance in an amount of not less than \$1,000,000.00 per occurrence.
