A SEWER ORDINANCE AUTHORIZING THE "ACQUISITION OF SEWER PUMPS AND ASSOCIATED EQUIPMENT" FOR THE HADLEY PUMPING STATION, IN THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

BE IT ORDAINED BY THE GOVERNING BODY OF THE BOROUGH OF SOUTH PLAINFIELD, NEW JERSEY as follows:

Section 1. The aforementioned assets be funded by existing funds in the Sewer Capital Improvement Fund. The funding requirements shall be identified by asset as follows:

Sewer Pumps & Station \$70,000.00

Totals \$70,000.00

- Section 2. That the improvements described in Section 1 hereof shall be authorized as general capital improvements for the Borough of South Plainfield in the County of Middlesex, New Jersey.
- Section 3. It is hereby determined and declared by this Mayor and Borough Council as follows:
 - A. That the maximum estimated amount of money to be raised from all sources for the purposes stated in Section 1, hereof, is \$70,000.00.
 - B. That the cost for the equipment shall be \$70,000 from from the Capital Improvement Fund.
 - C. The estimated useful life of said improvements is hereby determined to be ten (10) years.
- Section 4. That the total amount of the appropriation to be expended for Architectural and inspection costs, legal costs, advertisement of ordinance and other expenses as provided in Section 48:2-20 of the Revised Statutes, is not to exceed \$1,000.00.

Section 5. This ordinance shall take effect after final passage and publication in accordance with the law.

<u>ORDINANCE – FIRST READING BY TITLE</u> – the following two ordinances were read by title by Clerk Antonides. The public hearing was set for May 5, 2014 at approximately 7:00 p.m.

ORDINANCE # 2000 CALENDAR YEAR 2014 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET COST OF LIVING ALLOWANCE AND TO ESTABLISH A CAP BANKWHEN THE COLA IS EQUAL TO OR LESS THAN 2.0 PERCENT (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. A. 40A:4-45.1 *et seq.*, provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.0% or the Cost-of-Living Adjustment (COLA), whichever is less, over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.14 provides that a municipality may, in any year in which the COLA is equal to or

less than 2.0% increase its final appropriations by a percentage greater than the COLA, but not to exceed the 3.5% rate as specified in the law, when authorized by ordinance; and,

WHEREAS, the COLA for 2014 has been certified by the Director of the Division of Local Government Services in the Department of Community Affairs as .5% and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, in any year in which the COLA is equal to or less than 2.0%, may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of South Plainfield in the County of Middlesex finds it advisable and necessary to increase its 2014 budget by more than .5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$627,849.18 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2014 budget year, the final appropriations of the Borough of South Plainfield shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$732,490.71 and that the 2014 municipal budget for the Borough of South Plainfield be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Councilman Diana questioned the period of usefulness for Ordinance 2001 being 20 years asking why such a long period. Mr. Cullen explained that it is the bond law that provides for the useful life of which the bond counsel refers to when creating bond ordinances. Councilman Diana said this is not something he can support. Mayor Anesh described the merit of the work to be performed. Councilman Diana clarified that his opposition is to the bonding and not the work performed. Mayor Anesh clarified that Councilman Diana's position is to put this project directly in the current year's budget. Councilman Diana said that he believes that is something that should be considered. Councilman Bengivenga advised that pursuant to his meetings with Administration and Finance he believes this to be the last bond of the year, of which is less than last year. Also, Councilman Bengivenga stressed that a good portion of this project is being off-set by D.O.T. grant funding. There are about four roads that are covered by this bond.

BOND ORDINANCE 2001

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$409,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$386,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$409,000, and further including the aggregate sum of \$23,000 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, negotiable bonds are hereby authorized to be issued in the principal amount of \$386,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

d) The acquisition of a generator for the High School, including all related costs and expenditures incidental thereto.	\$ <u>25,000</u>	\$ <u>23,000</u>	15 years
Total:	\$ <u>409,000</u>	\$ <u>386,000</u>	

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with A0775957

the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvements or purposes described in Section 3(a) of this bond ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.
- (b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 11.19 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$386,000, and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$61,350 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.
- Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance.

 This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.
- Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.
- Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on A0775957

behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the ARule@) for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

BUDGET RESOLUTIONS: Clerk Antonides read both budget resolutions by title. Mayor Anesh called upon Councilman Rusnak (Finance Chairman), to brief the Council on the status of the introduced 2014 budget. Councilman Rusnak spoke of fond memories of former resident, Frank Makorski. Councilman Rusnak announced that there will be a zero tax increase this year. The amount raised by taxes is down by \$72,963.00 from last year. Councilman Rusnak said that as introduced, the average home will be paying about the same in municipal taxes as it did a year ago. That figure amounts to \$1,591 per home (on average), and added that he hopes to see that figure go down by the time the budget is adopted. The zero increase is despite the dramatic increases in snow removal, Hurricane Sandy clean-up efforts, and healthcare costs. The budget does not rely on any land sales or one time gimmicks. The budget is \$754,000 below the Governor's levy cap and \$975,000 below the appropriation cap. We had a lot of finance meetings and a lot of time and effort went into this. Councilman Rusnak thanked all who worked on this and said the residents are well deserving of a zero percent tax increase. Councilman Diana said the devil is in the details and that he unfortunately has not had the opportunity to review this budget having requested information on it on April 9th and has not yet received anything. Councilman Diana said he is very disappointed not having the opportunity to go over the budget line item by line item to see where we are and where we are going. Councilman Rusnak advised that Councilman Diana had ample opportunity to reach out to him with any questions he may have had regarding the budget, despite Councilman Diana being away on vacation. Councilman Rusnak advised that we have a month before the public hearing and he would be glad to answer any questions Councilman Diana may have. Councilman Rusnak further stated that he would welcome any suggestions any member of Council may have pertaining to the budget. Councilman Diana pointed out a "factual discrepancy" that April 9th he had indeed inquired about the budget and quoted email correspondence he had. Councilman Diana again expressed his concern about not having received budget information sooner and that his vacation status is irrelevant as he was available through internet connections. Mayor Anesh pointed out that historically the budget has always been worked on and put together by the Administration and Finance Committee. This committee than presents the introduced budget to Council of which they then have ample time to review and evaluate it prior to a public hearing and adoption. Preparing the data for the introduction of a budget each year goes down to the minute. They are not done and formulated well in advance. That does not prevent you from sitting down with the Finance Committee and asking A0775957

any pertinent questions you have. Mayor Anesh said that Councilman Diana can certainly abstain this evening and not make any decision. There is no one trying to keep information from Councilman Diana. We have a budget that is being introduced that is flat and doesn't think there are very many people in New Jersey who would vote against a flat budget. Mr. Cullen clarified that no one who was not part of the Administration Finance Committee were sent budget information. No one was treated any differently. Most of the detailed budget was stilled being keyed throughout Thursday. There are thousands of transactions. We don't put thousands of transactions into the system then back thousands of transitions out. Thus when Councilman Diana asked for the detailed budget, Mr. Cullen said he did not have it. Mr. Cullen said that if anyone wishes to go and look at the computer for dates, to go ahead. He did not have it. That may not be adequate for some, but that is the truth. If you want a different explanation, none exist. No detail went to anyone. Some departments were done, others were not. Mr. Cullen said he is available anytime for all the Council pertaining to their budget questions. Mr. Cullen said he will give the Council anything they want (if it exists) and went on to stress that some of the items asked by Councilman Diana were not reports during his 12 year tenure that were ever asked or required before. It is not something that can just be whipped together. Mayor Anesh asked Mr. Cullen if there is anything different for this introduction than any other in the past 12 years. Mr. Cullen said no, this is the same procedure we always have used and do not recall a time ever handing out detailed budgets prior to budget hearings. Councilman Diana said no one is questioning Mr. Cullen's abilities or intent. Mr. Cullen said he did not receive the state formatted budget document until Thursday of which copies were then distributed to the Council. Mr. Cullen said he will be happy to provide whatever he is able to. Councilman Diana asked Mr. Cullen if he could provide him with the 2013 and 2014 summary. Mr. Cullen said he will do that. Councilman Bengivenga concluded by advising that this is still a work in progress. He himself had called Mr. Cullen up until 3pm today regarding the budget.

COUNCIL REPORTS:

Borough Attorney Paul Rizzo, Esq. - reported progress.

<u>Administrator Cullen</u> – reported that we will begin meeting with Department Heads to discuss their respective budgets.

<u>Engineer Miller</u> – gave a progress report pertaining to the forthcoming bid for the Montrose Avenue road improvements in which he hopes to be able to award a bid by the second meeting in May.

<u>Clerk Antonides</u> – advised that instructions for filing the annual Financial Disclosure Statements will be forthcoming pursuant to a recent webinar on the subject.

Councilman Diana – advised that this past Saturday's spring clean-up was a success with 175 participants. Councilman Diana thanked all who participated. Councilman Diana also thanked Len Miller for his assistance with a water issue near the Progressive Building. Also, Councilman Diana asked if the Council could look into vacating all the paper streets in the Highland woods area.

<u>Councilman Rusnak</u> – advised that he looks forward to hearing of any suggestions pertaining to the 2014 budget.

Councilman Bengivenga – reported progress.

Councilman Richkus - reported a successful opening day of baseball and softball. There was a nice turnout.

Councilman White - reported progress.

Council President Barletta – reported progress.

<u>Mayor Anesh</u> – reminded everyone that the Mayor's Wellness is having their Spring Health Fair on April 26th at the Senior Center. Also the "Caught on a Walk Program is in effect. Mayor Anesh announced that the theme of the Health Fair will be "Step Up South Plainfield" in which pedometers may be given out.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Ms. Nancy Grennier asked about resolution #14-140 in which Mr. Cullen responded that this appeal is not part of the recent bond. Ms. Grennier reminded everyone that May 21st is the Junior Journalist Banquet.

Mr. Sorrentino advised that Mr. Subs is sponsoring an event to help support a local family in need.

Ms. Debbie Boyle from Van Fleet reported on all the various events

Ms. Chrissy Buteas of 434 Lucy Court applauded Councilman Diana for asking some of the tough questions. It seemed disturbing that he had not received the information he requested in a timely manner. Trying to contact the Council from Iceland seems to speak volumes of his dedication. Ms. Buteas asked to go over the highpoints of the budget. Councilman Rusnak reiterated the highlights he stated earlier in the evening. Ms. Buteas expressed her concerns over expenses being too high. Mayor Anesh agreed citing the largest of the expenses are due to snow removal, hurricane clean-up and healthcare costs; most of which were unforeseen costs. Mayor Anesh went on to say that we could have chosen to let the snow melt and spend nothing, or, we plow the roads. Mr. Cullen further explained the mechanics of it. Ms. Buteas suggested that pencils need to be sharpened. Mayor Anesh said that some of these major expenses were unforeseen and cannot be sharpened away. You cannot sharpen away the snow. We do look at all expenditures which is why you are seeing zero tax increase today; less than what you had in 2009. Ms. Buteas said this is being done due to one-time land sales and FEMA funding. Mayor Anesh countered by saying that Ms. Buteas in 2009 sat on Council and took a full year's state aid and balanced it with six month budget. To summarize, further dialog went back and forth pertaining to the 2014 budget and varied differences of opinion. Ms. Buteas went on to question this evenings bond ordinance and asked about the history of Montrose Avenue. Councilman Bengivenga and Mayor Anesh responded. Ms. Buteas asked about a resolution pertaining to computer and information technology that was on the agenda. Mr. Cullen explained it includes servers for the court office, recreation, and various upgrades to our software systems throughout the borough of which have not been upgraded in years. Ms. Buteas expressed concerns about how the current senior center rental ordinance reads and suggested that the fees charged for non-profits use of the senior center be reviewed and perhaps amended to charge non-profits the lower rental fee. The Council asked Mr. Rizzo to look into this.

With no further comments from the public, Mayor Anesh closed the floor. At 7:35 p.m. Mayor Anesh called for a recess from the public portion of the meeting to go into Executive Session advising that everyone is welcome to stay if they choose.

Without further comment and no more action necessary for this evening, Mayor Anesh called for a motion to adjourn. Councilman White made a motion to adjourn at 7:55 p.m., seconded by Councilman Rusnak and unanimously carried. The meeting was adjourned.
