Section 5. This ordinance shall take effect after final passage and publication in accordance with the law.

RESOLUTION 2014-226 AUTHORIZING A REVIEW OF COMPLIANCE WITH PRIOR ANNUAL CONTINUNING DISCLOSURE OBLIGATIONS AND PARTICIPATION IN THE SECURITIES AND EXCHANGE COMMISSION'S MUNICIPALITIES CONTINUNING DISCLOSUE COOPERATION INITIATIVE

WHEREAS, the above-defined issuer has previously issued one or more series of bonds, including in the past five (5) years pursuant to one or more preliminary and final official statements (collectively, the "Bonds"); and

WHEREAS, in connection with the issuance of such Bonds, the issuer covenanted with Bondholders to provide certain secondary market disclosure information on an annual basis to the National Recognized Municipal Securities Information Repositories (pre-2009) and to the Municipal Securities Rulemaking Board's Electronic Municipal Market Access Data Port (2009 to present) ("EMMA"), which secondary market disclosure information may consist of one or more of the following: audited financial statements, municipal budgets, other financial and operating data and ratings changes; and

WHEREAS, the Securities and Exchange Commission (the "SEC") has recently focused attention on what is alleges is widespread failure of local government issuers across the nation to meet their continuing disclosure obligations and misrepresentation through material misstatements in an official statement (innocently, inadvertently or otherwise) of past compliance with continuing disclosure obligations; and

WHEREAS, in an effort to remedy these perceived issues, the SEC has implemented the Municipalities Continuing Disclosure Cooperation Initiative (the "SEC Initiative"), a limited-time program ending at 12:00 a.m. on September 10, 2014, that encourages issuers of municipal bonds, including the issuer, to self-report possible material misstatements or omissions, made in the past five (5) years in an official statement regarding compliance with prior continuing disclosure obligations; and

WHEREAS, should the SEC determine than an issuer has made material misstatements in an official statement regarding compliance with prior continuing disclosure obligations, issuers participating in the SEC initiative agree to accept certain non-monetary penalties, in lieu of unknown, and, by all accounts, hefty monetary and non-monetary penalties the SEC has threatened on issuers that do not participate in the SEC initiative; and

WHEREAS, by participating in the SEC initiative, issuers agree to accept the following penalties, if imposed by the SEC (i) compliance with a cease and desist order in which the issuer neither admits nor denies the findings of the SEC, (ii) implementation of policies, procedures and training regarding

continuing disclosure obligations, (iii) compliance with all existing continuing disclosure undertakings, (iv) cooperation with any further SEC investigation, (v) disclosure of settlement terms in any final official statement issued within five years of the date of institution of the proceedings, and (vi) production to

the SEC of a compliance certificate regarding the applicable undertakings on the one year anniversary of the proceedings; and

WHEREAS, on July 24, 2014, the Division of Local Government Services issued Local Finance Notice 2014-9 (i) alerting local governments of the SEC initiative, (ii) strongly recommending that local governments examine their continuing disclosure contractual obligations and past official statements in order to determine if it is advisable for an issuer to participate in the SEC initiative and (III) cautioning local governments that fail to complete a disclosure assessment in connection with the SEC initiative will likely have difficulty accessing capital markets, difficulty in receiving timely approvals of the Local Finance Board or Director of the Division of Local Government Services, as applicable, and decreased scores on the future "Best practices Questionnaires"; and

WHEREAS, the issuer desires to conduct a disclosure audit which will (i) summarize the results of the issuer's prior compliance with its secondary market disclosure obligations and (ii) compare those results to the statements made by the issuer in its official statements regarding past compliance (the "Disclosure Audit"); and

WHEREAS, the issuer further desires to retain the services of disclosure specialist to conduct the Disclosure Audit; and

WHEREAS, based on the results of the Disclosure Audit, and weighing heavily the known, non-monetary penalties that may come through the issuer's participation in the SEC initiative versus the unknown, and, by all accounts, hefty monetary and non-monetary penalties the SEC has threatened on issuers that do not self-report, the issuer further desires to delegate to the Chief Financial Officer, in consultation with the issuer's general counsel, bond counsel, auditor and other finance professionals, the power to prepare and submit all documentation required to enter the issuer's Bond issues into the SEC initiative, as necessary;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BOND OF THE ISSUER, AS FOLLOWS:

Section 1. The issuer hereby authorizes completion of the Disclosure Audit.

Section 2. The issuer hereby authorizes the Chief Financial Officer to engage the services of a disclosure specialist to complete the Disclosure Audit; provided that the award of any contract in connection therewith meets the requirements of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.).

Section 3. In the event the Disclosure Audit reveals that the issuer <u>may</u> have made a material misstatement regarding the issuer's compliance with prior continuing disclosure undertakings, the issuer hereby authorizes and directs the Chief Financial Officer to prepare and submit all documentation necessary to enter the issuer's applicable Bond issues into the SEC initiative.

Section 4. Any action taken by the Chief Financial Officer, or any other officer of the Issuer, with respect to the Disclosure Audit, the engagement of a disclosure specialist and participation in the SEC initiative is hereby ratified and confirmed.

Borough Attorney Rizzo, Esq. – reported progress.

Administrator Cullen – advised that everyone has received a copy of the 2013 municipal audit and as evidenced by it, it was a very good year. Mr. Cullen said he feels pretty comfortable saying the Borough will be ending 2014 with an increase in surplus. Mrs. Cullen said she was notified by the Public Celebrations Chairman, John Sorrentino and the Secretary, Debbie Boyle, that that Public Celebrations Committee met and decided to allow her to donate the \$300 for this special award. Then Mrs. Cullen said she was sent a press release from the Public Celebrations Secretary in which it was published accordingly; acknowledging that the Alternative Press will be sponsoring this award. There seemed to be so much going on regarding this award donation that Mrs. Cullen said she decided to exercise her right and submit an OPRA request to find out exactly what was going on. Since submitting an OPRA request there was a decision made all of a sudden to rescind her donation. Mrs. Cullen said that after her own investigation through this OPRA request in reading many emails she is pretty certain that an email that went out by the Chairman, John Sorrentino, to the entire Public Celebrations Committee asking for "action and a vote as soon as possible" is a violation of the Sunshine Law. An action was taken behind the scenes to block her donation. Mrs. Cullen said she is hurt and astounded after having read these emails. She has received phone calls from people now scared of repercussions. Mrs. Cullen said in her opinion, she should not be surprised as there seems to be a small group of people who manipulated innocent volunteers who are dedicated to our community. Mrs. Cullen said she will gladly supply this information from this OPRA request to prove that she feels there was a violation of the Sunshine Law that has taken place. To conclude, Mrs. Cullen said she wants to clarify her motive. South Plainfield is all about people getting involved for the betterment of our community. She said she personally wrote an email to the Parade Committee and Mr. Sorrentino asking if he could distribute it to the full committee explaining her position. Mrs. Cullen said that as a result of her OPRA request, it was not distributed accordingly. However, another party did the same thing and sent an email to Mr. Sorrentino asking for it to be distributed to the committee and it was. Mrs. Cullen said in her opinion, this act is malicious and it's slander on the part of the head of this committee who is entrusted by his entire committee. Mrs. Cullen said he violated the law and her rights as a citizen. She then asked both Mr. Rizzo Esq., and Councilman Richkus to look into this also.

Mayor Anesh said first he wants to congratulate the Library Board President, Darlene Cullen as well as the trustees on the recent ground breaking ceremony. The kids had a great time. It was a great day for South Plainfield. Much credit is given to the Public Celebrations Committee, Cultural Arts and all those many other people who contributed to such a successful event.

As for the Public Celebrations Committee, this is very unfortunate, sad and disturbing. One thing that we looked at over the years has been how to get more people involved with the floats at the parade. There were many ideas, one being to solicit businesses for sponsorships. It was a noble idea. Mayor Anesh said that he has checked with our Borough Attorney as to the legalities of the Borough sponsoring a donation in this regard but our attorney feels the Borough is not able to do this. So that leaves us to seek out businesses for their sponsorships. The intent has always been to help spark more interest in the floats. Mayor Anesh said that it is his understanding that the Alternative Press in this case offered a \$300 donation to sponsor the best float and then asked if they would be able to judge it as well. It most certainly is not earth shattering or unrealistic to ask to judge a float that you are sponsoring the award for. Somehow a member of this committee thought this to be some unfair advantage and decided to announce this request to the editor of the other newspaper in our town. What transpired was a complete misrepresentation of what was actually intended. What should have been, and still is, an honest offer to solve an issue and be considered as a sponsor has morphed into something that never should have taken place. It is uncalled for and unfortunate. Mayor Anesh said he saw the email in which the Chairman was calling for a vote of the entire membership to rescind the acceptance of this donation. Again, the whole thing is just uncalled for and unfortunate. Mayor Anesh said that he brings all this up because several years back as the result of the annual notice to businesses seeking their sponsorship, a company made some offers seeking to be more involved than what the sponsorship requested. They requested to meet with him as the Mayor and offered a \$5,000 donation at the time. They wanted to be more involved because they were seeking more exposure for their business. Mayor Anesh said the point is; the businesses are making these sponsorships in the first place to add more exposure for their establishments. Back then we didn't turn down \$5,000 so why would we turn away \$300. That would set a bad precedent especially when we are reaching out to the community and businesses seeking their support. Mayor Anesh said he doesn't want to see debate over what donations from businesses can and cannot be accepted. Mayor Anesh thanked Mrs. Cullen for her donation and said he hopes this issue to be resolved quickly. Mayor Anesh turned to Councilman Richkus and said he is looking to him to help broker a resolution of this issue because at the end of the day this parade is about South Plainfield and our history.

With no further comments from the public, Mayor Anesh closed the floor. At 8:06 p.m. Mayor Anesh called for a recess from the public portion of the meeting to go into Executive Session advising that everyone is welcome to stay if they choose.

ADJOURNMENT

Without further comment and no more action necessary for this evening, Mayor Anesh called for a motion to
adjourn. Councilman Richkus made a motion to adjourn at 8:16 p.m., seconded by Councilman White and
unanimously carried. The meeting was adjourned.
