<u>CALL TO ORDER:</u> Mayor Anesh called the meeting to order at 7:02 p.m. Mayor Anesh read the sunshine statement and announced that same is being held pursuant to the Open Public Meetings Act of 1974 and all provisions of that Act have been met with adequate notice of this meeting having been provided to the Borough's two official newspapers and also published on the Borough's website.

Flag Salute: was led by Mayor Anesh and Councilman Barletta led the invocation.

<u>Public Comment:</u> Mayor Anesh opened the floor for public comment on agenda items only. With no comments from the public, Mayor Anesh closed the floor.

LEGAL CLAIFICATION – VFW BUILDING: At this time, Mayor Anesh turned the floor over to Borough Attorney Rizzo to provide clarification on a recent situation pertaining to the VFW that has recently generated some false and negative accusations against the Borough Council via Facebook posts.

Mr. Paul Rizzo Esq., provided the history of the transaction of the VFW building. There have been comments that the Borough Council refuses to discuss this matter. The fact is Mr. Rizzo has been trying to discuss this matter on behalf of the Mayor and Council to find a solution to a statutory problem since May, 2014. Mr. Rizzo said he wrote to Tom Lanza, the VFW attorney, back on May 8, 2014 to alert him of this statutory problem. Back in May, Mr. Rizzo advised Mr. Lanza that he doesn't believe we have the legal authority to release the restrictions but the Governing Body is more than willing to work with the VFW but is constrained by Mr. Rizzo's legal opinion. Mr. Rizzo said he received no response from that correspondence. Mr. Rizzo than followed up with an email to Mr. Lanza in July asking him what the status is having heard nothing from his first communication. Again, Mr. Rizzo said he received no response from Mr. Lanza. On July 21, 2014 Mr. Rizzo said he received a message from Mr. Lanza's office saying that he was away on vacation and will get back to him on Thursday afternoon upon his return. Again, Mr. Rizzo said he did not receive a response. Mr. Rizzo than sent Mr. Lanza another email on August 6, 2014 asking him for some background on this matter. Again, Mr. Rizzo said he did not receive any response from Mr. Lanza. This has been the history of it in our trying to reach out to the VFW's attorney to try to resolve this matter. By December 2014, this situation started to come to a head as Mr. Rizzo was alerted by the buyer's attorney that they were to make an application to the Board of Adjustment for a variance. Mr. Rizzo said he then wrote to both Mr. Lanza and the buyer's attorney to alert them that we have never received any contact or communication from anyone to try to resolve the issue with the statute. On December 30th, Mr. Rizzo said he received communication in which the Commander of the VFW will be reaching out to several VFW chapters who have sold their respective chapters to see how those transactions took place. Mr. Rizzo said he thought that was a good idea, but is not certain if that was ever done or not as he received no other communication in this regard. Mr. Rizzo said he asked both attorneys if a Title Company is involved and if Title is cleared in order for the transaction to take place. Title Companies specialize in this work and as such Mr. Rizzo asked to see what the Title Companies position is in this regard and see how we can best deal with this statutory issue. Mr. Rizzo said he asked twice, and to his knowledge it was not done, as he was never told whether it was or A0823877

was not done. Mr. Rizzo said he reached a point where he made the suggestion of filing a Declaratory Action to solve this question. This way whatever agreement we reach would be signed off by a Judge that way there would be no question on the legality of the transaction and it would be resolved. After nearly ten months of no communication whatsoever, Mr. Rizzo said he doesn't know what else he could do accept to file a Declaratory Action in court. Any and all attempts he has made on behalf of the Governing Body have been ignored. Mr. Rizzo said he is sorry it has come to this point but frankly it is not his fault or the fault of the Governing Body. He has repeatedly reached out to the other party's attorney for input, assistance, in attempts to find a solution to this problem for months. But has received absolutely no response. To further summarize, Mr. Rizzo and the Mayor and Borough Council put emphasis on the fact that they all are united in wishing to support the VFW and their desire to relocate to a more conducive location for the good work that they do. The Governing Body in no way is trying to stop the sale of this parcel, profit from any proceeds etc., but in fact merely desire to assure that any action the Borough has is fully compliant with any and all applicable laws. Mayor Anesh further reiterated that the Governing Body is unified on this matter. Mayor Anesh said that in years past the Governing Body was burned with bad legal advice that ultimately cost the town hundreds of thousands of dollars (Suburban Bus Company). The Governing Bodies interest is to simply not let something like that reoccur. We have a willing attorney who is putting our best interests forward and seeking to do this the right and legal way. Furthermore, Mayor Anesh said he wishes to clarify a false rumor that was going around accusing the Borough Council of putting the profits from the sale of the VFW into the municipal budget. Mayor Anesh said this is a complete false statement and in no way shape or form is that happening or going to happen. Mayor Anesh said the Governing Body wishes to see the proceeds go toward the VFW. The Borough is not looking to take the VFW money nor to have the land revert back to the Borough as the Borough has no use for it. Mayor Anesh said on behalf of the Governing Body said he welcomes to meet with any representatives of the VFW to resolve this issue once and for all in which all laws are satisfied. Mayor Anesh said this probably could have been resolved months ago had Mr. Lanza reached out and commutated with Mr. Rizzo. Instead we have met with resistance.

Councilman Diana said that he has giving this situation considerable thought and research and has reached the same conclusion that our Borough Attorney has. Councilman Diana said he cannot in good conscience have himself or the Governing Body do something that runs afoul of the law. We are all committed to doing the legally compliant thing. Mr. Rizzo's opinion of what we should or shouldn't do morally is of no consequence, but his legal opinion is. He has tried to reach a solution, but we have not come to it yet. Councilman Diana said he would like to emphasize Mr. Rizzo's May 2014 where it states that the Governing Body is more than willing to work with the VFW to resolve this issue but is confined to Mr. Rizzo's legal opinion. That is the sum total to this. We are constrained to a legal opinion. Imagine our frustration to date where we have not received any communication back in order to resolve this issue. We will come to a solution. We will get there. We are not going to put the proceeds of this sale in any budget. The town is not going to take this land and use it for some other purpose. We will do this for the VFW, we just need to find the right way of doing it that does not put us all in a compromised position. Everyone extended a round of applause.

At this time Mayor Anesh opened the floor for comments from the public. Realtor for the sale of the VFW building, Mr. Moretti spoke first, followed by 11 members of this VFW Chapter who all spoke out citing all the various excellent services their VFW provides. The VFW attorney, Tom Lanza was not present. Many members enlightened the Governing Body on the history of the incorporation of their facility as they remember it. Most members expressed their appreciation to the Mayor and Council for clarifying their position and said they are happy to open a dialog. Because several Veterans were questioning the deed and the riveter language contained within, Mr. Rizzo did have to interject on several occasions clarifying that the deed is not the issue, the statute is.

To conclude, Mayor Anesh said that we will be in touch with the VFW representative(s) and hope to open the communication so that we can best resolve this issue. With no further comments from the public, Mayor Anesh closed the floor.

At this time, 8:20 p.m., Mayor Anesh called for a brief recess. At 8:30 p.m., Mayor Anesh called the meeting back to order. A0823877 **Proclamation(s)**: Read Across America – was read by Mayor Anesh in full. Mayor Anesh presented this Proclamation to the Library Board President Darlene Cullen, and Library Board Trustee Robert Bengivenga Sr., and Debbie Boyle who represents the Board of Education. Everyone extended a round of applause and photographs were taken.

ORDINANCE NO. 2016 AN ORDINANCE AMENDING THE BOROUGH CODE REVISING PARKING AND TRAFFIC ORDINANCES

WHEREAS, the Borough Police Department has recommended that Parking and Traffic Ordinances be reviewed and revised; and

WHEREAS, the Traffic Safety Advisory Commission has reviewed the recommendation and concurs in same;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Parking and Traffic Ordinances of the Borough of South Plainfield shall be amended prohibiting parking on the following designated streets:

- 1. Cady Lane Both sides the entire length of Cady Lane.
- 2. Avon Avenue Both sides between West Crescent Avenue and Cady Lane.

BE IT FURTHER ORDAINED that the Parking Ordinances of the Borough of South Plainfield shall be amended to provide that there shall be no parking, stopping or standing at any time on the following designated streets:

1. Jackson Avenue – West side from Evona Place to Garibaldi Avenue.

BE IT FURTHER ORDAINED that the Parking Ordinances of the Borough of South Plainfield shall be amended to provide that there shall be no parking, stopping or standing on one side of the following designated streets when school is in session between the hours of 7:00 a.m. to 9:00 a.m. and 2:00 p.m. to 4:00 p.m. During such time, parking, standing or stopping shall not be permitted as follows:

- 1. Stratford Avenue West side from Cedar Brook Avenue to Cromwell Place.
- 2. Wickford Road East side from Skene Drive to Cromwell Place.

BE IT FURTHER ORDAINED that the Traffic Regulations of the Borough of South Plainfield shall be amended to provide the following streets shall be designated as one-way traffic:

1. Jackson Avenue – Hamilton Boulevard to Garibaldi Avenue, traffic permitted to travel in a southerly direction.

2. Garibaldi Avenue – Jackson Avenue to Harvard Avenue, traffic permitted to travel in an easterly direction.

BE IT FURTHER ORDAINED that the Traffic Regulations of the Borough of South Plainfield shall be amended to provide that left turns shall be prohibited from the parking lot of premises located at 2300 Park Avenue onto Maple Avenue.

This Ordinance shall supersede and take precedence over Borough Ordinances 758, 1182 and 1201 in their entirety, which are hereby voided. This Ordinance shall also supersede and take precedence over that portion of Borough Ordinance 1992 which allowed parking on Garibaldi Avenue.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

ORDINANCE NO. 2017 AN ORDINANCE VACATING THE BOROUGH'S AUTHORITY AND CONTROL OVER CARNEGIE STREET, A PAPER STREET, WITHIN THE BOROUGH OF SOUTH PLAINFIELD

WHEREAS, there exists within the Borough of South Plainfield, County of Middlesex, State of New Jersey a "paper street" known as Carnegie Street, as shown on the Official Tax Map of the Borough of South Plainfield;

WHEREAS, a request has been made for the Borough to vacate its authority and control over Carnegie Street; and

WHEREAS, the Borough Council has determined that such right-of-way is no longer needed for public use; and

WHEREAS, the Borough does not have any intention to construct a road to be known as Carnegie Street; and

WHEREAS, N.J.S.A. 40:67-19 authorizes the Borough to release and extinguish public rights, and the rights of the Borough, arising from the dedication of a road;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey as follows:

1. The rights of the public and the Borough of South Plainfield in and to Carnegie Street are hereby extinguished and vacated;

2. At least one week prior to the time affixed for consideration of this Ordinance for final passage, a copy thereof, together with a notice of introduction thereof, at a time and place when and where the Ordinance will be further considered for final passage, should be mailed to every person whose land may be effected by this Ordinance insofar as it may be ascertained. Said notices shall be made by the Borough Clerk to the owners of Block 299, Lot 1.01 and Block 300, Lot 1.01;

3. The Borough Clerk shall, within 60 days of the effective date of this Ordinance, file copies of this Ordinance certified by her under the seal of the Borough to be a true copy thereof, together with proof of publication thereof in the office of the Clerk of the County of Middlesex in accordance with the provisions of N.J.S.A. 40:67-21;

4. The Mayor and Council declare this right-of-way to be surplus and not needed for public use;

5. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not effect the remaining portions of this Ordinance, and it shall remain in full force and effect; and

6. In the event of any inconsistencies between the provisions of this Ordinance and any other Ordinance of the Borough of South Plainfield, the provisions herein shall be determined to govern. All other parts, portions and provisions of the revised General Ordinances of the Borough of South Plainfield are hereby ratified and confirmed, except where consistent with the terms hereof.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

COUNCIL REPORTS:

Borough Attorney Rizzo, Esq. - had no report for this evening.

<u>Administrator Cullen</u> – gave a brief update on the status of our road salt for the season saying that we will be tapping into our snow trust for the excessive storms we have had.

<u>Engineer Miller</u> – briefed the Council on the forthcoming 2015 Road Improvement Program saying that his office is in the process of gearing up to go out to bid in the coming days.

<u>Clerk Antonides</u> –reported that the 2015 Annual Financial Disclosure Statements will be due on April 30th this year and that the filing procedure will be the same as last year. Ms. Antonides advised that instructions for filing will be distributed in the coming days.

Councilman Diana – reported progress.

Councilman Rusnak - reported progress.

Councilman Bengivenga - reported progress.

<u>Councilman Richkus</u> - thanked Councilman Diana for his earlier statements and the Veterans for their good service. Councilman Richkus went on to express his excitement for the forthcoming community pool refurbishment.

<u>Councilman Barletta</u> – also expressed his appreciation to Councilman Diana for his eloquent words pertaining to the VFW facility. Councilman Barletta than expressed his appreciation to the DPW for all their effort in keeping up with the recent snow storms we have had.

<u>Mayor Anesh</u> – advised the he recently taped two Comcast interviews; one pertaining to the new Library and the other pertaining to the forthcoming Health Fair. These two interviews are an excellent way to showcase our town.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Ms. Suzanne Lepore spoke of forthcoming Cultural Arts Commission events and expressed enthusiasm toward the Shakespeare Theatre coming to South Plainfield.

Mr. Timothy McConville asked the Council to please consider paving Murray Avenue if there is any money left over in the 2015 Road Improvement Program.

Mr. Jeff Seider of O'Donohue Avenue said this O'Donohue Avenue is also in need of repair. Mr. Seider went on to inquire if there is such a thing as a road warranty. Borough Engineer Miller advised that we have a two year maintenance bond in place for all road projects. Prior to release of said bond his firm does an inspection and deems the job to be closed or requests for repairs if needed. Mr. Seider mentioned the cracking of road surfaces and handicap ramps within two months of a road refurbishment project. Borough Engineer Miller explained the logistics of surface cracking and went on to mention that sometime garbage trucks and the like may take a corner too sharp in which the weight of their vehicles could possible cause cracking of a new handicap ramp. Mr. Miller did express his concern in that he has not heard of any such complaints within a two month time period from when a refurbishment project took place. To conclude, Mr. Seider asked if a sealer could be put on these cracks. Mayor Anesh said he can ask Cappi if that's possible.

Ms. Libby Barski inquired about the posting of new parking signs pursuant to this evening's ordinance that was adopted. Councilman Bengivenga said that signage will be going up in the coming days.

Mrs. Darlene Cullen of 1457 Fox Place reminded everyone that that the Library Board of Trustees hold their meetings the second Tuesday of each month at 7:00 p.m. Mrs. Cullen said that unfortunately no one comes to these meetings yet she was disenchanted to see a recent letter to the editor in the Observer criticizing some components of the catch basin and flag pole in front of the Borough Hall. Mrs. Cullen asked Engineer Miller to summarize the plans for retention basin of which Mr. Miller did with emphasis on design features and storm water management considerations. Mrs. Cullen concluded by reminding everyone that the construction plans for the Library renovations are posted in full at the Library and everyone is welcome to come and view them.

Mr. Jeff Seider inquired if consideration can be made for a serious of homes that do not have sidewalks in front of them on or about Rahway Avenue vicinity.
