WHEREAS, the bids have been reviewed by the Borough Engineer and the Borough Attorney who have verified that the lowest qualified bidder is US Municipal Supply Inc. in the amount of \$269,610.00 and that the bid be accepted and a contract, if applicable, be awarded for the purchase of a street sweeper; and

WHEREAS, funds for said purpose have been certified by the Chief Financial Officer and are available through the general fund budget;
