ORDINANCE NO. 2039 AN ORDINANCE AMENDING SECTION 181 OF THE CODE OF THE BOROUGH OF SOUTH PLAINFIELD TITLED "CHARITABLE CLOTHING BINS".

WHEREAS, charitable clothing bins are permitted within the Borough subject to requirements set forth in Chapter 181 of the Borough Code; and

WHEREAS, Chapter 181 of the Borough Code was amended by Ordinance 2038 which, in part, limited the amount of bins any one applicant could place on an approved lot; and

WHEREAS, said provision would negatively impact the recycling program of the Borough with regard to clothing boxes located at the Borough Recycling Center;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 181, titled "Charitable Clothing Bins" shall be amended as follows:

1. Add to Section 181-2(A)(7) the following: This provision and limitation shall not apply to any applicant placing clothing bins at the Borough Recycling Center pursuant to an agreement with the Borough.

ORDINANCE NO.2040 AN ORDINANCE AMENDING ORDINANCE 1366 REGULATING <u>PARKING OF RECREATIONAL VEHICLES.</u>

WHEREAS, the Borough Police Department has recommended that Ordinance 1366 regulating parking of recreational vehicles be revised; and

WHEREAS, the Traffic Safety Advisory Committee has reviewed the recommendation and concurs with same;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Ordinance 1366 regulating parking of recreational vehicles shall be amended as follows:

DELETE, SECTION 1(B). DEFINITION OF TRAILER, and

ADD: TRAILER – a vehicle without motive power designed for carrying persons or property on its own, and to be drawn by a vehicle with motive power. The term "trailer" shall include, but shall not be limited to horse trailers, boat trailers, skimobile trailers, landscape trailers, construction trailers and car trailers.

DELETE existing SECTION 2, replace with the following:

SECTION 2. PARKING PROHIBITED.

A. No person, firm or corporation shall park a recreational vehicle upon any road, street or highway within the Borough of South Plainfield;

B. No person, firm or corporation shall park a trailer, attached or unattached to a motor vehicle, upon any road, street or highway within the Borough of South Plainfield, except if said trailer is making deliveries or belongs to a contractor who is employed and doing work at the subject residence;

C. No person, firm or corporation shall park a trailer, attached or unattached to a motor vehicle, upon any road, street or highway overnight within the Borough of South Plainfield.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.
