ORDINANCE NO. 2042 AN ORDINANCE CREATING A "PUBLIC CELEBRATIONS COMMITTEE".

WHEREAS, the Public Celebrations committee has existed within the Borough; and

WHEREAS, it does not appear that the Public Celebrations Committee was created pursuant to ordinance, and the Governing Body of the Borough of South Plainfield wishes to establish the Public Celebrations Committee in accordance with the laws of the State of New Jersey;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Code of the Borough, Chapter 17, Titled "Boards, Committees and Commissions" shall be amended to add Article VI to be titled "Public Celebrations Committee", and to include the following sections:

17-36. ESTABLISHMENT, MEMBERSHIP AND TERMS; COMPENSATION:

- a. The Public Celebrations Committee shall consist of 11 members. Each member shall be appointed by the Mayor with the advice and consent of the Borough Council.
- b. Each member shall be appointed for a three-year term with the exception of appointments to be made effective January 1, 2016. There are presently five terms which shall expire as of December 31, 2015. At the discretion of the Mayor, with the advice and consent of the Borough Council, appointments to three of such positions shall be for three-year terms; one such position shall be for a one-year term; and one such position shall be for a two-year term.
 - c. All members of the Public Celebrations Committee shall serve without compensation.

17-37. QUALIFICATIONS FOR MEMBERSHIP:

Qualifications for membership are as follows:

a. A resident of the Borough of South Plainfield.

- b. Over the age of 18.
- c. No member of the governing body of the Borough of South Plainfield may be a voting member.

17-38. MEETINGS; CHAIRPERSON:

The Public Celebrations Committee shall meet regularly, and shall, at its first meeting of each year, elect from its number a chairperson who shall preside over all meetings.

17-39. RULES AND BY-LAWS:

The conduct of the Public Celebrations Committee at its meetings and activities shall be governed by rules and by-laws which shall be established by the Committee.

17-40. POWERS AND DUTIES:

The Public Celebrations Committee shall be responsible for the planning, organization and execution of events, activities, parades and the like designed help the Borough celebrate any holiday, event, or occurrence, which is determined worthy or desirable to be honored and celebrated. They may utilize individuals or organize support groups of volunteers with the authorization and consent of the Governing Body to assist in the duties. They shall lend their advice to the Governing Body on all matters within their jurisdiction.

17-41.

The Public Celebrations Committee shall report to the Recreation Committee of the Borough Council. Any funds appropriated for the Public Celebrations Committee by the Governing Body shall be disbursed by the Office of the Borough Administrator. Any payment on account of expenses or claims must be supported by vouchers.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

Only one person may be appointed and hold such titles. This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

SECTION 17-24(C) shall be amended by adding the following at the end of said provision:

The President of the South Plainfield Business Association shall be a voting member.
