COUNCIL REPORTS:

Borough Attorney Rizzo Esq. - was absent this evening. Mr. Bill Robertson reported progress.

Administrator Cullen – congratulated all the DPW appointments this evening saying they will be an excellent addition to our DPW. This past weekend we held the 90th Anniversary of the Borough which was a great event and excellent to see all the former Mayors present and speaking about past times in our Borough. Everyone present really seemed to enjoy the event. The 2016 Budget Introduction is being anticipated for April and based upon how it's shaping up so far, there are no surprises to be had. On another note, last week the high school had a major electrical issue in which Chief Parker and himself went to meet with the School Superintendent. The discussion entailed seeking a possible commercial location to fit all the students on a temporary basis. The discussion lead to Mr. Cullen contacting local realtor, Jack Morris, who very graciously donated a substantial commercial generator to keep the students at the high school until the repairs are all done. Mr. Cullen thanked Mr. Morris for his generosity in this regard.

<u>Engineer Miller</u> – thanked the Mayor and Council for their support with the new hires this evening stating that they will be a very good edition to the DPW. Mr. Miller also reported that the Tandum Truck was delivered but will be in the shop to be decaled accordingly before being put out on the road.

<u>Clerk Antonides</u> – announced that the annual financial disclosure statements will be forthcoming. They are due to be filed by April 30th and the procedure is the same as last year for filing.

<u>Councilman Wolak</u> – reported that the Easter Egg Hunt was a great success and well attended and went on to also say that the Cultural Arts Showcase was amazing and full of excellent local talent. To conclude Councilman Wolak advised that the St. Patty's Day Party will be held at the Senior Center tomorrow at 11:30-2:30.

<u>Councilman Richkus</u> - advised that April 16th marks the town-wide clean-up day beginning at Borough Hall. The Rescue Squad will hold their comedy show on April 10th in New Brunswick. On another note, sign removal from telephone poles is in full force. Some 60 signs have been removed. If anyone is interested in adopt-a-spot please see the Borough website for more information.

Councilman Barletta – also congratulated the DPW members appointed this evening and look forward to them serving this Borough for a long time. On another note, Councilman Barletta said that he and Mr. Miller, Mr. Cullen, Mayor Anesh met with the Administrator of the County, the County Engineer and a County special roads project person to discuss the situation with Quiet Zones. The meeting couldn't have gone any better. We left there with a very positive outlook on all three crossings. Prior to this meeting Councilman Barletta said he saw darkness, after this meeting he saw some light. We still have a very long way to go. It was a very productive meeting. COMMENTS FROM THE PUBLIC:
