BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD. IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$56,000 of the proceeds of obligations originally made available pursuant to the following bond ordinances of the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") are no longer necessary for the various purposes for which the

To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

ORDINANCE 2059

ORDINANCE OF THE BOROUGH OF SOUTH PLAINFIELD ESTABLISHING CHAPTER 70 "THIRD PARTY PAYROLL DISBURSEMENT" was read by title by Clerk Antonides by title on second reading. Mayor Anesh opened the floor for public hearing. With no comments made, closed the floor. Mayor Anesh asked the Council if they had any comments, but no comments were made.

WHEREAS, the Local Finance Board of the State of New Jersey adopted formal rules regarding "Electronic Disbursement Controls for Payroll Purposes" in order to provide formal authority for local governments to hire third party payroll services/disbursing services to disburse funds to payroll agencies; and

WHEREAS, in order to have a payroll service provide disbursement services, the Borough Council of the Borough of South Plainfield must formally approve the principle of a third party having access to Borough funds, formally assigning responsibility to an official to oversee the process by enacting an ordinance, and approving all contracts or extensions.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of South Plainfield, County of Middlesex, and State of New Jersey that Chapter 70 entitled "Third Party Payroll Disbursement" is hereby established in the Borough Code:

CHAPTER 70 "THIRD PARTY PAYROLL DISBURSEMENT"

§70-1. PURPOSES; DEFINITIONS.

A. The purpose and intent of these regulations is to abide by the requirements of N.J.S.A. 52:27D-20.1 and N.J.A.C. 5:30-17.1 et seq., governing electronic disbursement controls for payroll purposes.

B. Definitions. As used in this chapter, the following terms shall have the meanings indicated: "Approval Officer" Person(s) responsible for authorizing and supervising the activities of the payroll service.

Third party payroll service organization – Borough of South Plainfield

§70-2. AUTHORIZATION.

- A. The Borough is authorized to use a payroll service to prepare payment documentation, take possession of Borough funds, and make such disbursements itself on behalf of the Borough.
- B. The following payroll service providers shall be required to comply with these regulations:
 - (1) Payroll service providers who use their own customized programming process to execute disbursements for the Borough.
 - (2) Payroll service providers who use a third party processor to execute disbursements for the Borough.

§70-3. BOROUGH REQUIREMENTS.

- A. The appointment of a payroll service shall be pursuant to the Local Public Contracts Law, see N.J.S.A. 40A:11-1 et seq. and shall require the contractor to do the following, not by way of limitation: data collection, agency report preparation, calculation of withholding, direct deposit of payroll disbursements, and/or transfer of Borough funds to contractor's account for subsequent disbursement of payment.
- B. Any renewal or extension of a contract under these regulations shall be by resolution.
- C. The Chief Financial Officer is hereby appointed the approval officer and is responsible for authorizing and supervising the activities of the payroll service and shall further be charged with the reconciliation and analysis of all general ledger accounts affected by the activities of the disbursing organization. ']
- D. If required by the contract between the Borough and the payroll service, the payroll service is permitted to hold Borough funds pending transmittal to a payee.

§70-4. PAYROLL SERVICE REQUIREMENTS.

- A. A payroll service must meet all of the following requirements:
 - (1) Report any irregularities that may indicate potential fraud, noncompliance with appropriate laws, dishonesty or gross incompetence on the part of the approval officer;
 - (2) Report circumstances that could jeopardize its ability to continue operations or otherwise interrupt the services provided to the Borough.
- B. A payroll service must meet the requirements of N.J.A.C. 5:30-17.5. requiring that the approval officer be assured that the servicer has tis own internal controls and appropriately guard against theft and other adverse conditions.
- C. All contracts entered into pursuant to these regulations and the laws authorizing the same shall comply with the requirements of N.J.A.C. 5:30-17.6, which sets out a seres of mandatory contractual terms and conditions.

§70-5 ESTABLISHMENT OF SERVICE.

Upon the adoption of these regulation, the Borough Manager, with the assistance of the Chief Financial Officer and Borough Attorney, as necessary, is hereby authorized and directed to enter into a contract for payroll services in accordance with all local public contracting laws and N.J.A.C. 5:30-17. Appointment of the payroll service shall be by separate resolution of the Borough.

BE IT ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication in accordance with applicable law.

RESOLUTION AUTHORIZING SETTLEMENT OF 2011, 2012, 2013, 2014 and 2015 TAX APPEALS FILED BY ALFIERI BY NBTY AND ALFIERI-600 HADLEY ROAD ASSOCIATES, FOR THE PROPERTY KNOWN AS 600 HADLEY ROAD AND IDENTIFIED AS BLOCK 528.01, LOT 45.06, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

WHEREAS, Alfieri By NBTY and Alfieri-600 Hadley Road Associates (hereinafter referred to as "Taxpayer") are the tenant-taxpayer and owner of the property known as 600 Hadley Road and identified as Block 528.01, Lot 45.06, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$829,000 for all years under appeal; and

WHEREAS, Taxpayer filed appeals of the 2011, 2012, 2013, 2014 and 2015 tax assessments in the Tax Court of the State of New Jersey under docket numbers 011748-2011, 011504-2012, 011861-2013, 013475-2014 and 009945-2015; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for all years under appeal; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2011 original assessment in the amount of \$829,000 shall be reduced to \$744,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2011;
- The 2012 original assessment in the amount of \$829,000 shall be affirmed and remain unchanged;
- The 2013 original assessment in the amount of \$829,000 shall be affirmed and remain unchanged;
- The 2014 original assessment in the amount of \$829,000 shall be reduced to \$744,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2014;
- The 2015 original assessment in the amount of \$829,000 shall be affirmed and remain unchanged;
- Taxpayer has agreed to waive statutory interest provided the subject refunds are paid within sixty (60) days from the date of the entry of Judgment;
- Refunds regarding over payments shall be made payable to "Alfieri by NBTY, Alfieri-600 Hadley Road Associates and Zipp, Tannenbaum & Caccavelli, LLC, as attorneys", and forwarded to Paul Tannenbaum, Esq., Zipp, Tannenbaum & Caccavelli, LLC, 280 Raritan Center Parkway, Edison, NJ 08837 within 60 days from the date of the entry of Judgment; and
- The taxpayer has agreed that the provisions of N.J.S.A. 54:51A-8 (Freeze Act) are waived and shall not be applicable to this case.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

WHEREAS, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reductions to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 1. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$744,000 total tax assessment for the 2011 tax year for Block 528.01, Lot 45.06 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 2. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$744,000 total tax assessment for the 2014 tax year for Block 528.01, Lot 45.06 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 3. The Borough Attorney is authorized to execute on behalf of the Borough of South Plainfield the attached Stipulation of Settlement pertaining to the tax appeals filed by Alfieri by NBTY, Tenant-Taxpayer and

Alfieri – 600 Hadley Road Associates under Docket Nos.: 011748-2011, 011504-2012, 011861-2013, 013475-2014 and 009945-2015, for the property known as 600 Hadley Road and identified as Block 528.01, Lot 45.06, on the Borough of South Plainfield Tax Assessment Maps which reduces the 2011 total tax assessment on the Property from \$829,000 to \$744,000; which affirms the 2012 and 2013 total tax assessments on the Property at \$829,000; which reduces the 2014 total tax assessment on the Property from \$829,000 to \$744,000; which affirms the 2015 total tax assessment on the Property at \$829,000; which further provides that Taxpayer agrees to waive statutory interest on any refund or overpayment due provided the refund check is paid within sixty (60) days from the issuance of Judgment; which further provides that any refunds shall be made payable to "Alfieri by NBTY, Alfieri-600 Hadley Road Associates and Zipp, Tannenbaum & Caccavelli, LLC, as attorneys," and forwarded to Paul Tannenbaum, Esq., Zipp, Tannenbaum & Caccavelli, LLC, 280 Raritan Center Parkway, Edison, NJ 08837 within 60 days from the date of the entry of Judgment; and which provides that taxpayer has agreed to waive the provisions of N.J.S.A. 54:51A-8 (Freeze Act).

RESOLUTION 2016-209 AUTHORIZING THIRD PARTY PAYROLL DISBURSEMENTS AND APPOINTING A PAYROLL APPROVAL OFFICER

WHEREAS, N.J.A.C. 5:30-1, ENTITLED "Electronic Disbursement Controls for Payroll Purposes," sets forth standards for local governments to follow when contracting with an organization to make disbursements on behalf of the local unit, as permitted by N.J.S.A. 52:27D-20.1; and

WHEREAS, the Borough Council of the Borough of South Plainfield must formally approve a payroll service provider access to Borough funds, assign responsibility to an official to oversee the process, and enact policies regulating payroll disbursements by payroll service providers;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, State of New Jersey as follows:

- 1. ADP, Inc. is authorized to prepare any necessary payment documentation and make payroll and payroll agency disbursements on behalf of the Borough by executing such disbursements from the Borough's designated bank accounts, or by taking possession of Borough funds to make such disbursements and to hold those funds pending transmittal.
- 2. ADP, Inc. shall use its own customized programming process to execute disbursements for the Borough.
- 3.
