WHEREAS, Woodland Avenue straddles the boundary between the Borough of South Plainfield and the Township of Edison, and currently the northbound side in the Township of Edison is regulated with a speed limit of 25 mph, and the southbound side of Woodland Avenue in the Borough of South Plainfield is regulated by a speed limit of 35 mph; and

WHEREAS, it has been determined by the Traffic Safety Division of the South Plainfield Police Department that the speed limit should be consistent on said road, and a reduction from 35 mph to 25 mph is appropriate;

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Traffic Safety Division of the South Plainfield Police Department is hereby authorized to reduce the speed limit on Woodland Avenue on the southbound side to 25 mph from 35 mph to coincide with the speed limit on the northbound side of Woodland Avenue in the jurisdiction of the Township of Edison, County Middlesex, State of New Jersey; and

ORDINANCE NO. 16-2062 AN ORDINANCE ESTABLISHING PAVEMENT RESTORATION REQUIREMENTS FOR STREET EXCAVATIONS.

WHEREAS, the Governing Body of the Borough of South Plainfield is charged with establishing and maintaining safe passage and safe conditions on streets within the Borough; and

WHEREAS, a great deal of extensive utility work has been undertaken throughout the Borough which has left streets with only partial trench repairs or, at best, half-width repaying; and

WHEREAS, this situation has left numerous streets in an unsightly and unsafe condition;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 409, Streets and Sidewalks, Article III, Excavations and Streets, be amended as follows:

ADD: Chapter 409, Section 29.1, Restoration of Surfaces.

The permittee shall restore the surface of all streets, broken into or damaged as a result of excavation of work, to its original condition in accordance with the specifications of the Department of Public Works.

In the case of utility work undertaken by a public or private utility, which work involves placing new or replacing, or repairing of existing utility infrastructure, such as gas lines, water lines, electrical lines, and sewer lines, where the area to be trenched is greater than 50 linear feet, upon completion or within a reasonable amount of time as determined by the Borough Engineer, the permittee shall mill and repave the entire pavement surface from edge to edge, or curb to curb for the full length of the excavation in accordance with the specifications of the Department of Public Works.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for all years under appeal; and

WHEREAS, pursuant to the proposed Stipulations of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2012 original assessment in the amount of \$1,123,700 shall be reduced to \$869,900 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2012;
- The 2013 original assessment in the amount of \$1,123,700 shall be reduced to \$931,700 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2013;
- The 2014, 2015 and 2016 original assessments in the amount of \$1,123,700 shall be affirmed and remain unchanged;
- Taxpayer has agreed to waive statutory interest provided the subject refunds are paid within one hundred twenty (120) days from the date of the entry of Judgment;
- Refunds regarding over payments shall be made payable to "G&W Laboratories, Inc. and McCarter & English, LLP, as attorneys", and forwarded to Frank E. Ferruggia, Esq., McCarter & English, LLP, Four Gateway Center, 100 Mulberry Street, Newark, New Jersey 07102 within one hundred twenty (120) days from the date of the entry of Judgment;
- The parties have agreed that the provisions of N.J.S.A. 54:51A-8 (Freeze Act) shall not be applicable to this case; and
- As a result of the settlement, any and all Counterclaims shall be withdrawn.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, pursuant to the proposed Stipulations of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:
