RESOLUTION 2016-297 ADOPTING THE RECOMMENDATION OF THE PLANNING BOARD OF THE BOROUGH OF SOUTH PLAINFIELD TO REMOVE THE DEED RESTRICTION WHICH PROHIBITS THE ERECTION OF STRUCTURES ON LOT 3, BLOCK 318.

WHEREAS, Daniel Chin residing at 408 Hamilton Boulevard in the Borough of South Plainfield requested that the Borough Council remove a deed restriction affecting property which he owns and is located at 303 New Market Avenue, also known as Lot 2, Block 519; and

WHEREAS, the subject property had previously consisted of multiple lots, what had been known as Lots 20-23, Block 519 (subsequently known as Lot 2, Block 318), having been acquired by predecessors in title, David and Amelia Dorosh from the Borough of South Plainfield in 1947, and what had been known as Lot 3, Block 318 having been acquired by David Dorosh from the Borough of South Plainfield by Deed dated December 26, 1972; and

WHEREAS, at the time Mr. Dorosh acquired Lot, 3, Block 318 in 1972, it was sold with a restriction which prohibited the erection of any structures on said lot; and

WHEREAS, Mr. Chin purchased the property in or around 2014 with the intent to subdivide the property, being aware of the deed restriction at the time of purchase; and

WHEREAS, on September 25, 2015, the Borough Council referred the matter to the Planning Board for investigation and recommendation; and

WHEREAS, the Board received advice from the Board Planner and Board Engineer concerning the request; and

WHEREAS, the Board was not able to determine or locate any information regarding why the deed restriction was included in the Deed of 1972, and no further information has been obtained concerning same; and

WHEREAS, the Board advised Mr. Chin that it believed any proposed subdivision would create non-conforming lots and that he would, therefore, have a heavy burden to be granted variances for lot area and lot width if he proceeds with an application for subdivision; and

WHEREAS, notwithstanding its opinion concerning subdivision, the Board found no reason to continue the restriction against the erection of a structure upon the property; and

WHEREAS, on February 23, 2016, the Planning Board recommended to the Borough Council that it positively consider Mr. Chin's request for a removal of the restriction with the added advice that it was not in any way endorsing a subdivision of the property; that its vote does not grant any such relief to Mr. Chin or remove any obligations to fully comply with the Municipal Land Use Law and ordinances of the Borough of South Plainfield; and that if the Council determines to remove the deed restriction and does not further restrict subdivision, Mr. Chin

would still be required to file an application for minor subdivision and lot area/width variances, and meet the heavy burden of obtaining such relief;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that it hereby adopts the recommendation of the Planning Board of the Borough of South Plainfield to remove the restriction which prohibits the erection of structures on Lot 3, Block 318, with the understanding and direction that this Resolution is not an endorsement of subdivision of the property, and that Mr. Chin or any subsequent owner would be required to comply with Municipal Land Use Law and the ordinances of the Borough of South Plainfield, and file an application for minor subdivision and any required variances to the Borough Planning Board if so desired.

Borough Attorney Robertson Esq. - reported progress

Administrator Cullen - was absent this evening

<u>Engineer Miller</u> – advised that he received a letter from the County Engineer addressed to Todd Hirt from the DOT requesting to set-up a diagnostic team meeting between South Plainfield and Piscataway to discuss quiet zones.

<u>Clerk Antonides</u> – reported progress.

<u>Councilman Wolak</u> – reported progress.

<u>Councilman White</u> – briefly advised that a new plumbing group will be coming to South Plainfield shortly and went on to report progress.

<u>Councilman Rusnak</u> – reported progress.

<u>Councilman Richkus</u> - explained that he voted no this evening on resolution 2016-297 because he feels we are way too overdeveloped as it is and can't see lifting a deed restriction that prevents subdivision.

Councilman Barletta – congratulated Council President Bengivenga and Pricilla for their recent engagement and then went on to say that this evening will be his last council meeting as he will be resigning. Councilman Barletta explained that it has been a long time plan for he and his family to move to Lavallette. It is bitter sweet as South Plainfield has been his home for some 49 years. Councilman Barletta thanked Amy Antonides, Glenn Cullen, Len Miller, Paul Rizzo, and Chief Parker for all they do for the Borough. Councilman Barletta told Mayor Anesh and the Borough Council that it has been both an honor and a privilege to serve with you for the past six years. Though Councilman Barletta said he will miss South Plainfield very much, he will be back from time to time to say hello. Councilman Rusnak said it has been an absolute pleasure serving with Councilman Barletta for the past six years. Mayor Anesh said that though Councilman Barletta refers to himself as "angry Barletta" he doesn't believe Councilman Barletta is angry, but just passionate. Councilman White said he saw Councilman Barlettas passion and dedication. Councilman Wolak thanked Councilman Barletta learning a lot from him and it seems like the end of an era.

<u>Council President Bengivenga</u> – Council President Bengivenga commented saying that he has had Councilman Barletta as a running mate some ten years ago. He will be sorely missed.

<u>Mayor Anesh</u> – announced that October 15th will be the library dedication to Willow Park at 9:00 a.m. It will also be the open house for the Fire Department and the Fall Health Fair at the Senior Center. A lot will be going on that day.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Suzanne Lepore, Bullard Place, announced that the Cultural Arts Commission will have line dancing at the Senior Center on October 22nd, and there will be a book presentation at 2 p.m. on October 30th at the Library. The Halloween window decorating contest will also be taking place with painting beginning on October 23rd.

A resident from St. James Place thanked the Council for recognizing UNICO this evening and advised them that soon it will be their 50th anniversary as they have been in South Plainfield for 46 years now. He went on to inquire how much quiet zones will cost. Mayor Anesh said that though the true cost is still highly uncertain, it appears at a minimum it will cost some \$3 million.

April Bengivenga, Woodland Avenue, thanked Councilman Barletta for his years of service on Council and said that Lavallette is going to have a wonderful citizen.

Debbie Boyle of Van Fleet reported on various events and dates throughout the town in the coming days.

Chief James Parker thanked Councilman Barletta for his time served on Council in South Plainfield and wished him the best.

Mr. Jon Dean of 3321 Evergreen Lane congratulated Councilman Barletta then went on to inquire as to how to get the Building Department to accept credit cards. Mayor Anesh said we will have to look into that. Mr. Dean asked where the parcel regarding resolution #16-297 was located. Council President Bengivenga explained.

Nancy Grennier, from The Observer, asked what the status is for an October 27th Debate? Councilman Rusnak responded by saying whatever date and time she wishes, that he and his running mate, Stephanie Bartfalvi, will be there.
