BOND ORDINANCE 2072

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS FOR THE DEPARTMENT OF PUBLIC WORKS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$280,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$264,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF. BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$280,000, and further including the aggregate sum of \$16,000 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, negotiable bonds are hereby authorized to be issued in the principal amount of \$264,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 7.89 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$264,000, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$10,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements. Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount. Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

ORDINANCE NO. 2073

AN ORDINANCE AMENDING ARTICLE XIX OF THE SANITARY CODE OF THE BOROUGH OF SOUTH PLAINFIELD ENTITLED "LICENSING FEES".

WHEREAS, the Borough Council requested the Borough Health Advisory Board to review the annual licensing fee applicable to tattoo parlors as a result of a complaint received regarding same; and

WHEREAS, the Health Advisory Board met on January 24, 2017 and reviewed the annual licensing fee as requested, and made the following findings:

1. The current operators of a tattoo parlor located within the Borough who had complained regarding the fee were aware of such fee prior to the initiation of their business in the Borough in 2015;

2. The current annual license fee of \$4,000.00 has been in effect since at least 1987;

3. Neighboring Middlesex County municipalities charge varying fees ranging to \$900.00; and

WHEREAS, the Health Advisory Board discussed with the Health Inspector the nature of such businesses and of such inspections, and further reviewed the New Jersey State Sanitary Code for body art businesses; and

WHEREAS, the Health Advisory Board found that due to the nature of such businesses, inspections are involved and include review of many items, including sterilization techniques, equipment inspection, needle use and disposal, blood borne pathogen training, waste disposal, appropriate log examination, review of parental and general consent form processing, and paperwork for care instruction of new tattoos and piercings; and

WHEREAS, the Health Advisory Board noted that licensing fees must have a logical determination and relationship to the time and work involved on the part of the municipality in issuing the license and regulating the business; and

WHEREAS, due to the level of involvement, the Health Advisory Board recommends that no less than four (4) inspections be made of tattoo parlors per year, and based upon the foregoing recommended an amendment to the licensing ordinance to set the annual licensing fee at \$1,000.00; and

WHEREAS, the Mayor and Council have reviewed the findings and recommendations of the Health Advisory Board and wish to adopt same;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Article XIX of the Sanitary Code of the Borough of South Plainfield entitled "Licensing Fees" shall be and is hereby amended to set forth the annual fee for a tattoo parlor to be \$1,000.00.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

BOND ORDINANCE PROVIDING FOR RESURFACING OF VARIOUS ROADS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$1,300,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$900,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$1,300,000, including a \$375,000 grant from the State of New Jersey Department of Transportation Fiscal Year 2016 Municipal Aid Program for the improvement in Section 3(a) (the "State Grant"), and further including \$25,000 in road contributions for the improvement in Section 3(b) which is being applied as the down payment for the improvement as required by the Local Bond Law. ORDINANCE # 2075 CALENDAR YEAR 2017 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET COST OF LIVING ALLOWANCE AND TO ESTABLISH A CAP BANK WHEN THE COLA IS EQUAL TO OR LESS THAN 2.0 PERCENT PURSUANT TO N.J.S.A. 40A:4-45.14

WHEREAS, the Local Government Cap Law, N.J.S. A. 40A:4-45.1 *et seq.*, provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.0% or the Cost-of-Living Adjustment (COLA), whichever is less, over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.14 provides that a municipality may, in any year in which the COLA is equal to or less than 2.0% increase its final appropriations by a percentage greater than the COLA, but not to exceed the 3.5% rate as specified in the law, when authorized by ordinance; and,

WHEREAS, the COLA for 2017 has been certified by the Director of the Division of Local Government Services in the Department of Community Affairs as .5% and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, in any year in which the COLA is equal to or less than 2.0%, may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of South Plainfield in the County of Middlesex finds it advisable and necessary to increase its 2017 budget by more than 2.0% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$774,391.49 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2017 budget year, the final appropriations of the Borough of South Plainfield shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$774,391.49 and that the 2017 municipal budget for the Borough of South Plainfield be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

COUNCIL REPORTS:

Borough Attorney Rizzo Esq. - reported progress

<u>Administrator Cullen</u> – thanked all the department heads for getting everything in for the budget.

<u>Engineer Miller</u> – advised that no one has submitted and proposals for bulk waste so he has solicited another request in hopes of obtaining some proposals. On another note, this Thursday will be the bid opening for recycling services and if all is in good order we hope to award that bid at our next meeting.

<u>Clerk Antonides</u> – reported progress.

<u>Councilman Dean</u> – reminded everyone about the Homeowners Workshop at the Senior Center this Thursday from 6:00 p.m. to 9:00 p.m. and then went on to report progress.

<u>Councilwoman Faustini</u> – thanked the Library Board, Friends of the Library, and library staff for a very successful Read Across America event this past Saturday. Councilwoman Faustini said that though she has only attended one recreation meeting so far this year, the primary topic they discussed was a request to use the bus depot property for some overflow parking for sport games. It was initially requested to utilize the property for pony tail softball games, however due to the necessary field size needed for that purpose and due to certain wetland restrictions, it was ruled out for that use. Councilwoman Faustini met with Mr. Miller who came up with a conceptional plan for overflow parking, a dog park section as well as walking paths to the connecting sport fields. Further discussion will take place with the Recreation Committee in this regard as well as Mr. Miller. Councilman Dean inquired if special turf grass would be needed and expressed concern regarding potential flooding and lifting of any special turf material. Mr. Miller said no, the plan is to use just regular grass for this purpose.

<u>Councilman Bengivenga</u> – Councilman Bengivenga mentioned that in a past census he recalls about 1/3 of the town has dogs and likes the idea of a dog park in the bus depot area and then went on to report progress.

<u>Councilman Vesce</u> – thanked the Council for their support this evening with the Ordinance for the DPW and went on to report progress.

<u>Councilman Wolak</u> – said that a dog park at the bus depot site sounds like a good idea and went on to report progress.

<u>Council President White</u> – reported that In and Out Bagel had a soft opening but will be having their grand opening on March 11th at 10:00 a.m. and went on to report progress.

<u>Mayor Anesh</u> – Reminded everyone that the Spring Health Fair is in the works with the Step It Up Program scheduled for March 12^{th} and went on to report progress.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Suzanne Lepore of Bullard Place spoke about the spelling bee she attended this past Saturday of which two students were from South Plainfield and they did an outstanding job. It was exciting to see. The Talent Show will be this Saturday at 2:00 p.m. at Wesley Methodist Church. It should be an enjoyable event and encourage everyone to come.

Mr. Anthony Risoli of 2529 Hamilton Blvd. asked if a dog park would be paid for out of dog trust funds. Mr. Cullen said he is uncertain if he can use dog trust funds for that purpose but would look into it.

Stephani Bartfalvi reminded everyone that the Taste of South Plainfield will be next Monday, March 13th at the Senior Center.

Nancy Grennier from The Observer, advised that there is 16 restaurants so far scheduled for the Taste of South Plainfield and 20 other businesses and went on to encourage everyone to attend. On another note, Mrs. Grennier questioned the status of the lights on Hamilton Avenue. Mr. Miller said that PSE&G have been counted a couple of times about that and each time he inquiries about the status they keep saying it is on their list. Mrs. Grennier concluded by reminding everyone that the school referendum election is next Tuesday.

Mr. Mike Zushma reminded everyone that the Lions Club is having their annual gourmet breakfast on April 9th. April 8th is the Keystone luncheon. As a life member of the Rescue Squad, they had told him that they didn't get their money yet from last year. Councilman Bengivenga said they will as he just signed the voucher today. Mr. Zushman than asked if there is a list of roads to be paved. Councilman Bengivenga said it will be Lane, Manning and Ritter Avenues.

Mr. Jason Risoli of 2529 Hamilton Blvd. asked for a status update on the 100 Main Street location. Mr. Cullen explained that due to personal reasons the applicant has had to post phone his variance a few times. It is now scheduled to be heard April 18, 2017. Mr. Risoli asked if a business started up illegally why we are allowing it. Mayor Anesh explained that our Borough officials enforce the code and use discretion. Mr. Rizzo Esq. explained that Borough Officials have protection from political imposition and the Zoning Officer has discretion and her own opinion regarding the terms of operating such business's. Mayor Anesh invited Mr. Risoli to go speak to the Zoning Officer to hear from her directly. Mr. Risoli went on to mention how some buffer zones like Sports Zone look like "holocaust sites" and asked if the town has any landscape plans. Mr. Miller said they had to bank some parking for their site if deemed necessary by the Board. The Board will request them to come back in and readdress he parking if need be. On another note, some dumping of debris near Home Depot seems to be taking place. Mr. Miller said they have been required to clean up the site at least twice now, but it really is a matter of enforcement to catch them in the action so that the cement doesn't go all over our roads and clump up. Chief Parker said he will look into it.

With no further comments from the public, Mayor Anesh closed the floor.
