Clerk Antonides read the following Bond Ordinance #2076 by title on first reading. Mayor Anesh set the public hearing for May 1, 2017 at approximately 7:00 p.m. There were no comments from Council.

BOND ORDINANCE 2076

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$611,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$449,500 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$611,000, including a grant in the amount of \$137,500 from the County of Middlesex for the improvement or purpose in Section 3(a) (the "County Grant") and further including the aggregate sum of \$24,000 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments and the County Grant, negotiable bonds are hereby authorized to be issued in the principal amount of \$449,500 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum (A0950521)

amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are

as follows:

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 12.91 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$449,500, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

An aggregate amount not exceeding \$41,500 for items of expense listed in and permitted under
N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.

Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or, if other than the County Grant referred to in Section 1 hereof, to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final

adoption, as provided by the Local Bond Law.

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessment for the tax years under appeal and recommended that the settlement be approved and therefore, this

proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for the tax years under appeal; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2013 tax appeal shall be withdrawn and the 2013 total tax assessment shall remain unchanged;
- The 2014 original assessment in the amount of \$975,000 shall be reduced to \$850,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2014;
- The parties agree that the provisions of <u>N.J.S.A.</u> 54:51A-8 (Freeze Act) shall not apply to the assessment;
- Taxpayer has agreed to waive statutory interest provided the refund is paid within 60 days of the entry of Judgment. The tax refund shall be made payable to "CVS Pharmacies and Stavitsky & Associates, LLC as attorneys" and forwarded to counsel for Taxpayer within 60 days of the date of Judgment.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

Borough Attorney Rizzo Esq. - reported progress

<u>Administrator Cullen</u> – advised that the budget hearing with department heads are scheduled for April 10th and 12th. May 1st is the public hearing date for the budget. Mr. Cullen thanked everyone for this support this evening with resolution 170 which will allow Officer McNelly to place a special battle cross monument at monument park.

<u>Engineer Miller</u> – reported that the Franklin Avenue Road project is essentially finished and fell under budget. As such we have enough money left to pave Murry Avenue. Therefore we will get that extra road paved at no additional cost to the contract.

<u>Clerk Antonides</u> – reminded everyone that instructions for the filing of the annual financial disclosure statements will be forthcoming of which the deadline is set for April 30th.

Councilman Dean - advised that he Councilman Vesce, Councilwoman Faustini, Mr. Cullen and Mr. Miller all met and went around to visit several parks and while touring these parks he noticed that on New Market Avenue there are no curbs but a complete depression going into the property. Councilman Dean said he would like to see if we can put in a full curb. Councilman Dean than suggested to perhaps contact the county to see what they would charge to do the park. Mayor Anesh asked what he meant by do the park. Councilman Dean said to construct the park. Mayor Anesh asked for more clarification. Councilwoman Faustini said that Councilwoman Vesce said other than fencing they did paving and laid the stone. Councilman Dean concurred adding that they did the bulldozing and grading also. Mayor Anesh asked Mr. Miller what we are doing to obtain quotes. Mr. Miller said we are looking to see if we can do it ourselves, mostly what materials need to be purchased, and see if a contractor is needed. We want to keep the costs down and it appears we will not need to go out to bid. Mayor Anesh said that we do not object to the county assisting us if they are the cheapest cost though we would prefer to obtain some open space funds that were promised for this project. When we acquired this property there was a hold harmless agreement never came in front of the governing body. Mayor Anesh summed up by saying he would prefer a grant from the county, however, if they are going to provide cheaper estimates than anyone else for the Borough to pay for their services we will entertain that. Councilman Dean asked what our bid threshold is. Mr. Cullen said \$40,0000 and quotes are still required.

<u>Councilwoman Faustini</u> – concurred with the sentiments expressed for Officer Mcnelly's battle cross monument and went on to thank the governing body for their support this evening on resolution #17-176 for bail reform. Councilwoman Faustini went on to remind everyone of the dates for the Easter Egg Hunt, Litter Clean-Up, and the opening day of baseball.

<u>Councilman Bengivenga</u> – advised that he will not be around for the next meeting as he and his fiancé will be down in Virginia to honor the memory of her brother who passed away in the Virginia Tech shooting. This year marks the

ten-year anniversary. He had a military career. It is important to note that he did save lives on that day. He was honored two years ago for his heroic act.

<u>Councilman Wolak</u> – reported that the new fire truck has arrived. It is expected to be in service sometime in May and the wet down event is scheduled for June 24, 2017. There will be a live burn drill on April 8th.

Council President White - reported progress.

Mayor Anesh - reported progress.

Upon return from Executive Session at 8:30 p.m., Mayor Anesh called the public meeting back to order saying the results of this evenings Executive Session has not resulted in any further business or action needed this evening.

Without further comment and no more action necessary for this evening, Mayor Anesh called for a motion to adjourn. Councilman Bengivenga made a motion to adjourn at 8:30 p.m., seconded by Council President White and unanimously carried. The meeting was adjourned.
