## RESOLUTION 2017-255 RESOLUTION AUTHORIZING SETTLEMENT OF 2010, 2011, 2012, 2013, 2014 and 2015 TAX APPEALS FILED BY CRAGWOOD, LLC, FOR THE PROPERTY KNOWN AS 40 CRAGWOOD ROAD AND IDENTIFIED AS BLOCK 528.01, LOT 47, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

**WHEREAS**, Cragwood, LLC (hereinafter referred to as "Taxpayer") is the owner of the property known as 40 Cragwood Road and identified as Block 528.01, Lot 47, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$3,000,000 for 2010, 2011, 2012 and 2013; and

WHEREAS, the assessed value of the Property was set at \$4,515,000 for 2014 and 2015; and

**WHEREAS**, Taxpayer filed appeals of the 2010, 2011, 2012, 2013, 2014 and 2015 tax assessments in the Tax Court of the State of New Jersey under docket numbers 002728-2010, 004245-2011, 005956-2012, 003147-2013, 008126-2014 and 001619-2015; and

**WHEREAS**, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

**WHEREAS,** the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessment for the tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for the tax years under appeal; and

**WHEREAS**, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2010 original assessment in the amount of \$3,000,000 shall be reduced to \$2,728,700 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2010;

#### **COUNCIL REPORTS:**

Borough Attorney Rizzo Esq. - reported progress.

<u>Administrator Cullen</u> – advised that the Middlesex County pre-con meeting is scheduled for next week pertaining to the forthcoming traffic light placement at Oak Tree Road and Woodland Avenue. Mr. Cullen went on to say we are working on a remedy for the area near the New Brunswick Avenue rail road tracks as the area is becoming dangerous to motorists with traffic back-ups. Mr. Cullen congratulated the 2017 graduates. A letter will be going out regarding the new recycling schedule. Mayor Anesh interjected and encouraged everyone to use the My Waste App.

<u>Engineer Miller</u> – briefed everyone regarding the culvert failure that will need to have an emergent repair estimated to cost \$22,000.00 as it is not up to present day standards. Mr. Miller said the two bid awards tonight fell below the engineering estimates which was good to see.

<u>Clerk Antonides</u> – reported progress.

<u>Councilman Dean</u> – reported that he has been touching base regarding the new recycling change and it seems that the biggest issue as described by Alice Tempel was the schedule change itself. Councilman Dean also learned that they only collect #1 and #2 plastics. #3 and #7 go to the landfill. The next collection scheduled is on the  $22^{nd}$  and  $23^{rd}$ .

<u>Councilwoman Faustini</u> – advised that the community pool is open regular hours now. The membership is up about 10% this year and there has been a lot of positive feedback about the new changes at the pool. On another note, the Library will be putting up some new swings at Willow Park by the end of the month.

<u>Councilman Bengivenga</u> – said that regarding the road bids, we do strive to obtain the best service for the lowest amount. Asphalt for us is about 69-70 a ton. We seem to be lucky enough to get the better rates than seen throughout most of New Jersey.

<u>Councilman Vesce</u> – Thanked Len, Glenn and Councilman Bengivenga for reporting on the road improvements and is glad to see these projects moving ahead. Alice Tempel has also placed a recording about the recycling schedule on the hot line.
