RESOLUTION AUTHORIZING SETTLEMENT OF 2012, 2014, 2015, 2016 and 2017 TAX APPEALS FILED BY SUSHMAA REALTY, LLC, FOR THE PROPERTY KNOWN AS 2500 HAMILTON BLVD (A) AND IDENTIFIED AS BLOCK 476, LOT 1.05, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

WHEREAS, Sushmaa Realty, LLC (hereinafter referred to as "Taxpayer") is the owner of the property known as 2500 Hamilton Boulevard (A) and identified as Block 476, Lot 1.05, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$825,000 for all years under appeal; and

WHEREAS, Taxpayer filed appeals of the 2012, 2014, 2015, 2016 and 2017 tax assessments in the Tax Court of the State of New Jersey under docket numbers 012130-2012, 013057-2014, 010735-2015, 010214-2016 and 011008-2017; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for all years under appeal; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2012 tax appeal shall be withdrawn by Taxpayer;
- The 2014 original assessment in the amount of \$825,000 shall be reduced to \$728,440 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2014;
- The 2015 original assessment in the amount of \$825,000 shall be reduced to \$728,440 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2015;
- The 2016 original assessment in the amount of \$825,000 shall be reduced to \$728,440 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2016;
- The 2017 tax appeal shall be withdrawn by Taxpayer;
- Taxpayer has agreed to waive statutory interest provided the subject refunds are paid within sixty (60) days from the date of the entry of Judgment; and
- Refunds regarding over payments shall be made payable to "Michael A. Vespasiano, Attorney Trust Account", and forwarded to Michael A. Vespasiano, Esq., 331 Main Street, Chatham, NJ 07928 within 60 days from the date of the entry of Judgment.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

COUNCIL REPORTS:

Borough Attorney Rizzo Esq. - reported progress.

Administrator Cullen – welcomed back Amy not just tonight but every day of the week as it's great to have her back. Mr. Cullen explained that ordinance 2092 introduced this evening is being funded by \$192,000.00 by a FEMA grant. The Ledger just released a tax report for the County and South Plainfield came in as second lowest taxes again. Cranbury seems to always come in first. To conclude Mr. Cullen wished Councilwoman Faustini a happy birthday.

Engineer Miller – gave a brief update on the status of the 2017 road improvements saying that they are on going. Belmont will be done next week with drainage repair and paving. Because such low rates came in, it has enabled us to add a few more roads into our program for this year. The dog park is still moving along. Mr. Miller concluded by saying that he met with the water company recently to review the upcoming projects.

<u>Clerk Antonides</u> – Clerk Antonides thanked Glenn Cullen, Diane Janus, Andrew Nguyen, Anne Daley and Carmella Sutor for all their help during her leave of absence and expressed how much she appreciated all their time and effort. On another note, Clerk Antonides reminded everyone of the poll worker training class scheduled on Tuesday, October 17th at 7:00 p.m. at the Senior Center.

<u>Councilman Dean</u> – thanked the governing body for their support this evening with the hiring of the new employees for the Clean Communities program and the groundskeeper. Councilman Dean said he noticed the speed humps put in on West Fairview. Councilman Dean inquired with Lt. DeLair about the Geary Drive sector of

town if speed bumps were considered over there. He didn't believe a speed study was done there. One of the residents in the area has a petition signed to request speed humps. Mayor Anesh said it was his understanding that the speed report came back that the speed was actually low in that area. Councilman Dean said that perhaps it's not so much the speed as it is the volume of cars especially in the morning hours. Other issues are the amount of cars parked on the street and there being no sidewalks for pedestrians. There is a concern about pedestrians in the roadway. There is also a sharp radios bend in the road. A speed hump may help ease some safety concerns.

Councilwoman Faustini – advised that some folks have asked why the lights are not on yet by the PAL fields and it is because we are just waiting for PSE&G to make the connection. We are still making progress with the dog park and are on target to open it by the end of the month. The Senior Center membership is up to 500 members. Flu shots are available at Twin City Pharmacy. There will be a Fall Festival at the Library on October 14th with a special guest reader. The fire department open house is on the same day. To conclude, the evangelical church of Scotch Plains is going to extend its "service to service" mission this year to South Plainfield for those in need on Sunday October 8th. They will be wearing teal colored shirts.

<u>Councilman Bengivenga</u> – mentioned the recent NJ.com article regarding abstract ratables over the past five to six years is a real testament to this administration as we've been fortunate to keep controls over our spending while promoting important new projects; road improvements, community pool, dog park and many more. Councilman Bengivenga briefly went over the do not block the box program and his concerns. Councilman Vesce is familiar with this and will look into it.

<u>Councilman Vesce</u> – also welcomed Amy back and is glad she is on the road to recovery. Echoed Councilman Deans comments about thanking the Council for the hiring of the groundskeeper and clean community help. Our road projects are well underway for 2017. Councilman Vesce said he did speak to a representative from the water company last week who indicated that they are going to be doing a renewal project on Plainfield Avenue with pipes. It won't be done this year or during school. Hopefully we can schedule it for next year.

<u>Councilman Wolak</u> – reported progress.

<u>Council President White</u> — welcomed Lynx Staffing to town. They will have their grand opening and ribbon cutting tomorrow. The Walgreens property owners on South Plainfield Ave. are in discussions with a couple national brand corporations. The owner of the property in turn are really great to work with. Council President White concluded by saying he hopes to make an announcement in the future.

Mayor Anesh - Reported progress.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Debbie Boyle of Van Fleet expressed her concerns regarding parking issues near the Riley School then went on to mention that the Historical Society and Business Association hosted a book signing and gave away 40 books. It was a very nice event. Mrs. Boyle then went on to remind everyone of various events forthcoming throughout South Plainfield

Suzanne Lepore of Bullard Place reminded everyone of some upcoming Cultural Arts events such as a book signing at the library and line dancing at the Senior Center on October 28th at 7 p.m.

Mr. Chris Springer of 2012 Perry Street said he recently attended a rally to extend the greenway that is in Metuchen. Their plan is to extend the greenway into the dismal swamp area and hopefully to Metuchen Road. It would be a great benefit to our town. It is great for bike riding, running and walking. Mr. Springer said he would like to inform more residents about this. Councilman Dean said that there is talk about obtaining some funding for this however clean-up efforts have to be done first. Mayor Anesh suggested to contact the Observer and Tapp to help get the word out.

With no further comments from the public, Mayor Anesh closed the floor. There was no closed session for this evening.
