Proclamation: National Patriotism Week

Mayor Anesh read the Proclamation in full and designated September 4-10, 2017 National Patriotism Week on behalf of the Benevolent and Protective Order of Elks Lodge #2298. Everyone extended a round of applause.

Mayor Anesh read the Proclamation in full and then invited the coaches and the players to come forward. Council President White gave each coach and player the Proclamation as they were called up. Photos were taken by family, friends and media present and everyone extended a round of applause.

Presentation: Municipal Cards

(Presentation via conference call with Municipal Cards CFO Eli Weingarden, Director of Government Relations, Ralph Black and slid show)

Council President White stated that this idea was brought forward by Christine Profilio. Councilman Bengivenga, himself and Administrator Cullen contacted the company to find out the details, value and benefit vs. the risk to the Borough and residents. Mr. Rizzo currently is looking over the contract as well as the potential resolution also. Eli Weingarden explained that Municipal Cards is a property tax savings program. The program benefits local government, property owners and business owners. All purchases made with the card earn a reward with a greater reward earned on local and online purchases. The reward is paid towards one's property taxes before it is due. The Municipality sends out a letter to local property owners introducing the program. The homeowners then can go online to learn more about the program and securely sign up for the card. The card is received within 7-1- business days. When the homeowner uses their card they earn a percentage of all their purchases as a reward to be applied to their property tax. The transaction data is sent to Municipal Cards for reward processing. It is paid to the Municipality by Municipal Cards and credited towards the homeowner's property tax account. There is no cost to the municipality. It effectively reduces property tax signaling responsiveness to the need of taxpayers for relief. It promotes local spending which benefits local business as well as the municipality through increased tax dollars and jobs. Homeowners would need to deposit a minimum of \$800.00 monthly. If only a portion of the money is used, the next month an additional \$800.00 will need to be deposited in addition to what is left in the account. A long discussion was entertained after the presentation. At the conclusion, the Council with discuss and look into it further.

COUNCIL REPORTS:

<u>Borough Attorney Rizzo, Esq.</u> –mentioned that the COAH Compliance hearing is this Friday which should go off without a hitch. Progress.

<u>Administrator Cullen</u> – mentioned that in Ordinance #2091 that was passed in introduction today is a Capital Ordinance and is coming out of Cash Reserve. Similarly, we anticipate another increase to the Borough's ratable base and we are fairly certain that that will occur in January and we are optimistic that we are going to see an increase with surplus. The only issue that you have with surpluses is that our tax bills went out later this year than normal because of the change in State funding. But even with that our miscellaneous revenues we believe are running favorable enough and believe that both the ratable base and the surplus are going to increase this year. Middlesex Water is finishing up Sampton Avenue, weather permitting. They are finalizing their work. They started on Joan Street. Amy is still out. We don't really have a target date. We wish her a speedy recovery and thanked the Deputy Clerk for all her work over the last couple weeks. Progress.

<u>Engineer Miller</u> – mentioned that on the Road Projects that we do have going the Contractor is about finished up on Lane Avenue. There is some minor work he has to do to close that out. He is scheduled to start the word on Belmont Avenue this week which is the second project we awarded the resurfacing project. We will start out with the drainage first and then moving along with the rest of the project hopefully right after that. Progress.

<u>Councilman Dean</u> – stated that he spoke to Alice Temple today and one of her Clean Communities business associates, Bill Elliott has moved out of town and is no longer going to be doing his job. She is going to be posting a job position for this Clean Communities Aid which entails removing illegal signs, clearing off storm drains and picking up litter on the road side. She will be putting that in the Observer. Labor Day was great. Debbie Boyle and the Celebrations Committee did an excellent job and commended them for all their hard work on that and setting up. The fireworks were excellent.

<u>Councilwoman Faustini</u> –reported on a few more recreation projects. Memorial Field lighting. 3 of the 4 light poles already had footings and the completion should be done next week. Wrestling floor underlayment has been installed and the rotation of the mats is near completion. Cheer mats should now be expected to be delivered next week. Willow Park has now been up and running. We are still waiting for the adaptive swing. As far as the Dog Park goes, the water line is in. The grading has been completed. The fencing has begun installation and should be done this week. The donated Flagpole has been ordered. The stone is to be delivered next week and some paving the following week and thanked Councilman Dean for donating use of equipment from his company A-Tech to do hydro-seeding for the dog park and also thanked Councilman Bengivenga who is going to partner along with this with Councilman Dean and donate the seed. She also thanked the Elks for the Flagpole donation and the Buddha's light International is donating benches and thanked them as well. We have a targeted opening date of October 21st. Lastly she thanked the Public Celebrations Committee and everyone who worked so hard and put in many hours that day. It was fabulous. Progress

<u>Councilman Bengivenga</u> – mentioned that yesterday was a great day. The fireworks were great last night. Councilman Bengivenga stated that he received a political phone call saying that a Councilman's company is where the borough purchased the garbage trucks and wanted to clarify this Cassie and Roberto were sitting in the audience. Councilman Bengivenga then read the resolution that states, award the contract to purchase two garbage trucks to Atlantic Sales and Salvation of Delran NJ. No on this Council, no one ever on this Council has ever worked or have been associated with Atlantic Sales and Salvage. I work for Republic Services of NJ. They do not sell garbage trucks to any municipality or anybody in the public. Our trucks go overseas. We have no connections or business dealings with this Company. Progress

<u>Councilman Vesce</u> – echoed the other Council members on the Board and added that the Labor Day Parade was a great success and thanked the DPW. Councilman Vesce added that something was brought to his attention which he did also see which was the road was swept immediately after the parade. It makes people disburse and get the roads back open. Councilman Vesce stated that he spoke to Council President White and there is a Tom Stillman who is requesting a name change for South Clinton Avenue, which is a County Road. It is for the Historical Society for Drake, the Drake House. They would like to rename it Drake's Crossing. Councilman Vesce is researching it now and will give him the information and added that he has two options. He can rededicate it without renaming it, like you see on some of the streets with the name underneath it, or he can ask if the Borough has any objection to renaming it and if they do not have an objection, it goes to Resolution and then it goes to the County. The County would give it consenting resolution and then the name would get changed. Mr. Stillman is bringing it back to his Society to see which way he wants to go. Progress.

<u>Councilman Wolak</u> – stated agreed that Labor Day Parade was fantastic and the fireworks were great. Thank you everybody and Congratulated the 9U Baseball Team. Progress.

<u>Council President White</u> – stated the Dunkin Donuts on Maple Avenue is not leaving town. It is being renovated and a new platform is being done. It is supposed to be completed by this weekend. Council President White reported progress on the "seamless" forms which are online form which allow residents, builders, etc. to go online and fill out the forms. It on the Borough webpage under "Quick Links". Council President White also stated that he is grateful that DMV is moving back to South Plainfield in February. Progress

<u>Mayor Anesh</u> – reminded everyone that Mayor's Wellness Committee will be meeting this week. We have a couple of items that we will be planning as usual the Fall Health Fair. Generally, it falls on the same day as the Fire Department Open House and will make it a community event. In addition to that we will be planning the additional seminar. It was a year or so ago that we did a seminar over in the Library highlighting the heroine epidemic and we had speakers and we will be looking to do something along the same lines as that format. We are finalizing a Community Health Survey that will be going out. This is all to make sure that South Plainfield could get one of the few healthy town designations that are throughout the State of New Jersey. It is completely anonymous. Lastly, Mayor Anesh wished all of the administrators, students and especially the parents a successful school year. Progress

Mayor Anesh opened the floor for public comment.

Debbie Boyle of Van Fleet Avenue thanked everyone for participating in the parade or coming out and being supporters. We had 12 new additions to the parade. Mayor Anesh added that thanks to Anne who was out there on Plainfield Ave. was on Facebook live. Stephanie videotaped the entire firework show also. Debbie also thanked Chief Parker for all the meetings that we had. Everything went very smooth, the DPW was amazing. The Business Association is hosting a book signing at the Highland Woods. That will be for the new book Dorothy Miele and Dr. Veit wrote on South Plainfield on the September 19th at 6:00 p.m. National Walk and Bike to School Day is the first Wednesday in October, which is October 4th and is for Mayors Wellness. The donations for the PBA, Fire Dept. and Rescue is something that Stephanie Bartfalvi and I started last year. It is honoring the first responders and residents make donations in the jar.

Roberto Sayers of West Crescent Parkway was wondering why his name was mentioned. Councilman Bengivenga responded that he received a poll which was from Roberto's party and they were saying would you be incline to vote for somebody if you knew that a Council Member's employer is where they bought the garbage trucks from but that is not true and that is why I read the resolution to Atlantic Salvage in Delran NJ. Councilman Bengivenga added that he is not sure if you know that poll. Roberto responded that this is why he is here asking because he does not know about this. Roberto added that most of you know me and whenever anything is brought to my attention I ask for the facts. I do not believe in destroying peoples reputations for politics, after all we are neighbors.
