**Review of Agenda Items**: Clerk Antonides reviewed all the items on the agenda. Mr. Rizzo Esq. asked to pull the Woodbrook Road Environmental Clean-Up from the executive session Mayor Anesh asked if the Council had any comments, but no comments were made. Councilman Vesce asked if we are locked into the purchase of the canvas enclosure for the Recycling Enhancement Grant. Mr. Cullen said no and Councilman Dean said that Alice Tempel is seeking other options. Clerk Antonides pointed out that this is a time sensitive grant application. Mr. Cullen said we just need to get the application submitted right now but believes we are not locked into a canvas enclosure. After a brief discussion the consensus of the governing body was to proceed and authorize the grant submission but continue to have Alice Tempel seek out other alternatives.
