Bond Ordinance #2112

BOND ORDINANCE PROVIDING FOR VARIOUS ROAD IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$844,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$799,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

- Section 1. The improvement described in Section 3(a) of this bond ordinance is hereby authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as a general improvement. For the improvement or purpose described in Section 3(a), there is hereby appropriated the sum of \$844,000, including the sum of \$45,000 as the down payment required by the Local Bond Law, \$25,000 of which is being provided from the Reserve for Road Improvements and \$20,000 of which is being provided from the Capital Improvement Fund.
- Section 2. In order to finance the cost of the improvement or purpose not covered by application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$799,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.
- Section 3. (a) The improvement hereby authorized and the purpose for the financing of which the bonds are to be issued is various road improvements, including, but not limited to, milling and resurfacing of Ball Place, Cromwell Place, Cedarbrook Avenue, Front Street and other various roads, all as set forth on a list on file in the Office of the Clerk, and further including all work and materials necessary therefor and incidental thereto.
- (b) The estimated maximum amount of bonds or bond anticipation notes to be issued for the improvement or purpose is as stated in Section 2 hereof.
- (c) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefor.
- Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date, unless such bond anticipation notes are permitted to mature at such later date in accordance with applicable law. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law or other applicable law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.
- Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.
 - Section 6. The following additional matters are hereby determined, declared, recited and stated:
- (a) The improvement or purpose described in Section 3(a) of this bond ordinance is not a current expense. It is an improvement or purpose that the Borough may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.
- (b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is 10 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of

New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$799,000, and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.

(d) An aggregate amount not exceeding \$65,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purpose or improvement.

Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3(a) of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purpose described in Section 3(a) hereof shall be applied either to direct payment of the cost of the improvement or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

BOND ORDINANCE AMENDING IN ITS ENTIRETY BOND ORDINANCE #2076 OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, FINALLY ADOPTED MAY 1, 2017, TO INCLUDE ADDITIONAL PROJECTS, TO INCLUDE AN ADDITIONAL GRANT, TO DECREASE AND INCREASE CERTAIN APPROPRIATION AND AUTHORIZATION AMOUNTS, TO INCREASE THE DOWN PAYMENT, TO INCREASE THE SECTION 20 COSTS AND TO AMEND THE AVERAGE USEFUL LIFE.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY

OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Bond Ordinance numbered 2076 of the Borough of South Plainfield, in the County of Middlesex, New Jersey

(the "Borough), finally adopted May 1, 2017, is hereby amended in its entirety to read as follows:

"BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$751,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$559,325 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

- Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$751,000, including a grant in the amount of \$137,500 from the County of Middlesex for the improvement or purpose in Section 3(a) (the "County Grant") and a Community Development Block Grant (the "CDBG") in the amount of \$25,000 for the improvement or purpose in Section 3(i) and further including the aggregate sum of \$29,175 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.
- Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, the County Grant and the CDBG, negotiable bonds are hereby authorized to be issued in the principal amount of \$559,325 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

§84-2 Department Personnel

The Police Department of the Borough of South Plainfield shall consist of one (1) Chief of Police, two three (3) Captains, seven (7) Lieutenants, seven eight (8) Sergeants, forty-four (44) police officers and such other staffing requirements and employees as shall from time to time be deemed necessary by the Mayor and Council to properly preserve peace and good order within the Borough of South Plainfield.

All other provisions of this Chapter of the Code of the Borough of South Plainfield shall remain in full force and effect.

This Ordinance shall be effective upon final adoption and publication in accordance with the law.

COUNCIL REPORTS:

Borough Attorney Rizzo Esq. - reported progress.

<u>Administrator Cullen</u> – reviewed the highlights of the 2017 municipal audit and said if anyone has any questions to feel free to reach out to him.

<u>Engineer Miller</u> – advised that the road contractor is presently working on Lonsdale and will then move on to Orchard Lane next. Also we are going out to bid for the 2018 Road Resurfacing Project of which bids are due by June 21st. The new garbage truck will be on the road tomorrow and will be on the road at least twice a week. This will enable us to catch-up with bulk collection. We have also added another bulk item drop off date; June 23rd.

<u>Clerk Antonides</u> –reminded everyone that tomorrow is the Primary Election and that polls are open from 6:00 a.m. to 8:00 p.m.

<u>Councilman Vesce</u> – reported progress.

<u>Councilman Wolak</u> – congratulated the high school baseball team on their tournament win they worked really hard and then went on to report progress.

<u>Councilman White</u> – said he is very excited to welcome Fit Body Boot Camp who had their grand opening. The ribbon cutting was today and they will be a nice addition to our town. Councilman White then reported progress.

<u>Councilman Dean</u> asked if South Plainfield Avenue will be paved tomorrow. Mr. Miller said he will check. Councilman Dean expressed he is concerned for the crumbling curbs by Mr. Subs and thinks we should look at them. Mr. Miller said it's not in the Water Company's job program to do that. Mr. Miller said technically the curb and sidewalks are the responsibility of the businesses. Councilman Dean went on to discuss the status of various recycling issues we've been having. Mr. Cullen said that he has word that they will be adding an additional truck and an Inspector to oversee our recycling pick-up. Councilman Dean asked how well we are documenting their mishaps. Mayor Anesh said that it seems that Alice Tempel is on top of that. On another note Councilman Dean expressed concern about the dog park's grass being 18" high. Mr. Miller said yes, it is due to the weather, however, it is scheduled to be mowed tomorrow.

<u>Councilwoman Faustini</u> – advised that the new equipment at Willow Park is installed and the surface area should be going in this week, weather permitting. Buddha's Lite International Association sent us an invitation to join them for a presentation they are doing on vegetarianism at the Library; June 10th, 2 p.m. Due to the election at the Senior Center there will be no activities scheduled for tomorrow.

Council President Bengivenga — reported on the status of the Woodland Road traffic light advising that the gas pipe is still under that road however, PSE&G were called away to another project but they will be back in the coming days to address this gas pipe. The project has been stalled because of that. On another note, Council President Bengivenga inquired about barrels that have been near a guard rail on Clinton Avenue for what seems to be years now. Councilman Vesce said he is aware of that and it is because there was litigation involved with it, specs were changed which resulted in the County not having the right parts to make the repairs. They are working on a bid in this regard to resolve this issue. Council President Bengivenga proposed having a special meeting on Monday June 25 at 7 p.m. for the purpose of awarding the bid for the 2018 road resurfacing program. The governing body unanimously agreed, however, Councilman Vesce said he will be away that day.

Mayor Anesh - reported progress.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Jeff Seider asked if anyone would intentionally hire a bad contractor for your homes and then went on to express his concerns regarding what he believes to be substandard work performed by the contractor who installed trees on Franklin Avenue indicating that some were crooked, some too close together, some under wires, some root balls too far above ground, and some not staked. Councilman Dean said he too looked at it and spoke to Alice Tempel. A member of the Green Team acted as the landscape architect and did the measurements, etc. Alice said she did inspect it while the work was taking place. Mr. Seider asked why we should accept something installed incorrectly. Councilman Dean said at this point removing these tress will cause them to die. Mr. Rizzo said the environmental commission did the lay out and it was already approved. Mr. Cullen said the project was approved last May. Mr. Seider said that people are approving things not up to standard. Mr. Seider asked Mr. Miller if he has enough people to run the DPW. Mr. Miller said though this year's weather put us behind, which is why this year is very unique, under normal circumstances we may be on the minimal side but we're getting the work done. Mr. Seider said we need to find a better way even if it means increases our taxes. Mr. Seider said to please fix the pot holes. Mr. Seiders said we need to set a policy as to how we handle curbs and sidewalks.

At 8:18 p.m. Mayor Anesh called for a recess from the public portion of the meeting to go into Executive Session advising that everyone is welcome to stay if they choose.

Upon return from the closed session meeting Mayor Anesh announced that no action will be needed as a result of this evening's closed session meeting.

ADJOURNMENT

Without further comment and no more action necessary for this evening, Mayor Anesh called for a motion to adjourn. Council man White made a motion to adjourn at 9:54 p.m., seconded by Council President Bengivenga and unanimously carried. The meeting was adjourned.
