RESOLUTION AUTHORIZING SETTLEMENT OF 2013, 2014 and 2015 TAX APPEALS FILED BY M & M REALTY PARTNERS AT SOUTH PLAINFIELD LLC FOR THE PROPERTY KNOWN AS 1111 DURHAM AVENUE AND IDENTIFIED AS BLOCK 550, LOT 3 ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

**WHEREAS**, M & M Realty Partners at South Plainfield, LLC (hereinafter referred to as "Taxpayer") is the owner of the property known as 1111 Durham Avenue and identified as Block 550, Lot 3 on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$7,980,000 for 2013; and

WHEREAS, the assessed value of the Property was set at \$3,603,000 for 2014; and

WHEREAS, the assessed value of the Property was set at \$3,603,000 for 2015; and

**WHEREAS**, Taxpayer filed appeals of the 2013, 2014 and 2015 tax assessments in the Tax Court of the State of New Jersey under docket numbers 004293-2013, 001956-2014 and 004576-2015; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the 2013 tax year under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for the 2013 tax year; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2013 original assessment in the amount of \$7,980,000 shall be reduced to a total tax assessment of \$3,603,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2013;
- The 2014 tax appeal shall be withdrawn and the total tax assessment for tax year 2014, in the amount of \$3,603,000,

shall remain unchanged;

- The 2015 tax appeal shall be withdrawn and the total tax assessment for tax year 2015, in the amount of \$3,603,000, shall remain unchanged;
- Taxpayer has agreed to waive statutory interest provided that any refunds are paid within sixty (60) days from the date of the entry of the Tax Court Judgment; and
- Any refunds as a result of the settlement shall be made payable to "Michael I. Schneck, Esq., Attorney for M & M
  Realty Partners at South Plainfield LLC" and forwarded to counsel for taxpayer within sixty (60) days of the date of
  the Judgment.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

**WHEREAS**, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

**WHEREAS**, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

**WHEREAS**, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reductions to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 1. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$3,603,000 total tax assessment for the 2013 tax year for Block 550, Lot 3 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 2. The Borough Attorney is authorized to execute on behalf of the Borough of South Plainfield the attached Stipulation of Settlement pertaining to the tax appeals filed by M & M Realty Partners at South Plainfield LLC under Docket Nos.: 004293-2013, 001956-2014 and 004576-2015 for the Property known as 1111 Durham Avenue and identified as Block 550, Lot 3 on the Borough of South Plainfield Tax Assessment Maps which reduces the 2013 total tax assessment on the Property from \$7,980,000 to \$3,603,000; which withdraws the tax appeals for the 2014 and 2015 tax years; which provides that Taxpayer agrees to waive statutory interest on any refund or overpayment due provided the refund check is paid within sixty (60) days of the date of the Tax Court Judgment; and which further provides that any refunds shall be made payable to ""Michael I. Schneck, Esq., Attorney for M & M Realty Partners at South Plainfield LLC" and forwarded to counsel for taxpayer within sixty (60) from the date of the Tax Court Judgment.

#### **COUNCIL REPORTS:**

Borough Attorney Rizzo Esq. - reported progress.

Administrator Cullen — advised that we are expecting the tax bills to go out by the end of this week or by next Monday or Tuesday. The grace period has been extended until August 31<sup>st</sup>. The sewer bills should be out by this Wednesday or Thursday. The delay was due to the change of funding on the state level. Orchard Drive has been delayed due to six service lines that were in conflict. They were out last week moving these lines. Once that is done than the storm sewer work can be completed.

<u>Engineer Miller</u> – The milling on Hadley Road is taking place. The road has been kept open with no issues with traffic. When the paving takes place, it will be done at night. We received a letter from the County saying they will start their work on Plainfield Avenue from Sampton to the county line on the 26<sup>th</sup> to complete by August 3<sup>rd</sup> with striping to follow.

<u>Clerk Antonides</u> – Advised that she set-up a poll worker training class at the Senior Center on Thursday, October 18<sup>th</sup> at 7:00 p.m.

Councilman Vesce – was absent this evening.

<u>Councilman Wolak</u> – wished everyone a happy summer and is looking forward to seeing everyone at the upcoming Christmas in July event which should prove to be a good turnout.

<u>Councilman White</u> – thanked everyone that is involved with putting together the Christmas in July event.

Councilman Dean — asked if the woodchip pile will be hauled out this week, Mr. Cullen said yes, this week. There were a few more issues with recycling this week with Bolliger Way in particular. Mr. Cullen said he had DPW pick it up just because we had a storm forthcoming. Councilman Dean asked if Alice had any more calls while she was away. Mr. Cullen said no nothing was sent over to him. Councilman Dean said he noticed the Woodland Avenue project seems to be moving along now. Mr. Cullen said correct, but he is not sure if the gas line is completely moved yet. On a final note Councilman Dean said someone approached him earlier that on June 26<sup>th</sup> our garbage truck was involved in an accident of which neither he nor Councilman Vesce were notified about. Mr. Cullen said yes and Mr. Miller interjected that someone ran a stop street and hit the truck. There was no damage to our truck. The police were there and took a report. Councilman Dean said that when the public contacts them and starts asking them questions about the DPW truck being involved in an accident they would like to be notified. Councilman Dean said Councilman Vesce indicated that this is the third time now that he has not been notified of such an occurrence. Council President Bengivenga said this was a minor incident with no damage at all. Councilman Dean said he understands that but the point is it's a Borough vehicle involved in an accident. It seems other departments notify the council or liaison for that department. Council President Bengivenga said that it seems you've known about it for a month that you would have reached out to Len. Councilman Dean said he just literally found out.

Councilwoman Faustini - was absent this evening.

Council President Bengivenga – that we are still looking for window decorators for the Christmas in July event. The AC units at the PAL should be completed soon and same with the Senior Center. National Night Out is Tuesday, August 7<sup>th</sup> behind the Library. There is also an emergency vehicles event on August 4<sup>th</sup> at Veteran's Park. The Police Department is bringing back the Junior Police

Academy. Safety Town will be forthcoming in August. In the fall we will be hosting a buddy ball with basketball for special needs children. Again the grace period for tax bills has been extended to August 31<sup>st</sup>.

Mayor Anesh – was absent this evening.

### **COMMENTS FROM THE PUBLIC:**

Council President Bengivenga opened the floor for public comment.

Mr. Roberto Sayers of West Crescent Parkway inquired if there are any penalties worked into the recycling contract, in cases where the contactor isn't working up to par. Mr. Cullen said yes there are penalties, but we have to work through the county with that. We have worked up a bill to be compensated for the recycling services. Mr. Sayers said this is the 2<sup>nd</sup> or 3<sup>rd</sup> time that Councilman Vesce has not been notified of things happening at the DPW. Mr. Sayers said it should be an easy thing to do to just call him as an FYI and feels we can be doing better than this. Councilman White said that Mr. Miller and Councilman Vesce will work it out and discuss it.

Debbie Boyle of Van Fleet went over the itinerary for the Christmas in July event then went on to say we are a small community and encourages the Council to set an example by reaching out to people in person instead of having the Borough attorney write letters.

Nancy Grennier from the Observer thanked the Council for doing a second bills list to accommodate the Christmas in July vendors at the last minute. There should be 70-75 vendors in attendance. Mrs. Grennier asked to have the Santa chair, wreaths and barricades put out for the event. Mr. Miller said he will take care of it.

Mr. Jeff Seider of 208 O'Donohue Avenue asked what the table of organization is. Council President Bengivenga explained it. Mr. Seider said as a former elected official he would be very upset if he was not notified of something. If Mr. Miller reports to the Administrator than the Administrator should notify the Council liaison. Mr. Miller said he has never heard of any policy in this Borough for reporting of accidents to certain officials. Mr. Seider said it should be a town policy that the Department Heads report to the Administrator and in turn he informs the council liaison. No one should be left unaware. Councilman Dean said that is why he brought it up because a resident approached him and he had no idea about it. Mr. Seider said everyone should be equally aware and you all work for the tax payers. Mr. Miller stressed that this is an insignificant accident with no damage and questioned why other departments are not tasked with reporting every little scratch or fender bender i.e. police, fire, ems, etc. Mr. Seider asked what the status of Mario's position is. Mr. Cullen said we are weighing in on various options in that regard. At present John Abbruzzese is filling in. Mr. Seider stressed the importance of having someone full time taking care of these property maintenance issues that are all over town. Councilman Dean said a quick email going out to everyone would be all it would take.

Mr. Sayers said we spend a lot of time talking about common curtesy, and encouraged everyone to just let each other know what is going on. Send a simple email. You don't need a policy for common curtesy.

Ms. Boyle commented on the great job Eagle Scout Joe Reilly did on the Parade Marshall wall.

Council President Bengivenga said he just wanted to clarify that Department Heads should be notifying their council liaison opposed to the entire council.

### <u>ADJOURNMENT</u>

Without further comment and no more action necessary for this evening, Council President Bengivenga called for a motion to adjourn. Councilman White made a motion to adjourn at 7:57 p.m., seconded by Councilman Dean and unanimously carried. The meeting was adjourned.
