The following Ordinance 2125 was read by Clerk Antonides by title on second reading. Mayor Anesh opened the floor for public comment and with no comments made closed the floor.

BOND ORDINANCE #2125

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$629,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$597,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$629,000, and further including the aggregate sum of \$32,000 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, negotiable bonds are hereby authorized to be issued in the principal amount of \$597,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to ¹be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

b) The acquisition of police sport utility vehicles, traffic safety devices and surveillance equipment, including all related costs and expenditures incidental thereto.	\$230,000	\$218,300	5 years
c) The acquisition of a sport utility vehicle for the Fire Department, including all related costs and expenditures incidental thereto.	\$49,000	\$46,450	5 years
d) The acquisition of a heating, ventilation and air-conditioning unit for the Fire Department, including all related costs and expenditures incidental thereto.	\$ <u>12,000</u>	\$ <u>11,350</u>	15 years
Total:	\$ <u>629,000</u>	\$ <u>597,000</u>	

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date, unless such bond anticipation notes are permitted to mature at such later date in accordance with applicable law. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law or other applicable law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 5.19 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$597,000, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$7,500 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.

Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to

comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

ORDINANCE NO. 2127 AN ORDINANCE AMENDING CHAPTER 187, TITLED VEHICLES AND TRAFFIC.

WHEREAS, the Traffic Safety Advisory Committee has reviewed a concern with a parking lot entrance to 316 Durham Avenue, which is a McDonald's restaurant, and has recommended that the Vehicles and Traffic Ordinance be amended to prevent certain left turns; and

WHEREAS, the Governing Body of the Borough of South Plainfield has considered the recommendation of the Traffic Safety Advisory Committee and deems it to be appropriate;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 187, titled Vehicles and Traffic, shall be amended as follows:

Article IV, Prohibited Turns, Section 187-28(A)(12), shall be deleted and replaced with the following:

Parking lot entrance to 316 Durham Avenue (McDonald's restaurant), no left turn from the most southerly driveway onto northbound Durham Avenue, and no left turn from northbound Durham Avenue into the southerly driveway of 316 Durham Avenue.

ORDINANCE 2128 AN ORDINANCE AUTHORIZING SALE OF PROPERTY KNOWN AS BLOCK 362, LOT 3 OF THE BOROUGH OF SOUTH PLAINFIELD.

WHEREAS, the Borough of South Plainfield is the owner of Block 362, Lot 3 located on Kenneth Avenue (hereinafter the "Property"); and

WHEREAS, the Property is vacant and measures 75 feet by 100 feet; and

WHEREAS, the Property is no longer used by the Borough for any purpose; and

WHEREAS, the Property is undersized because it is less than the minimum width and size for development in the R-10 Zone; and

WHEREAS, the Local Lands and Buildings Law, N.J.S.A. 40A:12-1, et seq., allows the sale of municipally-owned properties at a private sale under certain circumstance (N.J.S.A. 40A:12-13(b)(5)) or at public auction; and

WHEREAS, the Borough Council is of the opinion that the criteria set forth in N.J.S.A. 40A:12-13(b)(5) are present, namely that the Property is less than the minimum width and size required for development in the R-10 Zone and is without capital improvements, and there are two owners with real property contiguous to the Property so that the Property shall be offered to the contiguous property owners and sold to whichever may be the highest bidder; and {A0961100.1}

WHEREAS, the Borough has had an appraisal performed by Sterling DiSanto & Associates and determined the fair market value of the Property to be \$120,000.00; and

WHEREAS, the Borough Council is of the opinion that the Property is a remnant lot what is no longer useful to the Borough; and

WHEREAS, the Borough Council is of the opinion that the sale of the Property is beneficial to the health, safety and welfare of the residents of the Borough because said Property is a remnant lot that is not useful to the Borough and requires expenditure of scarce public resources and does not generate any real estate tax revenue;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey as follows:

1. The Borough Council hereby authorizes the sale of the Property to the highest bidder between the owners of the contiguous properties at a minimum price of \$120,000.00;

2. Pursuant to N.J.S.A. 40A:12-13(b), the Borough Clerk shall advertise the sale of this Property in the official newspaper of the Borough within five days following enactment of this Ordinance;

3. The Borough Clerk shall post a description of the Property to be sold pursuant to this Ordinance, together with minimum price within the Borough Municipal Building;

4. The Borough Attorney shall transmit to the owners of the contiguous properties notice of the Borough's intention to sell;

5. Offers for the Property shall be made to the Borough Clerk for a period of 20 days following the advertisement herein required, at no less than the minimum price set forth in this Ordinance, by either of the contiguous property owners;

6. In the event neither contiguous property owner offers to purchase the Property, or does not offer the minimum price required, the Property may be sold at public auction on a date and time to be set by resolution of the Borough Council;

7. The Property will be sold "as is" and "whereas" without representations or warrantees, and subject to existing restrictions of record. The Property shall be conveyed by quit claim deed;

8. The Borough reserves the right to reject all bids in its sole discretion; and

9. The Borough Attorney is hereby authorized to prepare the necessary closing documents to convey the Property to the highest bidder, and the Mayor and Borough Clerk are hereby authorized to sign all necessary closing documents.

This Ordinance shall take effect immediately after adoption and publication according to law.

WHEREAS, it has been requested by the Mayor and Borough Council of the Borough of South Plainfield to develop, construct and refurbish a new community pool in the Borough; and

WHEREAS, information sessions available to the public pertaining to the proposed development, construction, and refurbishment of the community pool shall be held in the Council Chambers of Borough Hall located at 2480 Plainfield Avenue, South Plainfield, NJ 07080 at 7:00 p.m. on February 28, 2019, March 7, 2019 and March 18, 2019 in which the floor will be open for public comment; and

WHEREAS, the proposed development, construction and refurbishment of said new community pool is estimated to cost approximately \$2,475,000.00; and

Saturday, March 23, 2019	8:00 a.m. to 12 Noon

WHEREAS, N.J.S.A. 19:37-1 authorizes the Governing Body, when there is no other statute by which the voters' sentiment can be ascertained, to submit such a question to a vote of the legally registered electors; and

WHEREAS, the non-binding referendum shall be organized and operated by the Borough Clerk by way of paper ballot to be conducted and received in the Borough Clerk's Office at the Borough Municipal Building located at 2480 Plainfield Avenue, South Plainfield, New Jersey, from Tuesday March 19, 2019 through Saturday March 23, 2019, as part of South Plainfield Borough's traditional "Democracy Week"; and

WHEREAS, the form of any public question put to the voters must follow the guidelines indicated in N.J.S.A. 19:3-6, which requires the phrasing of any public question on a ballot to clearly set forth the true purpose of the matter being voted upon, in simple language that can be easily understood by the voter;

NOW THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, State of New Jersey that it hereby declares that the week of March 19, 2019 through March 23, 2019 be and hereby is declared "Democracy Week" in the Borough of South Plainfield at the aforementioned specific dates and times; and

BE IT FURTHER RESOLVED by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, State of New Jersey that during said "Democracy Week" the Borough Clerk is hereby authorized to organize and operate a non-binding referendum election through the traditional "Democracy Week" method by way of paper ballots within the Borough Clerk's Office in the Borough of South Plainfield in which all legal voters of the Borough of South Plainfield that have been registered to vote by March 1, 2019 or sooner may participate; and

BE IT FURTHER RESOLVED by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, State of New Jersey that during said "Democracy Week" the Borough Clerk is hereby authorized to prepare, distribute and collect paper ballots for the said non-binding referendum election to obtain the public's sentiment for the following proposition:

"Shall the Borough Council of the Borough of South Plainfield adopt a bond ordinance in the maximum amount of \$2,475.000.00 to be authorized in order to fund the development, construction and refurbishment of a new community pool within the Borough of South Plainfield?"

To vote upon the public question printed below:

if you are in favor – check the box next to the word "yes" if you are opposed – check the box next to the word "no"

BE IT FURTHER RESOLVED by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, State of New Jersey that the Borough Clerk shall include the following Interpretive Statement to accompany the aforesaid proposition:

INTERPRETIVE STATEMENT:

The proposed bond ordinance would be used to fund the development, construction and refurbishment of a new community pool within the Borough of South Plainfield. The estimated cost for the development, construction and refurbishment of a new community pool is \$2,475,000.00. The bond ordinance requires a 5 % down payment in the estimated minimum amount of \$123,750.00, which would have to be included in the municipal budget.

A "Yes" vote on the above question means that you <u>do</u> want the Borough Council to authorize the adoption of a bond ordinance to fund the development, construction and refurbishment of a new community pool.

A "No" vote on the above question means that you do <u>not</u> want the Borough Council to authorize the adoption of a bond ordinance to fund the development, construction and refurbishment of a new community pool.

Borough Attorney Rizzo Esq. - reported progress.

Administrator Cullen - reported progress.

<u>Engineer Miller</u> – advised that the recent bids for curbside recycling came in significantly higher than what we are paying now through the County, almost double the price. As such, Mr. Miller recommended to hold off and await to see what the County is able to negotiate in this regard. <u>Councilman Vesce</u> – reported that the overhead signs for the truck route on Hamilton Blvd. may be installed the end of the week, with weather permitting. Councilman Vesce advised that he received a couple emails from residents and one was pertaining to the Hollywood Avenue truck route which Mr. Miller has provided and update on for him to relay back to the resident. The other resident questioned Montrose which he will also respond back to the resident.

<u>Councilwoman Faustini</u> – The Library is hosting a Black History Month for Children on February 28th and will be celebrating Dr. Seuss's birthday with a special guest reader on March 2, 2019 at 10:30 a.m. On another note, Councilwoman Faustini pointed out that the resolution authorizing Democracy Week was passed this evening. There will be three information sessions and a redendoring of the proposed new community pool will be available.

Mayor Anesh opened the floor for public comment.

Debra Boyle of Van Fleet reported on the upcoming Talent Showcase sponsored by Cultural Arts Commission and named the Spelling Bee winners.

Ms. Ginny O'Brien of 151 Morris Avenue said she read the article regarding the pedestrian beacon to be placed on Maple Avenue and suggested other locations with emphasis on Plainfield and Madison Avenues such a beacon may be good for due to her concerns for the high traffic. Councilman White said that Traffic Safety has been at that location this past week. Mayor Anesh said that we will have traffic safety look at that intersection further. Ms. O'Brien went on to express her concerns over the sewer back-up into her basement she experienced and paid for last year. Ms. O'Brien vented her frustration feeling the back-up was caused by the utility and not by her. Photographs were taken and showed a pole that went through her line thus causing the back-up. Ms. O'Brien wants a refund of the money she paid out to the utility company indicating she will get an attorney involved. Mr. Miller explained that we sent everything to BPU and as a result that informed her to go through the appeal process as they don't feel there is enough pictures of this situation. Mayor Anesh asked Mr. Miller to send copies of the photos to him.
