### ORDINANCE # 2134 CALENDAR YEAR 2019

# ORDINANCE TO EXCEED THE MUNICIPAL BUDGET COST OF LIVING ALLOWANCE AND TO ESTABLISH A CAP BANK WHEN THE COLA IS EQUAL TO OR LESS THAN 2.0 PERCENT PURSUANT TO N.J.S.A. 40A:4-45.14

**WHEREAS**, the Local Government Cap Law, N.J.S. A. 40A:4-45.1 *et seq.*, provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.0% or the Cost-of-Living Adjustment (COLA), whichever is less, over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, N.J.S.A. 40A:4-45.14 provides that a municipality may, in any year in which the COLA is equal to or less than 2.0% increase its final appropriations by a percentage greater than the COLA, but not to exceed the 3.5% rate as specified in the law, when authorized by ordinance; and,

**WHEREAS**, the COLA for 2019 has been certified by the Director of the Division of Local Government Services in the Department of Community Affairs as .5% and,

**WHEREAS**, N.J.S.A. 40A:4-45.15a provides that a municipality may, in any year in which the COLA is equal to or less than 2.0%, may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of South Plainfield in the County of Middlesex finds it advisable and necessary to increase its 2019 budget by more than 2.0% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$836,395.21 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS**, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2019 budget year, the final appropriations of the Borough of South Plainfield shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$836,395.21 and that the 2019 municipal budget for the Borough of South Plainfield be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, the Borough Fire Prevention Official/Marshall has requested revisions to Chapter 230 of the Code of the Borough of South Plainfield; and

WHEREAS, the Public Safety Committee has reviewed such request and has approved same;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 230, Fire Prevention be amended as follows:

All referenced sections shall be deleted as existing and shall be replaced with the language provided herein.

### § 230-2: Agency Designation.

The local enforcing agency shall be the Office of the Fire Marshall/Bureau of Fire Prevention.

### § 230-4: Life Hazard and Local Uses.

The local enforcing agency established by Section 230-2 of this Article shall carry out the periodic inspections of life hazard and local uses required by the Uniform Fire Code on behalf of the Commissioner of the Department of Community Affairs.

#### § 230-5: Organization.

The local enforcement agency established by Section 230-2 of this Article shall be under the control of the Fire Official/Fire Marshall and shall report to the Mayor and Council.

### § 230-21. Events Requiring Permits.

When Fire Official/Fire Marshall determines that an on-site fire inspector or fire-fighting personnel or equipment are required for fire watch as a result of any of the following listed below, the owner of occupant responsible shall obtain a permit for the use or event.

A. Fire protection system failures and/or deficiencies, including both suppression and detection systems required by the NJ International Fire and Building Codes.

- B. Emergency warning and fire detection systems required by the NJ International Fire and Building Codes.
- C. Fire safety at any occupancy or event within the Borough of South Plainfield to ensure the safety of the public or emergency responders or any other event in which a crown of potentially 500 persons or more is to assemble.
- D. Standby coverage at fire investigation scenes. (Specific to firefighters only.)
- § 230-22. Required Personnel; Hours on Duty.
- A. The Fire Official/Fire Marshall shall determine the number of inspectors and/or fire fighting personnel required.
- B. The Fire Official/Fire Marshall shall determine the hours that the fire inspector(s) and/or fire-equipment and personnel will be on duty.

### § 230-24. Fees for Services.

- A. Compensation for inspector(s) for non-working hours for "for profit" groups or entities will be at \$54.00 per hour with \$2.00 per hour being directed to the Borough. For such hours for not for profit groups or entities, compensation shall be \$40.50 per hour with \$2.00 directed to the Borough.
- B. Compensation for all certified firefighters (firefighter 1) required by the Fire Official/ Fire Marshall as part of a standby shall be \$27.00 per hour with \$2.00 per hour directed to the Borough. Firefighters will be compensated \$25.00 per hour.
- C. The rate for use of vehicles shall be as follows when requested under orders from the Bureau of Fire Prevention. All fees for apparatus will be placed in the care of the Borough of South Plainfield.

(1) Engine: \$50.00 per hour
 (2) Truck: \$100.00 per hour
 (3) Rescue: \$50.00 per hour
 (4) All others: \$25.00 per hour

### § 230-25. Right of Access.

The Fire Official/Fire Marshall or their designee(s) shall have right of access to the premises and areas surrounding it without interference from the property owner.

#### § 230-26. Permit Fees; Penalties for Failure to Secure Permit.

Failure to secure a permit prior to commencing the operation, process or activity for which a permit is required shall be punishable by a penalty of no more than double the amount of the applicable permit fee (N.J.S.A. 5:70-2.12(b)7).

### § 230-28. Hiring of Police Officers; Fees.

The hiring of fire inspectors or firefighters shall not be allowed in place of the need for sworn police officers; decisions decision of the Fire Official/Fire Marshall will be required. Fees for police officers hired for actions consistent with fire standby duties shall be at their rate of pay and not the pay schedule for fire Inspector/fighters.

WHEREAS, there is no limit to the amount property owners and local businesses can be taxed as long as it can be justified as going towards improving stormwater management, however, 5 percent or \$50,000 of the revenue is required to be paid to the state and another 5 percent can be used for locality's general fund; and

**WHEREAS**, sewage authorities must adhere to a two-percent cap on annual increases to property owners and businesses, but stormwater utilities will not have to adhere to the cap; and

**WHEREAS**, municipalities and counties already have stormwater systems in place that manage stormwater without the need of creating another level of bureaucracy; and

**WHEREAS**, New Jersey property taxpayers already pay the highest taxes in the nation, and the creation of any new tax is an impossible burden to put on their backs; and

**WHEREAS**, New Jersey's Business Tax Climate was named last in the nation by the nonpartisan Tax Foundation, and any new taxes to our business owners are not feasible; and

WHEREAS, municipalities and counties should come together and signal to their tax-paying residents and businesses that they're aware that New Jersey's tax burden is already too high by making their intentions known through this resolution; and

Mr. Miller agreed that we do need to do something, however, we need to address the drainage issue first. We can fill some pot hole areas in the meantime.

<u>Councilwoman Faustini</u> – the first Tiger Sharks sign-up is this evening and will be again this Saturday. The swim team will be at Oak Crest in Edison. The Senior Center will be running a Stroke Awareness Session on May 22<sup>nd</sup> at 11:15 a.m.

<u>Councilman Bengivenga</u> – thanked the council for their support this evening with Resolution 19-169 that opposes a rain tax placed upon our residents and businesses.

Councilman Dean – asked the status for the road repair of Susan Terrace with the Gas Company. Mr. Miller said we're working on it and will be sitting down with them to coordinate it soon. Councilman Dean asked the status of the free plantings and chain-link fence. Mr. Miller said he has quotes for the tree plantings but needs to clarify one thing and is still working on getting the fence prices. Councilman Dean asked if we will be fixing the low-lying area on St. Nicholas Avenue. Mr. Miller said the drains are working. At one time they had a blockage that we cleared out. We are still monitoring it. Councilman Dean thanked all who participated in Saturdays Clean-Up Day. We did a tremendous job and picked up a lot of trash. The Touch a Truck event will be July 13<sup>th</sup> at 10 a.m. which will be a salute to our Military at Veteran's Park. Proceeds will go toward the Wounded Warrior Project. To conclude Councilman Dean said that the Lions Club held free eye exams at all schools.

<u>Councilman White</u> – provided an update the Chic Filet is still progressing and moving forward with their plans of coming to South Plainfield.

Council President Wolak reported progress.

<u>Mayor Anesh</u> – said it was brought to his attention a concern about some who use Willow Park as a hang-out and was wondering if that can be addressed. Councilwoman Faustini said they are working on a Code of Conduct for that park and placing signage accordingly. This Saturday, May 11th is the Letter Carrier Food Drive.

Mayor Anesh opened the floor for public comment.

Debra Boyle of Van Fleet mentioned posting plaques at Borough Hall for veterans and then went on to report on various events and dates around town in the coming months.
