ORDINANCE NO. 2138 AN ORDINANCE AMENDING CHAPTER 230. FIRE PREVENTION.

WHEREAS, the Borough Fire Prevention Official/Marshall has requested revisions to Chapter 230 of the Code of the Borough of South Plainfield; and

WHEREAS, the Public Safety Committee has reviewed such request and has approved same;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 230, Fire Prevention be amended as follows:

All referenced sections shall be deleted as existing and shall be replaced with the language provided herein.

§ 230-2: Agency Designation.

The local enforcing agency shall be the Office of the Fire Marshall/Bureau of Fire Prevention.

§ 230-4: Life Hazard and Local Uses.

The local enforcing agency established by Section 230-2 of this Article shall carry out the periodic inspections of life hazard and local uses required by the Uniform Fire Code on behalf of the Commissioner of the Department of Community Affairs.

§ 230-5: Organization.

The local enforcement agency established by Section 230-2 of this Article shall be under the control of the Fire Official/Fire Marshall and shall report to the Mayor and Council.

§ 230-21. Events Requiring Permits.

When Fire Official/Fire Marshall determines that an on-site fire inspector or fire-fighting personnel or equipment are required for fire watch as a result of any of the following listed below, the owner of occupant responsible shall obtain a permit for the use or event.

- A. Fire protection system failures and/or deficiencies, including both suppression and detection systems required by the NJ International Fire and Building Codes.
- B. Emergency warning and fire detection systems required by the NJ International Fire and Building Codes.
- C. Fire safety at any occupancy or event within the Borough of South Plainfield to ensure the safety of the public or emergency responders or any other event in which a crown of potentially 500 persons or more is to assemble.
- D. Standby coverage at fire investigation scenes. (Specific to firefighters only.)

§ 230-22. Required Personnel; Hours on Duty.

- A. The Fire Official/Fire Marshall shall determine the number of inspectors and/or fire fighting personnel required.
- B. The Fire Official/Fire Marshall shall determine the hours that the fire inspector(s) and/or fire-equipment and personnel will be on duty.

§ 230-24. Fees for Services.

- A. Compensation for inspector(s) for non-working hours for "for profit" groups or entities will be at \$54.00 per hour with \$2.00 per hour being directed to the Borough. For such hours for not for profit groups or entities, compensation shall be \$40.50 per hour with \$2.00 directed to the Borough.
- B. Compensation for all certified firefighters (firefighter 1) required by the Fire Official/ Fire Marshall as part of a standby shall be \$27.00 per hour with \$2.00 per hour directed to the Borough. Firefighters will be compensated \$25.00 per hour.
- C. The rate for use of vehicles shall be as follows when requested under orders from the Bureau of Fire Prevention. All fees for apparatus will be placed in the care of the Borough of South Plainfield.
 - (1) Engine: \$50.00 per hour
 - (2) Truck: \$100.00 per hour
 - (3) Rescue: \$50.00 per hour
 - (4) All others: \$25.00 per hour

§ 230-25. Right of Access.

The Fire Official/Fire Marshall or their designee(s) shall have right of access to the premises and areas surrounding it without interference from the property owner.

§ 230-26. Permit Fees; Penalties for Failure to Secure Permit.

Failure to secure a permit prior to commencing the operation, process or activity for which a permit is required shall be punishable by a penalty of no more than double the amount of the applicable permit fee (N.J.S.A. 5:70-2.12(b)7).

§ 230-28. Hiring of Police Officers; Fees.

The hiring of fire inspectors or firefighters shall not be allowed in place of the need for sworn police officers; decisions decision of the Fire Official/Fire Marshall will be required. Fees for police officers hired for actions consistent with fire standby duties shall be at their rate of pay and not the pay schedule for fire Inspector/fighters.

WHEREAS, a request has been made from local businesses along Kennedy Road to allow parking on Kennedy Road; and

WHEREAS, the Traffic Safety Officer has determined that the road can accommodate parking of passenger vehicles on one side without hindering truck traffic, and the request has been approved by the Traffic Safety Advisory Committee;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 187, titled Vehicles and Traffic, Article II, Parking, Stopping and Standing, Section 187-10 titled No Parking Certain Sections of Roadway, shall be amended to delete Section 187-10(A)(22) and replace with new Section 187-10(A)(22) as follows:

Kennedy Road:

a. West side, entire length, with the following exception, 15-minute parking allowed, west side of Kennedy Road between Montrose Avenue and St. Nicholas Avenue;

- b. East side, from St. Nicholas Avenue to Montrose Avenue;
- c. East side, 50 feet north of Montrose Avenue and 50 feet south of Yednak Drive.

BOND ORDINANCE REAPPROPRIATING \$65,000, INCLUDING \$62,500 OF PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES AND \$2,500 FROM THE CAPITAL IMRPOVEMENT FUND, IN ORDER TO PROVIDE FOR THE ACQUISITION OF A MASON DUMP TRUCK IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. It is hereby determined that \$62,500 of the proceeds of obligations, pursuant to N.J.S.A. 40A:2-39, originally made available pursuant to the following sections of the bond ordinances of the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") are no longer necessary for the various purposes for which the obligations previously were authorized as {A0961100.1}

described below. No money has been spent under Sections 3(e) and 3(f) of Bond Ordinance #2072 and, as a result, the \$2,500 appropriated from the Capital Improvement Fund for the purposes described below in Sections 3(e) and (3f) of Bond Ordinance #2072 is also being reappropriated as provided for herein:

The \$62,500 proceeds described in Section 1 and made available pursuant to N.J.S.A. 40A:2-39 and the \$2,500 from the Capital Improvement Fund are hereby reappropriated to provide for the acquisition of a mason dump truck, including all related costs and expenditures incidental thereto.

Section 3. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

RESOLUTION 2019-178

Authorizing the Public Hearing of the 2019 Municipal Budget

This is not a vote on the budget. Only a public hearing for the budget.

Budget consideration for adoption will take place on June 3, 2019.

Mayor Anesh turned the floor over to Mr. Cullen who advised that due to an amendment to the budget there will not be a vote on the adoption of the 2019 budget this evening. There have been some adjustments since meeting with all the department heads. There has not been any real significant change from where we were with the budget introduction, however, it was change enough to require an amendment to the budget with a second public hearing to be held June 3rd. At introduction the budget was almost \$31,965,000.00 of that, taxes were comprised of \$21,204,000.00 which made for an increase from 2018 of \$59.75 per household. The Library Tax is broken out which is up by \$55,774.00 which is based upon a state formula which is \$4.78 per household. The Borough's ratable base is up approximately \$13 million. That has resulted in \$183,000 in additional revenue which is the fourth consecutive year that the ratable base is up, and we do anticipate an increase in the ratable base for 2019 as well. Salaries are up by 2.2% which is primarily due to the hiring of school resource officers. The main reasons for the increase in the tax base is due to an increase in paying down our debt service, health insurance, the hiring of the school resource officers, and refurbishments to the pool. Since introduction, 18 different line items have been adjusted, the largest being with the pool. The largest decrease was in health benefits for \$24,000. The amended budget now shows municipal taxes down about \$15,000. The average home will experience a \$58.58 increase. A body armor grant was added to the budget after introduction. We are essentially down one dollar per average household from introduction.

Councilman Dean asked if the amendment reflects an increase or a decrease. Mr. Cullen said the overall taxes are decreasing by \$15,000, and \$10,000 decrease is in expenses. There were many ups and downs since the introduction.

Councilman Bengivenga thanked all the Department Heads for their contributions during the budget hearings and went on to thank Councilwoman Faustini and Dean who have helped support putting money in place to move forward with the pool project.

Mayor Anesh reminded everyone that all the budget documents are on the Borough's website. Mayor Anesh went on to set the budget adoption date and budget amendment public hearing for June 3, 2019.

Councilman Vesce inquired about the state reviewing the proposed amendment. Mr. Cullen said that this year we are self-review. Mr. Cullen explained the three categories of criteria if the adjustments were at certain levels it would in fact require the state to review said adjustment.

With no further questions or comments from the Borough Council, Mayor Anesh opened the floor for public comment on the 2019 municipal budget. With no comments from the public, Mayor Anesh closed the floor.

Borough Attorney Mickey Marcus Esq. - reported progress.

Administrator Cullen - reported progress

Engineer Miller – Hadley Road is scheduled to be paved tomorrow evening. Blackrock on Wednesday will be working road repairs for Laurel Lane, Ford and Geary Drives. We are currently out to bid for South 9th Street and hope to award said bid at the June 3rd meeting.

<u>Clerk Antonides</u> - reported progress.

Councilman Vesce – reported progress.

<u>Councilwoman Faustini</u> – We've had a tremendous response with the Tiger Sharks registration sign-up. We're very happy we can keep that program going this Summer. Councilwoman Faustini announced that the Library has now transitioned to a LMXAC automated system. This new system opened up 31 new catalogs for our library card holders.

<u>Councilman Bengivenga</u> – thanked all the vet's who gave the ultimate sacrifice to serve this country and reminded everyone that Memorial Day services will be on Monday. Councilman Bengivenga concluded by wishing Councilman Vesce a very happy birthday.

<u>Councilman Dean –</u> thanked the Mayor and Council for their support this evening with resolution 19-183. Councilman Dean went on to report that we all had a great time at the car show over the weekend, however, he noticed a lot of debris in the roadway and suggested that whenever we have these events in the downtown area to please have the street sweeper clean the area up prior to the event. Also, on the same note, Councilman Dean noticed debris for a long time around the OEM building area. Mr. Miller said he will take care of it.

Councilman White - thanked the Mayor and Council for their support of tonight's mental health proclamation.

Council President Wolak was absent this evening.

Mayor Anesh - reported progress.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Suzanne Lepore of Bullard Place thanked the governing body for the additional landscape at the dog park. It will be nice to have it for the Cultural Arts dog contest.

Sandy Doyon of Elizabethtown Court asked when the job for a new Recreation Director will be posted. Mr. Cullen explained that we are waiting for Dan Mason to finish authoring the job description and believes it will be posted by the end of this week. Will there be any qualification changes? Mr. Cullen said it will be similar qualifications. Ms. Doyon asked if there has been any internal investigation as to why there was such a breakdown with missing money in the Recreation Department. Mayor Anesh said there is an ongoing police investigation. Ms. Doyon said she is not speaking in terms of the police but internally. Mayor Anesh said it is all still a part of an official investigation at this time by the police, though we have already been putting new practices in place and confirmed that safe guards are going to be put in place. Councilwoman Faustini said some changes have already been put in place such as a new credit card system. Ms. Doyon said she feels the public really needs to know why no one is addressing this and it seems to be going by the wayside. If feels like no one cares and it is a big deal relatively speaking regarding missing money and how much. The town deserves to know about this theft. Mayor Anesh said any amount no matter the size of the town is relevant. Mayor Anesh said a \$1.00 theft would be too much. Ms. Doyon said that someone needs to say that we are looking at this and try to make sure it never happens again and it's not just falling by the wayside.

Debra Boyle of Van Fleet asked if she can have a copy of the mental health proclamation from this evening as it would be beneficial for the schools. Mayor Anesh said yes and then Ms. Boyle went on to report on various events and dates around town in the coming months.

Mike Zushma of 109 Suzanne Terrace said the Lion's Club recent eye screening at the grammar schools was a big success.

Ms. Jen Stockel of Delmore Avenue inquired about the status of the community pool. Councilwoman Fausinti explained that it is progressing and Mr. Cullen explained what is forthcoming in this regard.

Nancy Grennier thanked the Governing Body for coming out to the Junior Journalist event.

Mr. Jeff Seider inquired about the amended budget as discussed, this evening. Mr. Cullen reviewed the points he made earlier. Mr. Sider asked if the school resource officers are part of shared services. Mr. Cullen said yes. Mr. Seider said he doesn't feel this cost should be coming out of the municipal budget at all but feels the school board doesn't have good budget practices. Mr. Seider asked if the broom operator is out on a daily basis. Mr. Miller said that is the plan, however other things like emergencies that come up can prevent that from occurring. Mr. Seider said Pershing Place and O'Donohue have not been broom swept. Mr. Seider said he feels we should have a full-time dedicated broom operator and went on to mention all his storm sewer drain concerns around town. Mr. Miller said to keep in mind we have over 3,000 storm drains. Councilman Dean said that he supports Mr. Miller if he deems we need to hire more qualified guys to do the job. Mr. Seider asked the status of fixing up the recycling center. Mr. Miller explained. Councilman Dean said our center of town really begins at the Middle School and we need to remember that area is all part of the down town area and we need to be mindful of keeping it clean.

A resident came forward and thanked the governing body for the mental health proclamation this evening expressing the importance of mental health awareness and the stigma surrounding it. His good friend died of it not that long ago.

With no further comments from the public, Mayor Anesh closed the floor.

Without further comment and no more action necessary for this evening Mayor Anesh called for a motion to adjourn. Councilman White made a motion to adjourn at 8:14 p.m., seconded by Councilman Bengivenga and unanimously carried. The meeting was adjourned.
