COUNCIL REPORTS:

Borough Attorney Paul Rizzo – reported progress.

<u>Administrator Cullen</u> – advised that the tax bill grace period has been extended to August 23rd. The sewer bills our going out now. Mr. Cullen congratulated the Senior Center on their new BINGO machine and also congratulated Captain Koep on his retirement.
