RESOLUTION 2019-298

RESOLUTION AUTHORIZING SETTLEMENT OF 2018 and 2019 TAX APPEALS FILED BY 140 SOUTH PLAINFIELD LLC, FOR THE PROPERTY KNOWN AS 140 SOUTH PLAINFIELD AVENUE AND IDENTIFIED AS BLOCK 249, LOT 25, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

WHEREAS, 140 South Plainfield LLC (hereinafter referred to as "Taxpayer") is the owner of the property known as 140 South Plainfield Avenue and identified as Block 249, Lot 25, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$1,622,200 for the years under appeal; and

WHEREAS, Taxpayer filed appeals of its 2018 and 2019 tax assessments in the Tax Court of the State of New Jersey under docket numbers 005224-208 and 002442-2019; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessment for the tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for the tax years under appeal; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2018 total tax assessment shall be affirmed and remain unchanged;
- The 2019 original assessment in the amount of \$1,622,200 shall be reduced to \$1,422,200 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2019;
- The parties agree that the provisions of <u>N.J.S.A.</u> 54:51A-8 (Freeze Act) shall apply to the assessment for tax year 2020;
- The Borough agrees to withdraw its Counterclaim filed in the 2019 tax appeal;
- Taxpayer has agreed to waive statutory interest provided that the tax refund is made payable to "Jennifer R. Jacobus, Esq., Attorney for 140 South Plainfield LLC" and forwarded to counsel for Taxpayer within 60 days of the date of Judgment.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

WHEREAS, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reduction to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 1. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$1,422,200 total tax assessment for the 2019 tax year for Block 249, Lot 25 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 2. The Borough Attorney is authorized to execute on behalf of the Borough of South Plainfield the attached Stipulation of Settlement pertaining to the tax appeals filed by 140 South Plainfield LLC under Docket Nos.: 005224-2018 and 002442-2019 for the property known as 140 South Plainfield Avenue and identified as Block 249, Lot 25 on the Borough of South Plainfield Tax Assessment Maps which affirms the 2018 total tax assessment; which reduces the 2019 total tax assessment on the Property from \$1,622,200 to \$1,422,200; which provides that the provisions of N.J.S.A. 54:51A-8 (Freeze Act) shall apply to the assessment for tax year 2020; which provides that the Taxpayer has agreed to waive statutory interest provided the refund is received within 60 days of the Judgment; which provides that any tax refunds resulting from the settlement shall be made payable to "Jennifer R. Jacobus, Esq., Attorney for 140 South Plainfield LLC" and forwarded to counsel for Taxpayer within 60 days of the date of Judgment and which further provides that the Borough's Counterclaim filed in the 2019 tax appeal shall be withdrawn.
- 3. This settlement shall be without prejudice to the Borough's dealings with any other taxpayer's request or appeal for a tax assessment reduction.

COUNCIL REPORTS:

Borough Attorney Paul Rizzo - reported progress.

<u>Administrator Cullen</u> – provided a brief status on the community pool refurbishment saying that we should begin to see work at the site this Thursday. On another note, for the fifth year in a row we should see an increase in our ratable base and by the end of this year it should prove to be the highest ever.

<u>Engineer Miller</u> – the contractor is presently working on South 9^{th} Street with concrete work and we expect him to mill and pave soon after. The road resurfacing and sewer bid opening is scheduled for Friday, at 10:00 a.m.

<u>Clerk Antonides</u> - reported progress.

<u>Councilman Vesce</u> – advised that the county is just about finished with the paving on Park Avenue. Also, to answer Ms. Lepore's question from the last meeting regarding ADA ramps, according to county engineers, it is a federal regulation that they must install them even if it leads just to a grassy area.

<u>Councilwoman Faustini</u> – the Fall recreation sports are all up and running. There is still some room in the field hockey program for sign-ups. The buddy ball program will begin next Monday and this time we will be doing kickball. Basketball sign-ups will be over the next few weeks. Councilwoman Faustini then went on to remind everyone that the children's events at the Library will be suspended until October 1^{st} .

<u>Councilman Bengivenga</u> – congratulated South Plainfield's Michael Price who won a prime-time Emmy award for outstanding program. Congratulations to him and his family.

<u>Councilman Dean</u> – reported that John Abbruzzese has been dealing with a lot of property issues pertaining to the spread and control of bamboo plants. Last week we discussed this issue with the Environmental Commission and also reviewed a rough draft ordinance pertaining to the control of bamboo. The Environmental Commission got a bit hung-up with a desire to add other invasive species to the ordinance. Right now, the main issue John is having is dealing with the bamboo itself because as it stands now, he can't do his job because he has nothing to fall back on regarding bamboo. Council President Wolak expressed his concern about such an ordinance being overly excessive and doesn't wish to penalize anyone. The difference is other invasive species that the Environmental Commission was talking about were ones that are growing in their natural habitat. This is not the natural habitat for bamboo, it would

have to be planted by someone. Councilman Dean asked Mr. Abbruzzese if he is having problems in the field dealing with other invasive species, he said no, it is strictly bamboo. There are a variety of species of bamboo, however, it is the running bamboo that is the problematic one. Everyone that was at the meeting agreed we should just stick to all bamboo to be safe opposed to just running bamboo. Mr. Cullen said we even have it growing into newly paved roads, so it really is a concern. Councilman Dean said we have a resident on Worth Drive who can't let their kids play in the yard because it is riddled with bamboo rockets taking over his entire backyard from what is believed to have stemmed from his neighbor's yard. Mayor Anesh said the problem is you can't control it. Councilman White said once it gets planted in the ground it will overrun everything and cutting it back is not enough. Mayor Anesh asked Councilman Dean if Alice is in agreement to ban all bamboo. Councilman Dean said yes. Council President Wolak said he is not in favor of prohibiting bamboo in people's vards as it seems too excessive. Councilman Bengivenga said the problem particularly with running bamboo is that it gets out of control the concern that he has is with the enforcement aspect of it. For example, what if his neighbor planted bamboo and then sold his home to a new owner, and now the new owner is the one penalized. Councilman Dean agreed. Further brief discussion ensued regarding the issues with enforcement and penalties. Glenn said we have a problem with bamboo on Audubon Avenue and if that bamboo were to go into residential property is the Borough now responsible? Councilman Bengivenga and Dean provided examples of bamboo cracking sidewalks and puncturing pool liners. Discussion further ensued regarding how one would determine where the bamboo originated from. Mayor Anesh pointed out that right now there is nothing in place for John Abbruzzese to enforce. There does appear to be some legalities that need to be answered. At this point more work needs to be done before we consider an ordinance and the Council Committee and Environmental Commission should meet to discuss this further.

Councilman Dean went on to mention an email from Christine Laney on Fred Allen Drive who is a little upset that no one reached out to her. She is complaining about the roadway. Councilman Dean asked Mr. Miller if the DPW ever sprayed the road there. Mr. Miller said no. Councilman Dean asked if Mr. Miller can take a look at it as there appears to be a lot of grass and weeds breaking through. Ms. Laney said the last time she thinks her road was resurfaced was in 1998-99. Mr. Miller said he will look at it but is concerned that this isn't the only road that has weeds growing through it.

Councilman White - reported progress.

Council President Wolak - reported progress.

Mayor Anesh - reminded everyone about the upcoming Mayor's Health Fair on October 19, 2019 and went on to report progress.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Suzanne Lepore of Bullard Place thanked Councilman Vesce for his follow-up pertaining to the ADA ramps. Ms. Lepore went on to advise of Cultural Arts related events that are forthcoming. The 1st annual scarecrow festival will be hosted, and 20 groups are being sought to design their own scarecrow to be displayed in front of Borough Hall. Interested parties can refer to Event Bright.

Debbie Boyle of Van Fleet reported on various events and dates forthcoming throughout the Borough.

Mr. Cullen noted the recent passing of Dick Patrone saying he will be well missed. He provided the Borough with many years of service.

With no further comments from the public, Mayor Anesh closed the floor at 7:36 p.m. and announced that we are going into a closed session meeting and everyone is welcome to stay if they wish.

ADJOURNMENT

Without further comment and no more action necessary for this evening Mayor Anesh called for a motion to adjourn. Council President Wolak made a motion to adjourn at 7:44 p.m., seconded by Councilman White and unanimously carried. The meeting was adjourned.
