ORDINANCE #2175

CALENDAR YEAR 2020 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET COST OF LIVING ALLOWANCE AND TO ESTABLISH A CAP BANK PURSUANT TO N.J.S.A. 40A:4-45.14

WHEREAS, the Local Government Cap Law, N.J.S. A. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference

between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of South Plainfield find it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of its citizens; and.

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$862,510.25 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of South Plainfield, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2020 budget year, the final appropriations of the Borough of South Plainfield shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$862,510.25 and that the 2020 municipal budget for the Borough of South Plainfield be approved and adopted in accordance with this ordinance; and.

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

COUNCIL REPORTS:

Borough Attorney Paul Rizzo - reported progress.

Administrator Cullen – pointed out that resolution 20-177 executes an interlocal service agreement with the County that pertains to COVID-19 relief as the state has given Middlesex County some \$143 million to delegate out within the County. Mr. Cullen said that he will be meeting with the county soon regarding this agreement. We have requested \$200,000 in funding relief. Unfortunately, this relief does not cover losses in revenue. Mr. Cullen advised that last week he submitted a survey to the County regarding the status of our fiscal COVID-19 expenditures. Mr. Cullen said that this borough had taken a large loss in revenue. Mr. Cullen said we are looking forward to meeting with the County and any reimbursement that we can get is welcome, but we will still have a shortfall to makeup for.

<u>Engineer Miller</u> – reported that the road projects are underway, and the contractor is working on the milling and paving with a punch list to follow. The road project for St. Nicholas has a bid opening for this Thursday morning which will be funded by a NJ DOT grant. We are also in the process of making a new application to the NJ DOT for the 2021-year road improvements.

<u>Clerk Antonides</u> – reported progress.

Councilman Wolak - reported progress

<u>Councilman White</u> – advised that Charlie's Philly Steaks are now open for take out and delivery service. Also, the state has released it's second round of funds for NJ Economic Development.

<u>Councilman Smith</u> – reported progress.

Council President Faustini – reported progress.

Mayor Anesh – advised that this Borough has had a total of 500 positive COVID-19 cases, however, the numbers are coming down. The Governor issued today a new Executive Order that will allow for outdoor dining and non-essential businesses to open beginning June 15th with some restrictions in place, and Salons and Barbers can also open June 22nd with some restrictions in place. Gyms will soon follow. Mayor Anesh commended all Borough employees who have been working hard getting things done. Residents for the most part can get what they need. Mayor Anesh said that with the recent George Floyd situation that's on everyone's minds he just asks everyone to keep it civil and peaceful. Mayor Anesh concluded by thanking residents for how they've been handling everything they've been through in recent months so well.

Debbie Boyle of Van Fleet mentioned the availability of all kinds of different grants being available and hopes that the federal government will come through.
