RESOLUTION 20-287 STANDARD PROCEDURES AND REQUIREMENTS FOR EMERGENCY REMOTE MEETINGS.

WHEREAS, the State of New Jersey, Department of Community Affairs, has established regulations set forth in N.J.A.C. 5:39-1.1 through 1.7 for the conduct of remote meetings during public health emergencies; and

WHEREAS, such regulations require adoption of a resolution establishing procedures and requirements for public participation in meetings held during public health emergencies;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Borough Council hereby adopts the following protocols, procedures and requirements for emergency remote meetings:

- 1. A "declared emergency" shall mean a public health emergency as defined in the Health Powers Act, N.J.S.A. 26:13-1, et seq., or a state of emergency declared to P.L. 1942, c. 251, or both, or a state of local disaster emergency which has been declared by the Governor and is in effect;
- 2. The Borough Council may hold a remote public meeting to conduct public business during a declared emergency if the emergency reasonably prevents the local public body from safely conducting public business at a physical location with members of the public present;
- 3. If, during a declared emergency, the Borough Council holds a physical meeting at a location where, pursuant to State/Federal guidelines meant to mitigate risk, capacity restrictions are required to reduce the number of individuals that can be present at a meeting, the Borough Council shall either:
- a. Hold the meeting at another location with adequate capacity for the reasonable expected attendance by the public; or
 - b. Hold the public meeting as both an in-person and remote public meeting;
- 4. A public meeting held solely in person without a remote access alternative provided shall not prohibit members of the public from attending in person;
- 5. Adequate notice of the remote public meeting shall also include, in addition to the Open Public Meetings Act requirements of N.J.S.A. 10:4-8, clear and concise instructions for accessing the remote public meeting, the means for making public comment and how to access any public documents on the Borough's website in the manner set forth at N.J.A.C. 5:39-1.5;
- 6. At the commencement of a remote public meeting, the Mayor, or person chairing the meeting in his or her absence, shall announce publically and shall cause to be entered into the minutes an accurate statement regarding adequate and electronic notice or an explanation of the reason or reasons such notice was not adequately provided as set forth in N.J.A.C. 5:39-1.5:

- 7. The electronic communications used for a remote public meeting shall have a function that allows the Mayor, or person chairing the meeting in his or her absence, to mute the audio of all members of the public, as well as allow members of the public to mute themselves, and the same shall be announced at the beginning of every remote public meeting;
- 8. The Borough Council shall allow members of the public to make public comment by audio or by audio and video. In advance of the remote public meeting, public comments may be submitted by electronic mail or in written letter form to the Borough Clerk by noon on the Wednesday preceding the meeting;
- 9. Public comments submitted through electronic mail or written letter before the remote public meeting will be read aloud and addressed during the remote public meeting in a manner audible to all meeting participants and the public listening;
- 10. Disruptive conduct at an in-person public meeting or remote public meeting includes sustained inappropriate behaviors, including, but not limited to, shouting, interruption and use of profanity. Any member of the public who continues to act in a disruptive manner at remote public meeting after receiving an initial warning may be muted while other members of the public are allowed to proceed with their questions or comments;
- 11. Remote public meetings shall be subject to the requirements of the Open Public Meetings Act, N.J.S.A. 10:4-1, et seq., and all other applicable ordinances, statutes and regulations.

RESOLUTION AUTHORIZING SETTLEMENT OF 2019 and 2020 TAX APPEALS FILED BY MEDI-PHYSICS FOR THE PROPERTY KNOWN AS 900 DURHAM AVENUE AND IDENTIFIED AS BLOCK 528 LOT 46.10, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

WHEREAS, Medi-Physics (hereinafter referred to as "Taxpayer") is the owner of the property known as 900 Durham Avenue and identified as Block 528, Lot 46.10 on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$2,625,500 for tax year 2019 and \$1,525,500 for tax year 2020; and WHEREAS, Taxpayer filed appeals of its 2019 and 2020 tax assessments in the Tax Court of the State of New Jersey under docket numbers 007200-2019 and 003287-2020; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulations of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, recommended the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market value for the Property which was over assessed for the years under appeal; and

WHEREAS, pursuant to the proposed Stipulations of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2019 original assessment in the amount of \$2,625,500 shall be reduced to \$1,575,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax refund for 2019;
- The 2020 original assessment in the amount of \$1,525,500 shall be affirmed and remain unchanged;
- Taxpayer has agreed to waive statutory interest provided the subject refund is paid within sixty (60) days from the date of the entry of Judgment;
- Any refunds regarding overpayment shall be made payable to "Medi-Physics and Garippa, Lotz & Giannuario, P.C., as attorney" and forward to Gregory S. Schaffer, Esq., c/o Garippa, Lotz & Giannuario, P.C., 66 Park Street, Montclair, New Jersey 07042 within 60 days from the date of the entry of Judgment; and
- Taxpayer agrees to waive the provisions of N.J.S.A. 54:51A-8 (Freeze Act).

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulations of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulations of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

WHEREAS, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reductions to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 1. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$1,575,000 total tax assessment for the 2019 tax year for Block 528, Lot 46.10 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.
- 2. The Borough Attorney is authorized to execute on behalf of the Borough of South Plainfield the attached Stipulations of Settlement pertaining to the tax appeals filed by Medi-Physics under Docket Nos.: 007200-2019 and 003287-2020 for the property known as 900 Durham Avenue and identified as Block 528, Lot 46.10 on the Borough of South Plainfield Tax Assessment Maps which reduces the 2019 total tax assessment on the Property from \$2,625,500 to \$1,575,000; which affirms the 2020 total tax assessment on the Property in the amount of \$1,525,500; which further provides that Taxpayer agrees to waive statutory interest on any refund or overpayment due provided the refund check is paid within sixty (60) days from the entry of Judgment; which further provides that any refunds shall be made payable to "Medi-Physics and Garippa, Lotz & Giannuario, P.C., as attorney" and forward to Gregory S.
