Proclamation - Bag-It Up NJ with presentation

A member of the audience quested what food vendors will replace food containers with. Dr. Alice Tempel said that will be up to the merchants to decide. Dr. Tempel passed out literature and reusable bags to those present. Mayor Anesh thanked everyone for their presentation saying it was very powerful and a copy of it will be posted on our Borough's website. Councilman Smith thanked everyone for all they did for this presentation this evening.

<u>Presentation</u> –Public Celebrations Luminary Donation to the SPVFD – Mayor Anesh invited members of the Public Celebration Committee and Fire Department forward. Council President Faustini and Councilman Wolak were also present. The Public Celebrations Committee presented the Fire Department with a donation check for \$3,366.50 that was raised as a result of the resent luminary event. The below ordinance 2221 was and read by title by Clerk Antonides on the first reading. Mayor Anesh set the public hearing for February 7, 2022.

WHEREAS, Mark and Dana Ettere have offered to donate Lot 5, Block 452 to the Borough; and

WHEREAS, the Tax Assessor of the Borough has given an opinion that Lot 5, Block 452 has a fair market value of \$100,000.00; and

WHEREAS, it is further deemed that it is in the public's best interests that said donation be accepted;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that the Borough of South Plainfield accept the donation of Lot 5, Block 452 from Mark and Dana Ettere, and the Borough Attorney is authorized to prepare any and all documents necessary to accept such title, and to obtain insurance of title; and the Mayor and Clerk are authorized to execute any and all documents necessary to accept such donation; and

BE IT FURTHER ORDAINED that the Borough Attorney or Borough Clerk are authorized to provide a letter to Mark and Dana Ettere advising that the donation will be accepted, and that the property being donated has a fair market value of \$100,000.00.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

RESOLUTION SUPPORTING GREATER PURPOSE LLC TO OPERATE A CLASS 2 CANNABIS MANUFACTURING FACILITY AT THE PROPERTY LOCATED AT BLOCK 446, LOT 4.01, AT THE LOCATION KNOWN AS 3602 KENNEDY ROAD, BOROUGH OF SOUTH PLAINFIELD, MIDDLESEX COUNTY, STATE OF NEW JERSEY UPON APPROVAL BY THE NEW JERSEY CANNABIS REGULATORY COMMISSION.

WHEREAS, pursuant to N.J.A.C. 17:30, the New Jersey Cannabis Regulatory Commission ("Commission") is responsible for accepting, reviewing, and making determinations on applications for personal use cannabis business licenses; and

WHEREAS, pursuant to N.J.A.C. 17:30-7.1, N.J.A.C. 17:30-7.8, and N.J.A.C. 17:30-7.10 Alternative Treatment Centers ("ATCs") and applicants for cannabis business licenses ("license-applicants") need to submit proof of local support in the form of municipal approval as part of either their certification (ATCs) or application (cannabis business license applicants) to the Commission; and

WHEREAS, the license-applicant Greater Purpose LLC (the "Applicant"), a limited liability company of the State of New Jersey received a zoning permit (permit no: 20210517.000), dated December 16, 2021, from the Borough of South Plainfield, authorizing the Applicant to seek all required permits and inspections by local and state officials to operate as a Class 2 Cannabis Manufacturer at the property located at block 446, lot 4.01, at the location known as 3602 Kennedy Road, Borough of South Plainfield, Plainfield, Middlesex County, State of New Jersey (the "Property"); and

WHEREAS, the Property is located in the M-3 zoning district; and

WHEREAS, in accordance with Chapter 540, Article VII, Zone District Regulations, Section 540-45(a)(6) of the ordinances of the Borough of South Plainfield, the Applicant's proposed use (Class 2 Licensed Cannabis Manufacturer) is a permitted use in the M-3 zoning district; and

WHEREAS, the above referenced ordinance permits up to two (2) Licensed Cannabis Manufacturers in the M-3 Industrial Zone (the "License Limit"); and

WHEREAS, at the time of adoption of this Resolution, the issuance of a license to the Applicant by the Commission would not exceed the License Limit referenced above; and

WHEREAS, the Borough of South Plainfield recognizes that the Applicant's proposed use provides an opportunity to enhance the Borough of South Plainfield's economy by providing jobs and additional revenue.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey as follows:

- 1. The Applicant is in compliance with the Borough of South Plainfield's local codes and ordinances.
- 2. Should the Applicant receive approval by the Commission <u>first in time</u>, the Greater Purpose LLC, a limited liability company of the State of New Jersey, shall be deemed approved by the Borough of South Plainfield until the License Limit, in accordance with Chapter 540, Article VII, Zone District Regulations, Section 540-45(a)(6) of the ordinances of the Borough of South Plainfield, is reached (emphasis added).
- 3. The Borough of South Plainfield shall issue written notice to the Applicant, to all other supported license applicants, and issue similar written notice to the Commission once the License Limit is reached.
- 4. The Applicant, if approved by the Commission and deemed approved by the Borough of South Plainfield, shall comply with Chapter 175, Cannabis Transfer Tax and User Tax, Section 175-1 of the ordinances of the Borough of South Plainfield.

BE IT FURTHER RESOLVED by the Mayor and Council of the Borough of South Plainfield that it hereby reserves the right to amend, terminate, or repeal this Resolution and/or any approvals/support granted herein to the Applicant at any point in time, if the License Limit is reached prior to approval by the Commission.

This Resolution shall take effect immediately.

COUNCIL REPORTS:

Borough Attorney Paul Rizzo – reported progress.

<u>Administrator Cullen</u> – advised that the sewer bills will be going out this Friday afternoon and everyone should be receiving them by next week. The sewer bills reflect the effects of Covid-19 in that more people are working from home using their own residential plumbing, opposed to commercial business which may have had shut-downs with less sewer usage.

Engineer Miller – reported progress.

Clerk Antonides - reported progress.

Councilman Smith – thanked the Environmental Commission and the South Plainfield High School students for all they do and went on to report progress.

Councilwoman Mott - reported progress.

Councilman Wolak - congratulated Joseph Temenski for his appointment this evening as a firefighter and went on to report progress.

<u>Councilman Bengivenga</u> – advised that we have been fortunate to have been able to keep the sewer bills flat until Covid hit, and as Mr. Cullen said, residents are using more sewer at home then before Covid. Councilman Bengivenga said that this will stabilize in the future and we continue to work hard to fix our infrastructure.

<u>Council President Faustini</u> – advised that the Pal has pickleball open hours Monday-Friday 10am to 12 pm for anyone interested. Registration is online. Stem programs are also available. On another note, Council President Faustini updated everyone on the proposed Covid Memorial at Putnam Park saying that we will begin the sale of bricks for those who lost a loved one during Covid. A brick memorial path will circle around a memorial stone. The Library will soon post their upcoming events for February. Council President Faustini concluded by wising everyone a happy Lunar New Year, noting it is the Year of the Tiger.

<u>Councilman White</u> – announced that the new Brazilian Ji Jitsu is now open in South Plainfield and those interested are welcome to stop by. Councilman White went on to report progress.

<u>Mayor Anesh</u> – advised that South Plainfield's new daily covid total is 24, with a grand total to date of 5,215 cases. The County's new daily total was 2,621, with a grand total to date of 165,814 cases. South Plainfield has 74 cumulative deaths, and the County has 2,395 cumulative deaths. Mayor Anesh said everyone in our building is back to wearing masks again and we continue our Covid-19 safety protocol throughout Borough Hall and residents are advised to make an appointment before visiting Borough Hall. Mayor Anesh concluded by saying we are tracking the reopening of the Senior Center, stay tuned for further updates.
