Review of Agenda Items: Clerk Antonides reviewed all the items on the agenda and removed the two affordable housing matters slated for executive session. Mayor Anesh asked the Council if they had any comments. There were no comments from Council. Mr. Cullen requested to have a special meeting on Monday, July 25th at 7:00 pm for the purpose of 1) adopt an ordinance authorizing compensation for seasonal special law enforcement officers, 2) introduce an ordinance for capital improvements to Willow Park, Monument Park and the Municipal Complex 3) to authorize an executive session pertaining to affordable housing, 4) to promote a Seargent for the Police Department, and 5) to authorize the payment of bills. The governing body was in agreement to schedule this special meeting accordingly.
