

**SOUTH PLAINFIELD BOROUGH
BOROUGH COUNCIL MEETING MINUTES
JULY 11, 2022, 7:00 P.M.
AGENDA MEETING**

***Due to the COVID-19 outbreak, this meeting was also transmitted virtually via the Webex platform**

CALL TO ORDER: Mayor Anesh called the meeting to order at 7:00 p.m. Mayor Anesh read the sunshine statement and announced that same is being held pursuant to the Open Public Meetings Act of 1974 and all provisions of that Act have been met with adequate notice of this remote hybrid meeting having been provided to the Borough's two official newspapers and also published on the Borough's website. Instructions for accessing the remote public meeting are found on the Borough's website next to the agendas. Documentation pertaining to the remote meeting can be found electronically on the Borough's website.

Review of Agenda Items: Clerk Antonides reviewed all the items on the agenda and removed the two affordable housing matters slated for executive session. Mayor Anesh asked the Council if they had any comments. There were no comments from Council. Mr. Cullen requested to have a special meeting on Monday, July 25th at 7:00 pm for the purpose of 1) adopt an ordinance authorizing compensation for seasonal special law enforcement officers, 2) introduce an ordinance for capital improvements to Willow Park, Monument Park and the Municipal Complex 3) to authorize an executive session pertaining to affordable housing, 4) to promote a Sergeant for the Police Department, and 5) to authorize the payment of bills. The governing body was in agreement to schedule this special meeting accordingly.
