PUBLIC HEARING: Release of a Performance Bond posted by Carrols LLC for public improvements to Block 56, Lot 1. Mayor Anesh asked Clerk Antonides if all is in order. Clerk Antonides said yes. Mayor Anesh asked if a representative for Carrols LLC was present, but there was none. Mayor Anesh then opened the floor for public comment pertaining to this block and lot. A member of the public named Kevin from 121 Sprague Avenue complained that lights are shining in his living room window from this Burger King establishment. Their original plans called for a landscaping buffer which was installed however the landscaping has not been maintained and died. The lights are now shinning in his windows. Ms. Silverstein of East Golf Avenue complained about parked idling trucks in the Burger King parking lot with fumes entering her house as a result, lovers lane in the parking lot, trash blowing into her yard, and issues with the lights. After a brief discussion, Mr. Miller said he will reach out to the engineer to contact the applicant to correct these matters. The release of the performance bond will be tabled until this matter is resolved.
