

ORDINANCE 2223

AN ORDINANCE AMENDING ORDINANCE 2150 THAT PROVIDES FOR THE COMPENSATION OF EMPLOYEES OF THE BOROUGH OF SOUTH PLAINFIELD AND THE METHOD OF PAYMENT OF SUCH COMPENSATION FOR AFSCME UNION EMPLOYEES

BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey, as follows:

This Ordinance shall be amended to indicate the revised salaries for the below two job classifications.

SECTION 1: The rates of compensation for each employee of the Boro of South Plainfield shall be on an annual basis as follows except where indicated. Such rates of pay shall be effective upon adoption of this ordinance:
