In the case of utility work which involves new or replacing, or repairing of existing utility infrastructure, such as gas lines, water lines, electrical lines, and sewer lines, where the area to be trenched is greater than 50 linear feet, upon completion or a reasonable amount of time as determined by the Borough Engineer, the permitee shall mill and repave the entire pavement surface from edge to edge, or curb to curb, for the full length of the excavation in accordance with the specifications of the Department of Public Works.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.
