# RESOLUTION 25-237 A RESOLUTION OF THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY ENDORSING THE FOURTH ROUND HOUSING ELEMENT AND FAIR SHARE PLAN AS ADOPTED BY THE PLANNING BOARD

WHEREAS, in accordance with the Amended FHA and the Administrative Office of the Court's Directive 14-24, the Borough of South Plainfield (the "Borough") filed a timely Fourth Round DJ Complaint with the Affordable Housing Dispute Resolution Program (the "Program"), along with its binding Resolution on January 23, 2025, accepting the Fourth Round Present and Prospective Need; and

**WHEREAS,** on February 27, 2025, in response to the DJ Complaint, New Jersey Builders Association filed an Answer/Objection of Interested Party challenging the Borough's modification of its "Prospective Need" Obligation; and

WHEREAS, the Program considered the challenge filed by New Jersey Builders Association and, after a settlement conference was conducted, the Superior Court, Law Division held that the "Present Need" Obligation is fixed at 54 affordable units and the "Prospective Need" Obligation is fixed at 206 affordable units for the Fourth Round Housing Cycle; and

WHEREAS, the entry of the Decision and Order Fixing Municipal Obligations for "Present Need" and "Prospective Need" for the Fourth Round Housing Cycle dated April 4, 2025 gave the Borough automatic, continued immunity from all exclusionary zoning lawsuits, including builder's remedy lawsuits, which is still in full force and effect; and

**WHEREAS,** in accordance with the Amended FHA, the Borough's affordable housing planner drafted a Fourth Round Housing Element and Fair Share Plan; and

**WHEREAS,** upon notice duly provided pursuant to N.J.S.A. 40:55D-13, the Planning Board held a public hearing on the Fourth Round Housing Element and Fair Share Plan on June 24, 2025 and adopted the 2025 Fourth Round Housing Element and Fair Share Plan on the same day; and

**WHEREAS,** a true copy of the Resolution of the Planning Board adopting the 2025 Fourth Round Housing Element and Fair Share Plan is attached hereto as Exhibit A; and

**WHEREAS**, the Borough Council of the Borough of South Plainfield wishes to endorse the 2025 Fourth Round Housing Element and Fair Share Plan and seeks a compliance certification of such plan from the Program;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that:

- 1. It hereby endorses the 2025 Fourth Round Housing Element and Fair Share Plan as adopted by the on June 24, 2025 via the Planning Board Resolution attached hereto as Exhibit A.
- 2. It authorizes and directs its Attorney to file with the Program (i) the 2025 Fourth Round Housing Element and Fair Share Plan; (ii) the Resolutions of the Planning Board adopting and the Borough Council endorsing

the 2025 Fourth Round Housing Element and Fair Share Plan; and (iii) any additional documents the professionals deem necessary or desirable.

3. It reserves the right to amend the 2025 Fourth Round Housing Element and Fair Share Plan should that be necessary.

WHEREAS, the Borough of South Plainfield has prepared a Fourth Round Housing Element and Fair Share Plan that addresses its regional fair share of the Affordable Housing need in accordance with the Municipal Land Use Law, N.J.S.A. 40:55D-1 to 171, and the Amended Fair Housing Act, N.J.S.A. 52-27D-301 to 329; and

**WHEREAS,** a Development Fee Ordinance was originally approved by the Council on Affordable Housing ("COAH") in 2008, and subsequently amended and approved by the Court in 2017; and

WHEREAS, the Development Fee Ordinance established an Affordable Housing Trust Fund which includes, but is not limited to development fees, payments from developers in lieu of construction of affordable housing units on-site, barrier free escrow funds, repayments from Affordable Housing Program loans, recapture funds, and proceeds from the sale of affordable housing units; and

WHEREAS, in accordance with the Amended Fair Housing Act, the Borough has prepared an updated Spending Plan (attached hereto as Exhibit A), which accounts for the collection and expenditure of all current and future Affordable Housing Trust Fund monies and will contribute to the development of affordable housing within the Borough; and

WHEREAS, the Affordable Housing Planner drafted a Fourth Round Housing Element and Fair Share Plan; and

**WHEREAS**, the Borough desires to submit its Spending Plan to the Affordable Housing Resolution Dispute Program for its review and approval;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that it adopts the Spending Plan attached hereto as Exhibit A.

- 2. That the Mayor is hereby authorized to execute, and the Borough Clerk to attest to an agreement with the firm of Piazza & Associates, Inc.;
- 3. That this contract is awarded as a Professional Service in accordance with N.J.S.A. 40A:11-5(1)(a)(I) of the Local Public Contracts Law as it is for services to be performed by persons authorized by law to practice a recognized profession;
- 4. That notice of this action shall be printed once in the official notice of the Borough of South Plainfield; and
  - 5. That this Resolution shall take effect immediately.
  - 6. That a certified copy of this Resolution shall be provided by the Borough Clerk to Piazza & Associates, Inc., Borough Administrator, Chief Financial Officer, and the Affordable Housing Attorney.
