Flag Salute: was led by Council President White and Council President White said the invocation.

Paul Rizzo Esq. swore in the Deputy OEM Coordinator. Everyone extended a round of applause and photos were taken by family, friends, and media present.

PRESENTATION: South Plainfield Women's Leadership Team – Essay Contest Award

Council President White called the Women's Leadership Team members forward, who presented first, second, and third place awards to the students for the annual essay contest. Debbie Boyle said a few words on behalf of the Women's Leadership Team. Everyone extended a round of applause and photographs were taken by family, friends and media present.

Council President White called for a brief recess at 7:13 p.m. Council President White called the meeting back to order at 7:16 p.m.

<u>Public Comment:</u> Council President White opened the floor for public comment. Council President White also awaited virtual hand raises and unmuted all microphones.

(Mayor Anesh arrived at 7:32 p.m. during the public comment session)

Debbie Boyle said this year the Mayor's Wellness Fair will have a new traveling health van at their Health Fair at Putnam Park then went on to express her support of Ordinance #2360 saying that it will be helpful with those volunteers who don't show up to meetings, or who cause chaos and lose control at meetings and feel this ordinance is a good thing to have in place.

Leon Aboosamara expressed his upset with the recent flooding from the storms, saying it's getting worse adding that sewer problems are occurring also and wants to know what the governing body plans to do going forward because we can't keep suffering like this. Mr. Aboosamara said he doesn't seem to ever receive an answer, other than have a street sweeper come to sweep his street. Mr. Miller explained that the EPA will begin this Fall by cleaning out the contamination then lowering and expanding the brook which will greatly help. They will put a barge in the New Market Pond starting at Vets Park to New Market Pond. Mr. Miller went on to explain that the sewer lines flow through PARSA lines and we have to work with them. Also, when we see that much rain fall in such a short amount of time, flooding is nearly unavoidable, and the sewer lines are going to back-up. Mr. Miller said it is possible to do a smoke test to see who has illegally hooked up their sump pump to the sanitary sewer, which is often one of the reasons for the sewers backing up.

A resident from Fred Allen Drive said he also experienced excessive flooding and sewage back-up from these storms and said we really need to get some help in this area, but feel like they are forgotten.

Karina Nagy said she was just here this past June with the same complaint and implored this governing body to make the infrastructure a priority for our community and our safety. Mr. Nagy interjected some comments from his seat in the audience regarding grants on the internet. Ms. Nagy concurred by saying she did see many state grants for flood improvements on the internet and that the council needs to make action happen.

Ms. Renet Roman said she is new to the neighborhood, likes her neighbors, and is upset that sewage is coming up during heavy rains and doesn't understand why this is happening. Councilman Bengivenga reiterated that it is most likely caused by the illegal sump pumps that residents are connecting into the sanitary sewer lines. Ms. Roman asked if DPW could have the street sweeper come and clean the street again. Mr. Miller said yes, he will do that.

Mr. Fabio Duarte (*Daughter Diane Nieves interpreted for him*) said he is concerned that whenever the train passes by, the breeze from it causes a terrible stench, of dead animals. Also the train horn is super loud and constant all night long. The taxes always go up, but never go down.

Mr. Felix Hernandez (*Neighbor Diane Nieves interpreted for him*) said this is the tenth time his house flooded. It's all the same problems that his other neighbors spoke of. He is concerned about his granddaughter playing outside that is now full of bacteria and hopes the Council can help.

ORDINANCE 2358 AN ORDINANCE AMENDING CHAPTER 84, POLICE DEPARTMENT, OF THE CODE OF THE BOROUGH OF SOUTH PLAINFIELD

BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 84, Police Department, of the Code of the Borough of South Plainfield be amended as follows:

DELETE: Article I, Establishment and Organization; Section 84-2(A), Department Personnel.

ADD: Article I, Establishment and Organization; Section 84-2(A), Department Personnel, as follows:

A. The Police Department of the Borough of South Plainfield shall consist of one Chief of Police; up to three Captains appointed as necessary; up to seven Lieutenants appointed as necessary; up to eight Sergeants appointed as necessary; up to 46 Police Officers appointed as necessary; and Special Law Enforcement Officers as budgeted, and such other staffing requirements and employees that shall, from time to time, be deemed necessary by the Mayor and Council to properly preserve peace and good order within the Borough of South Plainfield.

DELETE: Article I, Rules and Regulations, Section 84-4.

ADD: Article I, Rules and Regulations and Designation of Appropriate Authority as follows:

The Borough Clerk of the Borough of South Plainfield shall be designated as an Appropriate Authority as provided in New Jersey Statutes. The Appropriate Authority shall be responsible for the overall performance of the Police Department. The Appropriate Authority shall adopt and promulgate rules and regulations for the government of the Police Department and for the discipline of its members and employees. The Borough Administrator for the Borough of South Plainfield or their designee shall act as Hearing Officer in Police Department disciplinary proceedings.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

ORDINANCE 2360 AN ORDINANCE OF THE BOROUGH OF SOUTH PLAINFIELD AMENDING CHAPTER 17 TITLED BOARDS, COMMITTEES AND COMMISSIONS

BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 17 titled Boards, Committees and Commissions be amended to add the following:

Section 17-59, Removal

Any member of a board, committee or commission created and established in this Chapter shall be subject to removal by the Governing Body for inefficiency or misconduct.

Section 17-60, Grounds for Removal

Service as a member of a board, committee or commission is a privilege and a member does not have a right to any position on such board, committee or commission. A member may be removed from a position for any of the following reasons:

- A. Incompetency or inefficiency Demonstrably failing to perform duties as required.
- B. Insubordination Refusal to follow directions or instructions of Council members or appropriate Borough official(s).
 - C. Misconduct Acting in violation of municipal rules, regulations or professional standards.
- D. Lack of Civility Engaging in conduct constituting harassment of officials or other members; interference with the performance of duties by officials or other members; or attempting to exercise authority or control over any officials or other members which has not been vested in the member.
 - E. Criminal Activity Engaging in illegal activities, even if not resulting in conviction.
- F. Absenteeism Members are expected to attend meetings of their board, committee or commission. Absence from three consecutive meetings shall be deemed grounds for removal of the member from the board, committee or commission unless the member has provided in writing before the meeting the basis for the absence which has been accepted by the chairperson as an excused absence.
- G. Miscellaneous Engaging in any other activity which the Council, in its sole discretion, deems to be detrimental to the performance of the board, committee or commission.

Section 17-61, Procedure for Removal

The Council on its own initiative, or upon receipt of a signed written complaint alleging conduct of any member of a board, committee or commission alleged to have engaged in inefficient or inappropriate conduct as described herein shall determine the facts and circumstances and, if it finds sufficient grounds, shall notify the member of the nature of the complaint and the facts and circumstances set forth therein. The member shall have an opportunity to present the Council with any statement of information concerning the allegations. It shall be within the sole

discretion of the Council as to whether a hearing may be held. The Council shall render a decision as to whether the conduct of the member warrants removal from the board, committee or commission. The decision to remove shall require the vote by two thirds (2/3) of the members of the Council. Such decision shall be final.

Section 17-62, Vacancy

In the event a member has been found to have engaged in conduct warranting removal, such member shall be removed from the board, committee or commission by the Council which shall thereafter fill such position in accordance with the terms for filling a vacancy for such board, committee or commission.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

RESOLUTION AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION IN THE AMOUNT OF \$325,000 PURSUANT TO N.J.S.A. 40A:4-54 IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY AND AUTHORIZING THE ISSUANCE OF SPECIAL EMERGENCY NOTES TO FINANCE SUCH SPECIAL EMERGENCY APPROPRIATION PURSUANT TO N.J.S.A. 40A:4-55.

BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. A special emergency appropriation is hereby authorized pursuant to *N.J.S.A.* 40A:4-54, in the amount of \$325,000, to provide for the cost of extraordinary expense for the repair, reconstruction of streets, roads or bridges, or public property damaged by flood or hurricane. Such expense was not foreseen at the time of adoption of the calendar year 2025 municipal budget.

- (a) In order to finance the special emergency appropriation described in Section 1 of this resolution, the Borough is hereby authorized to borrow the sum of \$325,000 and to issue its special emergency notes therefor in accordance with *N.J.S.A.* 40A:4-55.
- (b) The special emergency notes authorized by this resolution may be issued in amounts and denominations not exceeding in the aggregate the amount of special emergency notes authorized herein, as determined by the chief financial officer of the Borough pursuant to this resolution.
- (c) The Borough may finance the special emergency appropriation from surplus funds available or may borrow money in a manner prescribed herein. Where an appropriation is financed from surplus funds available, at least one-fifth of the amount thereof shall be included in each annual budget until the appropriation has been fully provided for.

The following matters in connection with the special emergency notes are hereby determined:

- (a) All special emergency notes issued hereunder and any renewals thereof shall mature at such time as may be determined by the chief financial officer within the limitations of the Local Budget Law, provided however, that at least one-fifth of all such special emergency notes and the renewals thereof shall mature and be paid in each year so that all special emergency notes and renewals shall have matured and have been paid not later than the last day of the fifth year following the date of this resolution;
- (b) All special emergency notes issued hereunder shall bear interest at such rate or rates as may be determined by the chief financial officer;
- (c) The special emergency notes shall be in the form determined by the chief financial officer and the chief financial officer's signature upon the special emergency notes shall be conclusive as to such determination.

The chief financial officer is hereby authorized and directed to determine all matters in connection with the special emergency notes not determined by this or a subsequent resolution and the chief financial officer's signature upon the special emergency notes shall be conclusive as to such determination.

The chief financial officer is hereby authorized to sell the special emergency notes from time to time at public or private sale in such amounts as such officer may determine at not less than par and to deliver the same from time to time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof and payment therefor.

The special emergency notes issued pursuant to this resolution shall be a general obligation of the Borough. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on such special emergency notes and, unless otherwise paid or payment provided

for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.

The chief financial officer is authorized and directed to report in writing to this governing body at the meeting next succeeding the date when any sale or delivery of the special emergency notes pursuant to this resolution is made, such report to include the amount, description, interest rate and maturity of the special emergency notes sold, the price obtained and the name of the purchaser.

The Borough hereby makes the following covenants and declarations with respect to any special emergency notes to be issued by the Borough on a tax-exempt basis, as determined by the chief financial officer of the Borough in consultation with Bond Counsel. The Borough hereby covenants that it will comply with any conditions subsequent imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of interest on any such tax-exempt special emergency notes, including, if necessary, the requirement to rebate all net investment earnings on the gross proceeds above the yield on any such tax-exempt special emergency notes. The chief financial officer is hereby authorized to act on behalf of the Borough to deem any such tax-exempt special emergency notes authorized herein as bank-qualified for the purposes of Section 265 of the Code, when appropriate.

The Borough hereby declares the intent of the Borough to issue special emergency notes in the amount authorized in Section 2(a) of this resolution and to use the proceeds to pay or reimburse expenditures for the costs of the purpose described herein. This Section 9 is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.

Solely for purposes of complying with Rule 15c2-12 of the Securities and Exchange Commission, as amended and interpreted from time to time (the "Rule"), and provided that the special emergency notes are not exempt from the Rule and provided that the special emergency notes are not exempt from the following requirements in accordance with paragraph (d) of the Rule, for so long as the special emergency notes remain outstanding (unless the special emergency notes and any renewals thereof have been wholly defeased), the Borough shall provide electronically to the Municipal Securities Rulemaking Board's Electronic Municipal Market Access system or such other repository designated by the Securities and Exchange Commission to be an authorized repository for filing secondary market disclosure information, if any, for the benefit of the holders of the special emergency notes and the beneficial owners thereof, in a timely notice not in excess of ten business days after the occurrence of the event, notice of any of the following events with respect to the special emergency notes:

- (1) Principal and interest payment delinquencies;
- (2) Non-payment related defaults, if material;
- (3) Unscheduled draws on debt service reserves reflecting financial difficulties;

- (4) Unscheduled draws on credit enhancements reflecting financial difficulties;
- (5) Substitution of credit or liquidity providers or their failure to perform;
- (6) Adverse tax opinions, the issuance by the Internal Revenue Service of proposed or final determinations of taxability, Notices of Proposed Issue (IRS Form 5701-TEB) or other material notices or determinations with respect to the tax status of the special emergency notes, or other material events affecting the tax status of the special emergency notes;
- (7) Modifications to the rights of holders of the special emergency notes, if material;
- (8) Special emergency note calls, if material, and tender offers;
- (9) Defeasances;
- (10) Release, substitution or sale of property securing repayment of the special emergency notes, if material;
- (11) Rating changes;
- (12) Bankruptcy, insolvency, receivership or similar event of the Borough;
- (13) The consummation of a merger, consolidation or acquisition involving the Borough or the sale of all or substantially all of the assets of the Borough, other than in the ordinary course of business, the entry into a definitive agreement to undertake such an action or the termination of a definitive agreement relating to any such actions, other than pursuant to its terms, if material;
- (14) Appointment of a successor or additional trustee or the change of name of a trustee, if material;
- (15) Incurrence of a Financial Obligation of the Borough, if material, or agreement to covenants, events of default, remedies, priority rights or other similar terms of a Financial Obligation of the Borough, any of which affect holders of the special emergency notes, if material; and
- (16) Default, event of acceleration, termination event, modification of terms or other similar event under a Financial Obligation of the Borough, if any such event reflects financial difficulties.

The term "Financial Obligation" as used in subparagraphs (15) and (16) above means a (i) debt obligation, (ii) derivative instrument entered into in connection with, or pledged as security or a source of payment for, an existing or planned debt obligation or (iii) guarantee of (i) or (ii); provided, however, that the term "Financial Obligation" shall not include municipal securities as to which a final official statement has been provided to the Municipal Securities Rulemaking Board consistent with the Rule.

If all or any part of the Rule ceases to be in effect for any reason, then the information required to be provided under this resolution, insofar as the provision of the Rule no longer in effect required the provision of such information, shall no longer be required to be provided.

The chief financial officer shall determine, in consultation with McManimon, Scotland & Baumann, LLC ("Bond Counsel"), the application of the Rule or the exemption from the Rule for each issue of special emergency notes prior to their offering. Such chief financial officer is hereby authorized to enter into written contracts or undertaking to implement this resolution and is further authorized to amend such contracts or undertakings as needed to comply with the Rule or upon the advice of Bond Counsel.

In the event that the Borough fails to comply with this resolution or the written contract or undertaking, the Borough shall not be liable for monetary damages, remedy of the holders or beneficial owners of the special emergency notes being hereby specifically limited to specific performance of the covenants contained in this resolution or the written contract or undertaking.
