Flag Salute: was led by Mayor Anesh and Councilman Smith said the invocation.

Mayor Anesh reviewed some basic rules for conducting the hybrid virtual meeting this evening. All lines will be muted until such time that the floor is open for public comment. Mr. Rizzo Esq. said he did look into our sound ordinance and found that we did model ours after the DEP's recommendation. There is not much we can change. Chief Papa said that sound reading machines are complicated and don't always hold up in court. Chief Papa took her information and will look into the matter.

Section 1. The aforementioned assets be funded by the following sources:

Capital Improvement Fund \$45,000.00

Totals <u>\$45,000.00</u>

- Section 2. That the improvements described in Section 1 hereof shall be authorized as Capital Improvements for the Borough of South Plainfield in the County of Middlesex, New Jersey.
- Section 3. It is hereby determined and declared by this Mayor and Borough Council as follows:
 - A. That the maximum estimated amount of money to be raised from all sources for the purposes stated in Section 1, hereof, is \$45,000.00. Improvements shall include, but not be limited to, resurfacing of walkways, pavers and monuments/statutes.

- B. That the cost for the improvements totaling \$45,000.00 shall be paid from the Capital Improvement Fund.
- C. The estimated useful life of said improvements is hereby determined to be seven (7) years.
- Section 4. That the total amount of the appropriation to be expended for Architectural and inspection costs, legal costs, advertisement of ordinance and other expenses as provided in Section 48:2-20 of the Revised Statutes, is not to exceed \$10,000.00.
- Section 5. This ordinance shall take effect after final passage and publication in accordance with the law.

The following ordinance #2371 was read by Clerk Antonides by title for a second reading. Councilwoman Mott asked to amend Section 163-4 by adding "Class III" to that section. Mr. Rizzo Esq. said the suggested amended is very minor in nature and can be adopted tonight as amended.

ORDINANCE 2371 AN ORDINANCE AMENDING CHAPTER 163, ARTICLE I, TITLED LOW SPEED ELECTRIC VEHICLES, OF THE CODE OF THE BOROUGH OF SOUTH PLAINFIELD

BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 163, Article I, titled Motorized Bicycles be deleted and replaced as follows:

Article I, Low Speed and Motorized Electric Vehicles.

Section 163-1 - Definitions.

As used in this Article, the following terms shall have the meanings indicated:

Low Speed Electric Vehicles - a two- or three-wheeled vehicle with fully operable pedals and an electric motor of less than 750 watts that meets the requirements of one of the following classifications:

"Class One Low Speed Electric Bicycle" means a low speed electric bicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the bicycle reaches the speed of 20 miles per hour; or

"Class Two Low Speed Electric Bicycle" which means a low speed electric bicycle equipped with a motor that may be used exclusively to propel the bicycle and is not capable of providing assistance when the bicycle reaches the speed of 20 miles per hour.

"Class Three Motorized Electric Vehicle" - A pedal bicycle having a helper motor characterized in that either the maximum piston displacement is less than 50cc or said motor is rated no more than 1.5 brake horsepower or is powered by an electric drive motor and said bicycle is capable of a maximum speed of no more than 25 miles per hour on a flat surface, or a pedal bicycle having an electric motor that is capable of propelling the bicycle in excess of 20 miles per hour with a maximum motor powered speed of no more than 28 miles per hour on a flat surface. This term shall not include a low speed electric vehicle.

Section 163-2 - Operation of Low Speed Electric Vehicles Within the Borough.

- A. Any person operating a low speed electric vehicle shall obey the instructions of official traffic control signals, signs and other control devices applicable to vehicles, unless otherwise directed by a police officer. Operators of a low speed electric vehicle shall ride as near to the right side of the travel roadway as practical, exercising due care when passing a standing vehicle or one proceeding in the same direction.
- B. All persons under the age of 17 are required to wear a protective helmet while operating a low speed electric vehicle.
- C. No person shall operate a low speed electric vehicle on a sidewalk within the Borough or in any location prohibited by signage.
- D. No person shall ride or operate a low speed electric vehicle in a reckless or careless manner which endangers or is likely to endanger the safety or welfare of themselves or other persons or property. No person operating a low speed electric vehicle shall attach themselves to any street car or vehicle, nor shall the operator of the low speed electric vehicle allow others to hitch or hold onto an electric vehicle during operation. It shall be prohibited for a person operating a low speed electric vehicle to allow another person to ride as a passenger, unless the person is carried in a proper seat, trailer or other accessory that complies with current regulations and contains adequate provision for a retaining a passenger in place and for protecting the passenger.

Section 163-3 - Operation Prohibited.

Class Three Motorized Electric Vehicles as defined herein are prohibited from operating within or upon any roadway owned by or under the jurisdiction of the Borough, or in any park or parking lot owned by the Borough.

Section 163-4 – Operation of Class Three Motorized Electric Vehicles.

Class Three Motorized electric vehicles shall only be operated within the Borough if properly registered, insured and operated by a licensed operator. Class Three Motorized electric vehicles can only be operated by licensed operators on the roadways in accordance with the New Jersey Motor Vehicle Code. All operators, regardless of age, are required to wear a protective helmet while operating a motorized electric vehicle.

Section 163-5 - Statutory Provisions.

The provisions of N.J.S.A. 4-14.3, et seq. are hereby expressly incorporated by reference.

Section 163-6 - Violations and Penalties.

Any person who violates any provision of this Article shall be subject to a fine not to exceed \$250.00 for a first offense; not to exceed \$1,000.00 for a second offense; and not to exceed \$2,000.00 for a third or subsequent offense.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

 - A. That the maximum estimated amount of money to be raised from all sources for the purposes stated in Section 1, hereof, is \$175,000.00. Improvements shall include, but not be limited to, kitchen improvements, equipment and police equipment and computers.
 - B. That the cost for the improvements totaling \$175,000.00 shall be paid from a Community Development Block Grant of \$100,000 and \$75,000 from the Capital Improvement Fund.
 - C. The estimated useful life of said improvements is hereby determined to be seven (7) years.
- Section 4. That the total amount of the appropriation to be expended for Architectural and inspection costs, legal costs, advertisement of ordinance and other expenses as provided in Section 48:2-20 of the Revised Statutes, is not to exceed \$10,000.00.
- Section 5. This ordinance shall take effect after final passage and publication in accordance with the law.

ORDINANCE 2374 AN ORDINANCE APPROVING AN AMENDED MASTER LICENSE AGREEMENT ("MLA") WITH NEW YORK SMSA LIMITED PARTNERSHIP D/B/A VERIZON WIRELESS FOR THE INSTALLATION OF SMALL CELL EQUIPMENT IN PUBLIC RIGHTS-OF-WAY

WHEREAS, New York SMSA Limited Partnership d/b/a Verizon Wireless previously sought and obtained consent to install small cell antenna equipment as a way to address network gaps and improve broadband capacity for wireless consumers throughout the Borough of South Plainfield; and

WHEREAS, the Borough previously determined and continues to believe that reduction of network gaps and improvement of broadband data transmission capacity proposed by New York SMSA Limited Partnership d/b/a Verizon Wireless will benefit personal wireless service consumers in the Borough of South Plainfield; and

WHEREAS, New York SMSA Limited Partnership d/b/a Verizon Wireless has requested consent to install small cell antennas on existing and replacement utility poles at various locations within the Public Rights-of-Way in the Borough; and

- WHEREAS, the Borough has determined that its Public Rights-of-Way, such as they are or may be, themselves constitute a valuable resource, finite in nature, for the benefit of the public, and which therefore must be managed carefully; and
- **WHEREAS**, the Federal Telecommunications Act preserves local government's ability to "manage the public Rights-of-Way ... on a competitively neutral and non-discriminatory basis." 47 <u>U.S.C.</u> 253(c); and
- **WHEREAS**, the Federal Telecommunications Act preserves local government's authority over the, "placement, construction and modification of personal wireless service facilities." 47 <u>U.S.C.</u> 332(c)(7)(A); and
- WHEREAS, the Federal Telecommunications Act makes it unlawful for local government to prohibit or have the effect of prohibiting the provision of personal wireless service. 47 <u>U.S.C.</u> 332(c)(7)(B)(i)(II); and
- **WHEREAS**, New Jersey municipalities may give consent for the placement of Small Cell Equipment on poles lawfully erected within the public Rights-of-Way pursuant to N.J.S.A. 48:3-19; and
- WHEREAS, pursuant to the foregoing laws, and in furtherance of their respective goals and objectives, the Borough and New York SMSA Limited d/b/a Verizon Wireless have previously agreed to an acceptable Master License Agreement ("MLA"); and
- **WHEREAS,** New York SMSA Limited Partnership d/b/a Verizon Wireless has requested consent to install small cell antennas at eight additional locations within the Borough; and
- WHEREAS, on September 18, 2017, the Borough adopted Ordinance No. 2090 which provided for the same terms and conditions for a Master License Agreement with "Verizon Wireless, Inc.", and thereafter, it was requested that the Ordinance and Master License Agreement be amended to designate New York SMSA Limited d/b/a Verizon Wireless as the party to enter into agreement with the Borough; and
- WHEREAS, on October 16, 2017, the Borough adopted Ordinance No. 2094 which provided for the same terms and conditions for a Master License Agreement and amended the Agreement as to the entity named, New York SMSA Limited Partnership d/b/a Verizon Wireless replacing Verizon Wireless, Inc.;
- **NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of South Plainfield, County of Middlesex, State of New Jersey adopts the following sections:
- **SECTION 1.** The terms and conditions of the MLA with New York SMSA Limited Partnership d/b/a Verizon Wireless as amended are hereby approved. A copy of the MLA in substantially final form is attached to this ordinance as **Exhibit 1**. A copy of the fully executed agreement will be substituted for Exhibit 1 upon receipt of all signatures.
- **SECTION 2.** The Mayor of the Borough of South Plainfield is authorized to execute the attached amended MLA, in substantially this form or with de minimus changes approved by the Borough Attorney, which is incorporated into this ordinance for all purposes.
- **SECTION 3**. The Borough Engineer or the Borough Engineer's designee is authorized to execute any documents and Supplemental Licenses as may be necessary to carry out the intent of this ordinance.
- **SECTION 4.** Pursuant to N.J.S.A. 54:30A-124 and the terms of the MLA with New York SMSA Limited Partnership d/b/a Verizon Wireless the Borough shall recover reasonable fees for actual services incurred in the review of the MLA with New York SMSA Limited Partnership d/b/a Verizon Wireless and any Supplemental Licenses issued therefrom. New York SMSA Limited Partnership d/b/a Verizon Wireless shall make an eight hundred (\$800.00) dollar deposit toward anticipated municipal expenses which shall be placed in an escrow account. If said

escrow account contains insufficient funds to enable the Borough to perform its review, the chief financial officer shall provide New York SMSA Limited Partnership d/b/a Verizon Wireless a notice of insufficient balance. In order for review to continue, New York SMSA Limited Partnership d/b/a Verizon Wireless shall, within a reasonable time, post a deposit to the account in an amount to be mutually agreed upon.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.
