BOROUGH COUNCIL MEETING MINUTES  
FEBRUARY 16 2021, 7:00 P.M.

Using the \*6 button will mute and unmute the voice feature for any phone callers.

**Review of Agenda Items:** Clerk Antonides reviewed all the items on the agenda advising there is the addition of resolution 21-90.
