

**SOUTH PLAINFIELD BOROUGH
BOROUGH COUNCIL MEETING MINUTES
MARCH 15, 2021, 7:00 P.M.
AGENDA MEETING**

CALL TO ORDER: Council President White called the meeting to order at 7:00 p.m. Council President White read the sunshine statement and announced that same is being held pursuant to the Open Public Meetings Act of 1974 and all provisions of that Act have been met with adequate notice of this remote meeting having been provided to the Borough's two official newspapers and also published on the Borough's website. Using the *6 button will mute and unmute the voice feature for any phone callers.

Council President White called for a motion to add resolution 21-126 to this evening's agenda.
