

**SOUTH PLAINFIELD BOROUGH
BOROUGH COUNCIL MEETING MINUTES
APRIL 17, 2023, 7:00 P.M.
AGENDA MEETING**

CALL TO ORDER: Mayor Anesh called the meeting to order at 7:00 p.m. Mayor Anesh read the sunshine statement and announced that same is being held pursuant to the Open Public Meetings Act of 1974 and all provisions of that Act have been met with adequate notice of this remote hybrid meeting having been provided to the Borough's two official newspapers and also published on the Borough's website. Mayor Anesh reviewed some basic rules for conducting this virtual hybrid meeting this evening. All lines will be muted until such time that the floor is open for public comment. Using the *6 button will mute and unmute the voice feature for any phone callers.

Review of Agenda Items: Clerk Antonides reviewed all the items on the agenda. Mayor Anesh asked the Council if they had any further comments. Council President Bengivenga asked to separate out Resolution 23-151 on tonight's agenda to be voted on separately. Mr. Cullen amended the total on Resolution 23-157 to show the new temporary budget for debt service total of \$605,000. Without further comment, Council President Bengivenga made a motion to amend Resolution 23-157, seconded by Councilman White and unanimously carried.

**RESOLUTION 23-143
